- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in certification of teachers, providing for a Substitute Teaching Permit for Prospective 6 Teachers. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 10 as the Public School Code of 1949, is amended by adding a 11 12 section to read: 1.3 Section 1201.1. Substitute Teaching Permit for Prospective 14 Teachers. -- (a) An individual who does not hold a certificate under section 1201 shall be eliqible to teach as a substitute in 15 a school district or an area vocational-technical school 16 provided that: 17 18 (1) The uncertified individual shall meet all of the
- 20 <u>(i) Is currently enrolled in a teacher preparation program</u>

- 1 in a college or university located in this Commonwealth and
- 2 accredited by a regional accrediting agency recognized by the
- 3 United States Department of Education.
- 4 (ii) Has completed at least sixty (60) semester hours or the
- 5 equivalent of courses at a college or university located in this
- 6 Commonwealth and accredited by a regional accrediting agency.
- 7 (iii) Has met the requirements set forth in sections 111,
- 8 <u>111.1 and 1109(a) and 23 Pa.C.S. Ch. 63 Subch. C (relating to</u>
- 9 powers and duties of department).
- 10 (2) The chief school administrator of a school district or
- 11 <u>an area vocational-technical school may issue a Substitute</u>
- 12 <u>Teaching Permit for Prospective Teachers to an uncertified</u>
- 13 <u>individual meeting the requirements of clause (1).</u>
- 14 (3) An individual receiving a Substitute Teaching Permit for
- 15 Prospective Teachers may serve as a substitute teacher for no
- 16 more than ten (10) days per school year for a single
- 17 professional employe or temporary professional employe, provided
- 18 that the individual may serve as a substitute for multiple
- 19 professional employes or temporary professional employes for no
- 20 more than forty-five (45) days per school year.
- 21 (4) A Substitute Teaching Permit for Prospective Teachers
- 22 shall be valid for one (1) year and may be renewed for one (1)
- 23 additional year by the chief school administrator, provided that
- 24 the uncertified individual:
- 25 (i) provides documentation of the completion of an
- 26 additional fifteen (15) credit hours or equivalent from a
- 27 <u>college or university located in this Commonwealth and</u>
- 28 accredited by a regional accrediting agency; and
- 29 (ii) remains enrolled in a college or university located in
- 30 this Commonwealth and accredited by a regional accrediting

- 2 (5) The individual shall receive a salary fixed by the
- 3 governing body of the school district or area vocational-
- 4 technical school.
- 5 (6) The individual shall not have the right to elect
- 6 membership in the Public School Employees' Retirement System,
- 7 nor shall service as a substitute under this section be eliqible
- 8 for credit in the Public School Employees' Retirement System.
- 9 (b) This section shall expire on June 30, 2022.
- 10 Section 2. This act shall take effect in 60 days.
