A RESOLUTION

1 2	Designating the month of October 2016 as "Dyslexia Awareness Month" in Pennsylvania.
3	WHEREAS, Developmental reading disorder, or dyslexia, is a
4	language-based learning disability that occurs when there is a
5	problem in areas of the brain that help interpret language; and
6	WHEREAS, Dyslexia's symptoms include slow or inaccurate
7	reading, poor spelling, poor writing or mixing up similar words;
8	and
9	WHEREAS, Problems experienced by people with dyslexia may
10	include:
11	(1) confusing letters or having difficulty learning the
12	sounds that go with letters;
13	(2) having trouble learning how to speak, recognizing
14	words or determining the meaning of a simple sentence; and
15	(3) having trouble processing the sounds of language,
16	such as rhyming;

- 1 WHEREAS, Dyslexia can include disorganization of written and
- 2 spoken language or struggles in comprehending and concentrating
- 3 on longer reading assignments; and
- 4 WHEREAS, Dyslexia may also include difficulty in correctly
- 5 performing math operations, memorizing number facts or learning
- 6 a foreign language; and
- 7 WHEREAS, Dyslexia is a specific information processing
- 8 problem that does not interfere with one's ability to think or
- 9 understand complex ideas; and
- 10 WHEREAS, Contrary to some beliefs, dyslexia is not caused by
- 11 either a lack of desire to learn or substandard intelligence, as
- 12 individuals of all backgrounds and intellectual levels have
- 13 dyslexia, with the majority of individuals being of normal
- 14 intelligence and many being above average in intelligence; and
- 15 WHEREAS, Students with dyslexia are likely to struggle with
- 16 many aspects of academic learning, are at a higher risk of
- 17 dropping out of school entirely and often go for years without
- 18 being properly diagnosed; and
- 19 WHEREAS, Aside from problems in school, an individual with
- 20 dyslexia can experience a loss of self-esteem and general
- 21 reading problems that may persist into adulthood, which can
- 22 affect the individual's job performance; and
- 23 WHEREAS, According to the International Dyslexia Association,
- 24 approximately 85% of students classified as having a primary
- 25 learning disability have difficulty in reading and language
- 26 processing; and
- 27 WHEREAS, The number of people having some symptoms of
- 28 dyslexia is much higher, perhaps as much as 15% to 20% of the
- 29 entire United States population; and
- 30 WHEREAS, There is much hope for students who are correctly

- 1 diagnosed with this disorder, as they can successfully learn
- 2 with appropriate teaching methods; and
- 3 WHEREAS, The earlier the diagnosis of dyslexia, the better it
- 4 is for the student; and
- 5 WHEREAS, Dyslexia is a disorder that often manifests among
- 6 members of the same family; and
- 7 WHEREAS, Dyslexia affects individuals throughout their lives,
- 8 but its impact can change at each stage of life; and
- 9 WHEREAS, As a language-based disability, dyslexia is often
- 10 misunderstood; and
- 11 WHEREAS, A large percentage of the residents of this
- 12 Commonwealth experience one or more symptoms of dyslexia;
- 13 therefore be it
- 14 RESOLVED, That the Senate designate the month of October 2016
- 15 as "Dyslexia Awareness Month" in Pennsylvania.
