## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated

  Statutes, in registration of vehicles, further providing for

  special plates for veterans AND PROVIDING FOR SPECIAL PLATES <-FOR RECIPIENTS OF LEGION OF MERIT.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 1364 of Title 75 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding a subsection to read:
- 9 § 1364. Special plates for veterans.
- 10 \* \* \*
- 11 (c) Honoring our WOMEN veterans. -- Upon application of any
- 12 person, accompanied by a fee of \$35, which shall be in addition
- 13 to the annual registration fee and by such documentation as the
- 14 <u>department shall require</u>, the department shall issue to the
- 15 person a special registration plate designating the vehicle as
- 16 <u>belonging to a person who is honoring WOMEN veterans of the</u>
- 17 armed forces of the United States. The special registration

- 1 plate may be used only on a passenger car or truck with a
- 2 registered gross weight of not more than 14,000 pounds. The
- 3 <u>Veterans' Trust Fund shall receive \$15 of the fee paid by the</u>
- 4 applicant for the plate. The portion of the fee transferred to
- 5 the Veterans' Trust Fund under this subsection shall be used for
- 6 programs and resources that assist WOMEN veterans.
- 7 SECTION 2. TITLE 75 IS AMENDED BY ADDING A SECTION TO READ: <--
- 8 § 1368.1. SPECIAL PLATES FOR RECIPIENTS OF LEGION OF MERIT.
- 9 UPON APPLICATION OF ANY PERSON WHO IS A RECIPIENT OF THE
- 10 LEGION OF MERIT, ACCOMPANIED BY A FEE OF \$20 WHICH SHALL BE IN
- 11 ADDITION TO THE ANNUAL REGISTRATION FEE AND ANY DOCUMENTATION
- 12 THE DEPARTMENT REQUIRES, THE DEPARTMENT SHALL ISSUE TO THE
- 13 PERSON A SPECIAL REGISTRATION PLATE DESIGNATING THE VEHICLE
- 14 LICENSED AS BELONGING TO A PERSON WHO IS A RECIPIENT OF THE
- 15 LEGION OF MERIT. THE SPECIAL REGISTRATION PLATE MAY BE USED ONLY
- 16 ON A PASSENGER CAR OR TRUCK WITH A REGISTERED GROSS WEIGHT OF
- 17 NOT MORE THAN 14,000 POUNDS.
- 18 Section  $\frac{2}{3}$ . This act shall take effect in 120 days.
