## AN ACT

- Amending the act of August 26, 1971 (P.L.351, No.91), entitled "An act providing for a State Lottery and administration
- thereof; authorizing the creation of a State Lottery
- 4 Commission; prescribing its powers and duties; disposition of
- 5 funds; violations and penalties therefor; exemption of prizes
- from State and local taxation and making an appropriation,"
- 7 in Pharmaceutical Assistance for the Elderly, further
- providing for definitions.
- 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. The definition of "income" in section 502 of the
- 12 act of August 26, 1971 (P.L.351, No.91), known as the State
- 13 Lottery Law, is amended and the section is amended by adding a
- 14 definition to read:
- 15 Section 502. Definitions.
- 16 The following words and phrases when used in this chapter
- 17 shall have the meanings given to them in this section unless the
- 18 context clearly indicates otherwise:

- 2 "Income." All income from whatever source derived,
- 3 including, but not limited to, salaries, wages, bonuses,
- 4 commissions, income from self-employment, alimony, support
- 5 money, cash public assistance and relief, the gross amount of
- 6 any pensions or annuities, including railroad retirement
- 7 benefits, all benefits received under the Social Security Act
- 8 (49 Stat. 620, 42 U.S.C. § 301 et. seq.) net of amounts withheld
- 9 for Medicare Part B premium payment, all benefits received under
- 10 State unemployment insurance laws [and veterans' disability
- 11 payments], all interest received from the Federal Government or
- 12 any state government or any instrumentality or political
- 13 subdivision thereof, realized capital gains, rentals, workmen's
- 14 compensation and the gross amount of loss of time insurance
- 15 benefits, life insurance benefits and proceeds, except the first
- 16 \$10,000 of the total of death benefits payments, and gifts of
- 17 cash or property, other than transfers by gift between members
- 18 of a household, in excess of a total value of \$300, but shall
- 19 not include surplus food or other relief in kind supplied by a
- 20 government agency or property tax rebate nor shall the term
- 21 include any State veterans' benefit payments.

- 23 <u>"State veterans' benefit payments." Service-connected</u>
- 24 compensation or payments provided to a veteran or an unmarried
- 25 surviving spouse of a veteran by a State agency or authorized
- 26 under State law.
- 27 Section 2. This act shall take effect immediately.
