AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public welfare laws of the Commonwealth," in public assistance,
- further providing for reimbursement for certain medical
- 5 assistance items and services.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 443.6 of the act of June 13, 1967
- 9 (P.L.31, No.21), known as the Human Services Code, is amended by
- 10 adding a subsection to read:
- 11 Section 443.6. Reimbursement for Certain Medical Assistance
- 12 Items and Services. --* * *
- 13 (h) Payment for medical assistance capitation and fee-for-
- 14 <u>service for ambulance transportation shall be as follows:</u>
- 15 (1) For basic life support, not less than one hundred eighty

- 1 <u>dollars (\$180).</u>
- 2 (2) For advanced life support, not less than three hundred
- 3 dollars (\$300).
- 4 (3) FOR AIR AMBULANCE TRANSPORT, NOT LESS THAN THREE <--
- 5 THOUSAND THREE HUNDRED TWENTY-FIVE DOLLARS AND FIFTY-THREE CENTS
- 6 (\$3,325.53).
- 7 (4) Notwithstanding any other law to the contrary, for <--
- 8 ground mileage, not less than two dollars (\$2) for each loaded
- 9 <u>mile.</u>
- 10 (5) NOTWITHSTANDING ANY OTHER LAW TO THE CONTRARY, FOR AIR <--
- 11 MILEAGE, NOT LESS THAN TWENTY-TWO DOLLARS AND FORTY-FIVE CENTS
- 12 (\$22.45) PER MILE.
- 13 Section 2. This act shall take effect immediately.
