AN ACT

Designating a bridge on that portion of State Route 533 over Muddy Run, Southampton Township, Franklin County, as the 2 Private First Class Dana Edward Diehl Memorial Bridge. 3 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: Section 1. Private First Class Dana Edward Diehl Memorial 6 7 Bridge. Findings. -- The General Assembly finds and declares as 8 follows: 10 Private First Class Dana Edward Diehl, a native of 11 Shippensburg, lived most of his life a few miles from the 12

- bridge over Muddy Run. He crossed over the bridge on Sunday 13 mornings traveling to church, spent many hours fishing with 14 his father along Muddy Run and cooled off in the stream with 15 his family during hot summer days.
- 16 Private First Class Diehl graduated from Shippensburg Area Senior High School in 1967. During high 17

- school, he was a member of the wrestling team and active in
- 2 Boy Scout Troop No. 251.
- 3 (3) Private First Class Diehl honorably served his
- 4 country as a medical specialist with the 25th Infantry
- 5 Division, 3rd Squadron, 4th Cavalry, Headquarters Troop.
- 6 (4) On December 10, 1968, in Hau Nghia Province, South
- 7 Vietnam, Private First Class Diehl was killed when the
- 8 vehicle in which he was riding was struck by an explosive
- 9 device.
- 10 (b) Designation.--The bridge located on State Route 533 over
- 11 Muddy Run in Southampton Township, Franklin County, is
- 12 designated as the Private First Class Dana Edward Diehl Memorial
- 13 Bridge.
- 14 (c) Signs.--The Department of Transportation shall erect and
- 15 maintain appropriate signs displaying the name of the bridge to
- 16 traffic in both directions on the bridge.
- 17 Section 2. Effective date.
- 18 This act shall take effect in 60 days.
