## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An

act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in terms and courses of study, 5 further providing for fire and emergency evacuation drills. 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. Section 1517 of the act of March 10, 1949 10 (P.L.30, No.14), known as the Public School Code of 1949, is amended to read: 11 12 Section 1517. Fire and Emergency Evacuation Drills. -- (a) all [public schools] school buildings of school entities where 13 fire-escapes, appliances for the extinguishment of fires, or 14 15 proper and sufficient exits in case of fire or panic, either or 16 all, are required by law to be maintained, fire drills shall be periodically conducted while the school entity is in session and 17 18 students are present, not less than one a month, by the [teacher 19 or teachers] principal or person in charge, under rules and

- 1 regulations to be promulgated by the [district superintendent]
- 2 <u>chief school administrator</u> under whose supervision such
- 3 [schools] school entities are. In such fire drills the pupils
- 4 and teachers shall be instructed in, and made thoroughly
- 5 familiar with, the use of the fire-escapes, appliances and
- 6 exits. The drill shall include the actual use thereof, and the
- 7 complete removal of the pupils and teachers, in an expeditious
- 8 and orderly manner, by means of fire-escapes and exits, from the
- 9 building to a place of safety on the ground outside.
- 10 (a.1) A record of all fire and emergency evacuation drills
- 11 shall be completed by the principal or person in charge at each
- 12 school building and shall be accurate and up-to-date and kept on
- 13 <u>file in the respective school offices. The principal or person</u>
- 14 <u>in charge shall submit the record to the chief school</u>
- 15 administrator and the Department of Education by June + 30 each <--
- 16 year for review by the department for compliance with this
- 17 section. The Department of Education shall determine the manner
- 18 and form of the record to be used to document the fire and
- 19 emergency drills by the principal or person in charge at each
- 20 school building. The record must include, at a minimum, the
- 21 following:
- 22 <u>(1) The date and time of the drill.</u>
- 23 (2) The number of students participating in the drill.
- 24 (3) The duration of the drill.
- 25 (4) The drill type.
- 26 (5) A description of what occurred during the drill.
- 27 (5) The signature of the principal or person in charge. <--
- 28 (b) [District superintendents] Chief school administrators
- 29 are hereby required to see that the provisions of this section
- 30 are faithfully carried out in the [schools] school entities over

- 1 which they have charge.
- 2 (c) Any person who violates or fails to comply with the
- 3 provisions of this section shall be guilty of a misdemeanor, and
- 4 on conviction shall be sentenced to pay a fine of not less than
- 5 twenty-five dollars (\$25) nor more than five hundred dollars
- 6 (\$500), or to undergo imprisonment in the county jail for not
- 7 less than (10) days or more than sixty (60) days, or both.
- 8 (d) (1) All [schools] school entities using or contracting
- 9 for school buses for the transportation of school children shall
- 10 conduct on school grounds two emergency evacuation drills on
- 11 buses during each school year, the first to be conducted during
- 12 the first week of the first school term and the second during
- 13 the month of March, and at such other times as the chief school
- 14 administrator may require. Each such drill shall include the
- 15 practice and instruction concerning the location, use and
- 16 operation of emergency exit doors and fire extinguishers and the
- 17 proper evacuation of buses in the event of fires or accidents.
- 18 (2) Bus operators shall be provided with proper training and
- 19 instructions to enable them to carry out the provisions of this
- 20 subsection and may be required to attend classes and drills in
- 21 connection therewith.
- 22 <u>(e)</u> On or before the tenth day of April of each year, each
- 23 [district superintendent] <a href="mailto:chief-school-administrator">chief-school-administrator</a> shall
- 24 certify to the Department of [Public Instruction] Education that
- 25 the <u>fire and</u> emergency evacuation drills herein required have
- 26 been [held.] conducted in accordance with this section and
- 27 <u>documented in the record by the principal or person in charge of</u>
- 28 <u>each school building.</u>
- 29 (f) The Department of Education, by August 1, 2017 SEPTEMBER <--
- 30 1, 2018, and each August 1 thereafter, shall compile a report of <--

- 1 all fire and evacuation drill records and forward the report to
- 2 the Office of the State Fire Commissioner. The Office of the
- 3 State Fire Commissioner shall make available on its publicly
- 4 <u>accessible Internet website a searchable database containing</u>
- 5 information on the fire and evacuation drills conducted in each
- 6 school building of each school entity for the past five (5)
- 7 <u>school years. The searchable database shall be in a form and</u>
- 8 manner as determined by the State Fire Commissioner. The
- 9 <u>Department of Education shall</u> provide annually a report on
- 10 Statewide compliance with the provisions of this section to the
- 11 Education Committee of the Senate and, the Education Committee <--
- 12 of the House of Representatives- AND THE STATE FIRE COMMISSIONER <--
- 13 AND SHALL MAKE THE REPORT AVAILABLE ON THE DEPARTMENT'S PUBLICLY
- 14 ACCESSIBLE INTERNET WEBSITE.
- 15 (g) As used in this section, the following words and phrases
- 16 shall have the meanings given to them in this subsection:
- 17 "Chief school administrator" shall mean the superintendent of
- 18 a school district, superintendent of an area vocational-
- 19 technical school, executive director of an intermediate unit or
- 20 chief executive officer of a charter school or regional charter
- 21 school.
- 22 "School entity" shall mean an area vocational-technical
- 23 school, a school district, an intermediate unit, a charter
- 24 school or a regional charter school.
- 25 Section 2. This act shall take effect in 60 days.
