- Amending the act of July 28, 1953 (P.L.723, No.230), entitled "An act relating to counties of the second class and second 2 class A; amending, revising, consolidating and changing the laws relating thereto," in Allegheny Regional Asset District, further providing for imposition of sales and use tax. 3 4 5 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 Section 1. Section 3152-B(d) of the act of July 28, 1953 9 (P.L.723, No.230), known as the Second Class County Code, is 10 amended to read: 11 Section 3152-B. Imposition. -- * * * 12 The tax authorized by subsections [(a), (b) and 13 (c)] (a) and (b) may be imposed at a rate of [one per centum 14 (1%).] thirty-two hundredths per centum (.32%). The tax authorized by subsection (c) may be imposed at a rate of one per 15 16 centum (1%). 17 (2) The tax imposed by subsections [(a), (b) and (c)] (a) 18 and (b) shall be uniform. 19 * * *

- 3 enacted all of the following:
- 4 (1) An act that repeals the exclusions from the tax
- 5 imposed under Article II of the act of March 4, 1971 (P.L.6,
- No.2), known as the Tax Reform Code of 1971.
- 7 (2) An act that reduces the rate of tax imposed under
- 8 section 503(a) and (b) of the act of June 5, 1991 (P.L.9,
- 9 No.6), known as the Pennsylvania Intergovernmental
- 10 Cooperation Authority Act for Cities of the First Class, in a
- 11 manner that would result in the revenue generated by the tax
- imposed under section 503(a) and (b) of the Pennsylvania
- 13 Intergovernmental Cooperation Authority Act for Cities of the
- 14 First Class, being revenue neutral, subject to the repeal of
- exclusions described under paragraph (1), in comparison to
- the amount generated in the prior fiscal year.
- 17 (3) An act that reduces the amount deposited into the
- 18 Public Transportation Trust Fund under 74 Pa.C.S. § 1506(c)
- 19 (1).
- 20 Section 3. This act shall take effect as follows:
- 21 (1) This section and section 2 of this act shall take
- 22 effect immediately.
- 23 (2) The remainder of this act shall take effect upon
- 24 publication of the notice under section 2 of this act.
