AN ACT

- 1 Making appropriations from the Public School Employees'
- 2 Retirement Fund and from the PSERS Defined Contribution Fund
- to provide for expenses of the Public School Employees'
- 4 Retirement Board for the fiscal year July 1, 2018, to June
- 30, 2019, and for the payment of bills incurred and remaining
- unpaid at the close of the fiscal year ending June 30, 2018.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The sum of \$51,637,000, or as much thereof as may
- 10 be necessary, is hereby appropriated from the Public School
- 11 Employees' Retirement Fund to the Public School Employees'
- 12 Retirement Board for the payment of all salaries, wages and
- 13 other compensation and travel expenses of the employees and
- 14 members of the Public School Employees' Retirement Board, for
- 15 contractual services and other expenses necessary for the proper
- 16 conduct of the duties, functions and activities of the board for
- 17 the fiscal year beginning July 1, 2018, and for the payment of
- 18 bills incurred and remaining unpaid at the close of the fiscal
- 19 year ending June 30, 2018.
- 20 Section 2. The sum of \$4,950,000, or as much thereof as may

- 1 be necessary, is hereby appropriated from the PSERS Defined
- 2 Contribution Fund authorized under section 1799.8-E of the act
- 3 of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, to
- 4 the Public School Employees' Retirement Board for the payment of
- 5 all salaries, wages and other compensation and travel expenses
- 6 of the employees and members of the State PUBLIC SCHOOL
- 7 Employees' Retirement Board, for contractual services and other

- 8 expenses necessary for the proper conduct of the duties,
- 9 functions and activities of the board related to the
- 10 administration of the Public School Employees' Defined
- 11 Contribution Plan established under 24 Pa.C.S. Ch. 84 (relating
- 12 to School Employees' Defined Contribution Plan) for the fiscal
- 13 year beginning July 1, 2018, and for the payment of bills
- 14 incurred and remaining unpaid at the close of the fiscal year
- 15 ending June 30, 2018.
- 16 Section 3. This act shall take effect July 1, 2018, or
- 17 immediately, whichever is later.
