- 7 There is no authority for the State Treasurer, the Secretary
- 8 of the Budget, the Secretary of Revenue or the Pennsylvania
- 9 Gaming Control Board to transfer any money within or between the
- 10 appropriations in Parts III, V and VII.
- 11 Section 902. Effective date.
- 12 This act shall take effect July 1, 2018, or immediately,
- 13 whichever is later.
