4	The following words and phrases when used in this chapter
5	shall have the meanings given to them in this section unless the
6	context clearly indicates otherwise:
7	"Department." The Department of Conservation and Natural
8	Resources of the Commonwealth.
9	"Fund." The Keystone Tree Fund established by this chapter.
10	<u>§ 6602. Establishment.</u>
11	The Keystone Tree Fund is established in the State Treasury.
12	The money in the fund is appropriated on a continuing basis to
13	the department for the purposes specified in section 6604
14	(relating to authorized purposes).
15	<u>§ 6603. Sources of revenue.</u>
16	The fund shall include the following:
17	(1) Proceeds paid by the Department of Transportation
18	under 75 Pa.C.S. § 1321 (relating to contributions to
19	<u>Keystone Tree Fund).</u>
20	(2) Grants, gifts, donations and other payments from a
21	person or governmental entity to the fund.
22	(3) Money appropriated to the fund.
23	<u>§ 6604. Authorized purposes.</u>
24	The department may expend money from the fund for the
25	purposes and in the allocations as follows:
26	(1) A tree vitalize program, 40%.
27	(2) A riparian forest buffer grant program, 60%.
28	<u>§ 6605. Contributions.</u>
29	The department may solicit and accept gifts, donations,
30	legacies and other money for deposit into the fund from a person

2	<u>§ 6606. Statement of policy.</u>
3	The department shall adopt a statement of policy for the
4	maintenance and use the fund within 60 days of the effective
5	date of this section. The statement of policy shall be published
6	as a notice in the Pennsylvania Bulletin but shall not be
7	subject to review under section 205 of the act of July 31, 1968
8	(P.L.769, No.240), referred to as the Commonwealth Documents
9	Law, sections 204(b) and 301(10) of the act of October 15, 1980
10	(P.L.950, No.164), known as the Commonwealth Attorneys Act, or
11	the act of June 25, 1982 (P.L.633, No.181), known as the
12	Regulatory Review Act.

14	By July 31, 2018, and every year thereafter, the department
15	shall submit to the chairperson and minority chairperson of the

19	report detailing the fund revenues and expenditures in the prior
