AN ACT

- Designating a bridge on that portion of U.S. Route 219 over the Kinzua Creek, Lafayette Township, McKean County, as the Staff Sergeant Carl Enis Memorial Bridge.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Staff Sergeant Carl Enis Memorial Bridge.
- 7 (a) Findings.--The General Assembly finds and declares as
- 8 follows:
- 9 (1) Staff Sergeant Carl Enis, of Tallahassee, Florida,
- died March 15, 2018, at 31 years of age when an HH-60 Pave
- 11 Hawk helicopter crashed in western Iraq.
- 12 (2) Staff Sergeant Enis' family has generations of
- 13 connection to Lafayette Township in McKean County where Staff
- 14 Sergeant Enis spent considerable time vacationing and
- 15 learning to hunt and fish.
- 16 (3) Staff Sergeant Enis was assigned to the Air Force

- 1 Reserve's 308th Rescue Squadron at Patrick Air Force Base,
- 2 Florida, in which he served for eight years.
- 3 (4) Staff Sergeant Enis was a pararescueman who also
- 4 worked as a commercial real estate salesman.
- 5 (5) Staff Sergeant Enis' awards and decorations include
- 6 the Air Reserve Forces Meritorious Service Medal with bronze
- 7 oak leaf cluster, the National Defense Service Medal and the
- 8 Global War on Terrorism Expeditionary Medal.
- 9 (6) In the past two years, Staff Sergeant Enis received
- 10 multiple awards, including Airman of the Year for both the
- 11 920th Rescue Wing and Air Force Reserve Command.
- 12 (b) Designation. -- The bridge, identified as Bridge Key
- 13 25323, located on U.S. Route 219 over the Kinzua Creek,
- 14 Lafayette Township, McKean County, is designated the Staff
- 15 Sergeant Carl Enis Memorial Bridge.
- 16 (c) Signs. -- The Department of Transportation shall erect and
- 17 maintain appropriate signs displaying the name of the bridge to
- 18 traffic in both directions on the bridge.
- 19 Section 2. Effective date.
- This act shall take effect in 60 days.
