## A RESOLUTION

- 1 Congratulating The Pennsylvania State University IFC/Panhellenic
- Dance Marathon for raising more than \$10 million for the Four
- Diamonds Fund at Penn State Hershey Children's Hospital to
- 4 help fight pediatric cancer.
- 5 WHEREAS, THON is the commonly referred to name for The
- 6 Pennsylvania State University IFC/Panhellenic Dance Marathon,
- 7 the largest student-run philanthropy in the world; and
- 8 WHEREAS, THON is a yearlong fundraising and awareness
- 9 campaign to fight pediatric cancer, sustained by more than
- 10 16,000 volunteers, that culminates in a 46-hour dance marathon
- 11 in which dancers are not allowed to sit or sleep; and
- 12 WHEREAS, In 1977, THON partnered with the Four Diamonds Fund
- 13 at Penn State Hershey Children's Hospital and designated Four
- 14 Diamonds as the sole beneficiary of THON's fundraising efforts;

- 2 WHEREAS, Four Diamonds offsets the cost of treatment that
- 3 insurance does not cover, as well as expenses that may affect
- 4 the welfare of the child, and supports the medical team that
- 5 cares for the children and funds pediatric cancer research
- 6 through start-up grants and the Four Diamonds Pediatric Cancer
- 7 Research Institute; and
- 8 WHEREAS, Since 1977, THON has raised more than \$147 million
- 9 to help provide emotional and financial support to the children,
- 10 families, researchers and staff of the Four Diamonds Fund; and
- 11 WHEREAS, THON 2017 took place February 17 through 19, 2017,
- 12 at the Bryce Jordan Center at The Pennsylvania State University;
- 13 and
- 14 WHEREAS, THON 2017 revealed its total fundraising amount of
- 15 \$10,045,478.44; and
- 16 WHEREAS, THON has inspired similar events and organizations
- 17 across the United States, including at high schools and
- 18 institutions of higher education, and continues to encourage
- 19 students throughout the nation to volunteer and stay involved in
- 20 great charitable causes in their communities; therefore be it
- 21 RESOLVED, That the House of Representatives congratulate The
- 22 Pennsylvania State University IFC/Panhellenic Dance Marathon on
- 23 its continued success in support of the Four Diamonds Fund at
- 24 Penn State Hershey Children's Hospital and commend The

- 26 supporting organizations for their hard work in putting together
