A RESOLUTION

- Designating the month of July 2017 as "Fragile X Syndrome Awareness Month" in Pennsylvania.
- 3 WHEREAS, Fragile X syndrome is an inherited genetic condition
- 4 that causes intellectual and developmental disabilities; and
- 5 WHEREAS, Affecting approximately 1 in 4,000 males and 1 in
- 6 8,000 females, fragile X syndrome causes varying degrees of
- 7 intellectual disability and a range of behavioral issues and
- 8 medical conditions; and
- 9 WHEREAS, Mild to severe mutation in the fragile X mental
- 10 retardation 1 (FMR1) gene on the X chromosome is the single
- 11 genetic cause; and
- 12 WHEREAS, This particular mutation alters early brain
- 13 development and neurodevelopmental patterns, influencing
- 14 behavioral, cognitive and physical development; and
- 15 WHEREAS, Fragile X syndrome is the most common inherited form

- 1 of intellectual disability in males and a significant cause of
- 2 intellectual disability in females; and
- 3 WHEREAS, Related disabilities range from moderate learning
- 4 disabilities to more severe intellectual disabilities; and
- 5 WHEREAS, Affected individuals often experience delayed speech
- 6 and language development; and
- WHEREAS, Repetitive behaviors, poor impulse control,
- 8 depression, shyness and avoidance of social situations are some
- 9 of the potential behavioral manifestations; and
- 10 WHEREAS, Mitral valve prolapse and seizures are among the
- 11 related physical conditions; and
- 12 WHEREAS, Interventions include education and special
- 13 education services, counseling and assistive technologies as
- 14 well as drug therapies as needed; and
- 15 WHEREAS, Diagnostic and carrier screening is available; and
- WHEREAS, As many as 1 in 468 males and 1 in 151 females carry
- 17 the FMR1 premutation, which has an increased chance of expanding
- 18 to a full mutation in subsequent generations; and
- 19 WHEREAS, Specialists in pediatrics, molecular genetics,
- 20 psychiatry, psychology, neurology, genetic counseling, speech
- 21 and language pathology, occupational therapy, neurobiology,
- 22 pathology and social work contribute to our understanding of
- 23 fragile X syndrome; and
- 24 WHEREAS, Research focuses on the fragile gene as expressed in
- 25 persons with the syndrome and as carried by persons with the
- 26 premutation; and
- 27 WHEREAS, Related clinical trials and safety studies are being
- 28 conducted throughout our nation; therefore be it
- 29 RESOLVED, That the House of Representatives designate the
- 30 month of July 2017 as "Fragile X Syndrome Awareness Month" in

1 Pennsylvania.
