A RESOLUTION

- Designating the month of October 2017 as "Archives Month" in Pennsylvania.
- 3 WHEREAS, The historical documents and records of our nation
- 4 and our Commonwealth provide a crucial link to our past; and
- 5 WHEREAS, The House of Representatives recognizes the growing
- 6 importance of maintaining its own legislative, committee and
- 7 individual member records for posterity; and
- 8 WHEREAS, For more than 35 years, the House of Representatives
- 9 Archives has served as the official archival repository for the
- 10 records of elected members, committees and administrative
- 11 agencies of that body; and
- 12 WHEREAS, These historical records and documents, if not
- 13 professionally collected, cataloged and preserved by dedicated
- 14 archivists and staff and housed in a secure location, would be
- 15 lost to future generations of our citizens; and
- 16 WHEREAS, The House of Representatives Archives seeks to share

- 1 the valuable historical information and documents in its
- 2 holdings with researchers, legislators, staff members and the
- 3 public; and
- 4 WHEREAS, These records are accessible through many programs,
- 5 including the collection of House Committee records from 1971 to
- 6 the present, an interactive online historical, biographical
- 7 directory of members dating from 1862 to the present and an
- 8 extensive collection of more than 125 oral history interviews
- 9 with legislators, which allows former representatives to record
- 10 their experiences and discuss their legislation while they
- 11 served in the House of Representatives, providing scholars and
- 12 citizens alike with the ability to consult and utilize these
- 13 historically valuable resources; therefore be it
- 14 RESOLVED, That the House of Representatives designate the
- 15 month of October 2017 as "Archives Month" in Pennsylvania; and
- 16 be it further
- 17 RESOLVED, That the House of Representatives recognize the
- 18 invaluable contribution of its archival repository and its
- 19 committed staff members; and be it further
- 20 RESOLVED, That the House of Representatives urge all
- 21 Pennsylvanians to visit their local archives, historical
- 22 repositories and libraries to learn more about the contributions
- 23 of historical documents and records to the discovery of the rich
- 24 heritage of this Commonwealth.
