1 2 3	Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in proprietary and official rights, further providing for wearing of uniforms and insignia.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Section 6701 of Title 18 of the Pennsylvania
7	Consolidated Statutes is amended to read:
8	§ 6701. [Wearing of uniforms and insignia] <u>Uniforms, insignia</u>
9	and military decorations or medals.
10	[A] (a) Offense definedExcept as provided under
11	subsection (b), a person is guilty of a summary offense if,
12	without authority, he:
13	(1) wears or displays the uniform, decoration, insignia
14	or other distinctive emblem of any branch of the armed forces
15	of the United States or of any of the several states, or of
16	any association, for the purpose of obtaining aid or profit,
17	or while soliciting contributions or subscriptions; or
18	(2) wears an honorable discharge button issued or

- 2 (b) False claims about receipt of military decorations or 3 medals.--

4	(1) Except as provided under paragraph (2), a person
5	commits a misdemeanor of the third degree if the person
6	falsely represents himself verbally or in writing to have
7	been awarded any decoration or medal authorized by the
8	Congress of the United States for the armed forces of the
9	United States, any of the service medals or badges awarded to
10	the members of the armed forces of the United States, the
11	ribbon, button or rosette of any badge, decoration or medal
12	or any colorable imitation of the item with the intent to
13	commit fraud, obtain employment or be elected to public
14	office. Each violation shall constitute a separate offense.
15	(2) (i) If a decoration or medal involved in an offense
16	under paragraph (1) is any of the following, the person
17	commits a misdemeanor of the second degree:
18	(A) The Congressional Medal of Honor.
19	(B) The Distinguished Service Cross.
20	(C) A Navy Cross.
21	(D) An Air Force Cross.
22	(E) A Silver Star Medal.
23	(F) A Purple Heart.
24	(G) Any replacement or duplicate medal for
25	medals listed under clauses (A), (B), (C), (D), (E)
26	and (F).
27	(ii) Each violation under this paragraph shall
28	<u>constitute a separate offense.</u>
29	Section 2. This act shall take effect in 60 days.
