AN ACT

Providing for tax levies and information related to taxes; authorizing the imposition of a personal income tax or an earned income tax by a school district subject to voter approval; providing for imposition of and exclusions from a sales and use tax for the stabilization of education funding, 5 for increase to the personal income tax, for certain 6 licenses, for hotel occupancy tax, for procedure and 7 administration of the tax, for expiration of authority to issue certain debt and for reporting by local government 9 units of debt outstanding; establishing the Education 10 Stabilization Fund; providing for disbursements from the 11 Education Stabilization Fund and for senior citizen property 12 13 tax rent rebate assistance; and making repeals.

- 1 hereby enacts as follows:
- 2 CHAPTER 1
- 3 PRELIMINARY PROVISIONS
- 4 Section 101. Short title.
- 5 This act shall be known and may be cited as the Property Tax
- 6 Independence Act.
- 7 Section 102. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "Department." The Department of Revenue of the Commonwealth.
- "Education Stabilization Fund." The Education Stabilization
- 13 Fund established in section 1302.
- 14 "Fiscal year." The fiscal year of the Commonwealth beginning
- 15 on July 1 and ending on June 30 of the immediately following
- 16 calendar year.
- 17 "Governing body." The board of school directors of a school
- 18 district, except that the term shall mean the city council of a
- 19 city of the first class for purposes of the levy and collection
- 20 of any tax in a school district of the first class.
- "Internal Revenue Code of 1986." The Internal Revenue Code
- 22 of 1986 (Public Law 99-514, 26 U.S.C. § 166).
- "Local Tax Enabling Act." The act of December 31, 1965
- 24 (P.L.1257, No.511), known as The Local Tax Enabling Act,
- "Public School Code of 1949." The act of March 10, 1949
- 26 (P.L.30, No.14), known as the Public School Code of 1949.
- 27 "School district." A school district of the first class,
- 28 first class A, second class, third class or fourth class,
- 29 including any independent school district. For purposes of the
- 30 levy, assessment and collection of any tax in a school district

- 1 of the first class, the term shall include the city council.
- 2 "School per capita tax." The tax authorized pursuant to
- 3 section 679 of the act of March 10, 1949 (P.L.30, No.14), known
- 4 as the Public School Code of 1949.
- 5 "Secretary." The Secretary of Revenue of the Commonwealth.
- 6 "Tax Reform Code of 1971." The act of March 4, 1971 (P.L.6,
- 7 No.2), known as the Tax Reform Code of 1971.
- 8 CHAPTER 3
- 9 TAXATION BY SCHOOL DISTRICTS
- 10 Section 301. Scope.
- 11 This chapter authorizes school districts to levy, assess and
- 12 collect a tax on personal income or a tax on earned income and
- 13 net profits as a means of abolishing property taxation by the
- 14 school district.
- 15 Section 302. Definitions.
- 16 The words and phrases used in this chapter shall have the
- 17 same meanings given to them in the Tax Reform Code of 1971 or
- 18 the Local Tax Enabling Act unless the context clearly indicates
- 19 otherwise.
- 20 Section 303. Limitation.
- 21 Any tax imposed under this chapter shall be subject to the
- 22 limitations set forth in Chapter 11.
- 23 Section 304. Preemption.
- No act of the General Assembly shall vacate or preempt any
- 25 resolution passed or adopted under the authority of this
- 26 chapter, or any other act, providing authority for the
- 27 imposition of a tax by a school district, unless the act of the
- 28 General Assembly expressly vacates or preempts the authority to
- 29 pass or adopt resolutions.
- 30 Section 305. General tax authorization.

- 1 (a) General rule. -- A board of school directors may, by
- 2 resolution, levy, assess and collect or provide for the levying,
- 3 assessment and collection of a tax on personal income or a tax
- 4 on earned income and net profits for general revenue purposes.
- 5 (b) Personal income tax.--

- 6 (1) A board of school directors may levy, assess and
 7 collect a tax on the personal income of resident individuals
 8 at a rate determined by the board of school directors.
 - (2) A school district which seeks to levy the tax authorized under paragraph (1) must comply with section 306.
 - (3) If a board of school directors seeks to impose a personal income tax under this subsection and the referendum under section 306 is approved by the electorate, the board of school directors shall have no authority to impose an earned income and net profits tax under subsection (c) or any other act.
 - (4) A personal income tax imposed under the authority of this section shall be levied by the school district on each of the classes of income specified in section 303 of the Tax Reform Code of 1971 and regulations under that section, provisions of which are incorporated by reference into this chapter.
 - (i) Notwithstanding the provisions of section 353(f) of the Tax Reform Code of 1971, the department may permit the proper officer or an authorized agent of a school district imposing a personal income tax pursuant to this chapter to inspect the tax returns of any taxpayer of the school district or may furnish to the officer or an authorized agent an abstract of the return of income of any current or former resident of the school district or

- supply information concerning any item of income

 contained in any tax return. The officer or authorized

 agent of the school district imposing a tax under this

 chapter shall be furnished the requested information upon

 payment to the department of the actual cost of providing

 the requested information.
 - (ii) (A) Except for official purposes or as provided by law, it shall be unlawful for any officer or authorized agent of a school district to do any of the following:
 - (I) Disclose to any other individual or entity the amount or source of income, profits, losses, expenditures or any particular information concerning income, profits, losses or expenditures contained in any return.
 - (II) Permit any other individual or entity to view or examine any return or copy of a return or any book containing any abstract or particulars.
 - (III) Print, publish or publicize in any manner any return; any particular information contained in or concerning the return; any amount or source of income, profits, losses or expenditures in or concerning the return; or any particular information concerning income, profits, losses or expenditures contained in or relating to any return.
 - (B) Any officer or authorized agent of a school district that violates clause (A):
 - (I) May be fined not more than \$1,000 or

- imprisoned for not more than one year, or both.
- 2 (II) May be removed from office or
- 3
 discharged from employment.
- 4 (c) Earned income and net profits tax.--
- (1) A board of school directors may levy, assess and collect a tax on earned income and net profits of resident individuals at a rate determined by the board of school directors.
- 9 (2) A school district which seeks to levy the tax
 10 authorized under paragraph (1) must comply with section 306.
- 11 (3) If a board of school directors seeks to impose a tax 12 on earned income and net profits under this subsection and 13 the referendum under section 306 is approved by the 14 electorate, the board of school directors shall have no 15 authority to impose a personal income tax under subsection 16 (b) or any other act.
- 17 Section 306. Referendum.
- 18 (a) General rule.--In order to levy a personal income tax or
 19 an earned income and net profits tax under this chapter, a
 20 governing body shall use the procedures set forth in subsections
- 22 (b) Approved by electorate.--

(b), (c), (d), (e), (f) and (g).

23 Subject to notice and public hearing requirements of 24 subsection (q), a governing body may levy the personal income 25 tax or earned income and net profits tax under this chapter 26 only by obtaining the approval of the electorate of the 27 affected school district in a public referendum at only the 28 primary election preceding the fiscal year when the personal 29 income tax or earned income and net profits tax will be initially imposed or the rate increased. 30

- 1 The referendum question must state the initial rate 2 of the proposed personal income tax or earned income and net 3 profits tax, the purpose of the tax, the duration of the tax and the amount of revenue to be generated by the 4 implementation of the tax. 5
 - The question shall be in clear language that is readily understandable by a layperson. For the purpose of illustration, a referendum question may be framed as follows:

9 Do you favor paying a personal income tax of X% for the purpose of X, for X years, which will generate 10 11 \$X?

12 Do you favor paying an earned income and net profits 13 tax of X% for the purpose of X, for X years, which 14 will generate \$X?

- (4) A nonlegal interpretative statement must accompany the question in accordance with section 201.1 of the act of June 3, 1937 (P.L.1333, No.320), known as the Pennsylvania Election Code, that includes the following:
- (i) the initial rate of the personal income or 19 20 earned income and net profits tax imposed under this chapter; and
- (ii) the estimated revenues to be derived from the 22 23 initial rate imposed under this chapter.
- 24 (c) School district located in more than one county. -- In the 25 event a school district is located in more than one county,
- petitions under this section shall be filed with the election 26
- officials of the county in which the administrative offices of 27
- the school district are located. 28
- (d) Review and certification. -- The election officials who 29
- 30 receive a petition shall perform all administrative functions in

- 1 reviewing and certifying the validity of the petition and
- 2 conduct all necessary communications with the school district.
- 3 (e) Notification.--
- 4 (1) If the election officials of the county who receive
- 5 the petition certify that it is sufficient under this section
- and determine that a question should be placed on the ballot,
- 7 the decision shall be communicated to election officials in
- 8 any other county in which the school district is also
- 9 located.
- 10 (2) Election officials in the other county or counties
- shall cooperate with election officials of the county that
- 12 receives the petition to ensure that an identical question is
- placed on the ballot at the same election throughout the
- 14 entire school district.
- 15 (f) Certification of results. -- Election officials from each
- 16 county involved shall independently certify the results from
- 17 their county to the governing body.
- 18 (g) Adoption of resolution. --
- 19 (1) In order to levy the tax under this section, the
- 20 governing body shall adopt a resolution which shall refer to
- 21 this chapter prior to placing a question on the ballot.
- 22 (2) Prior to adopting a resolution imposing the tax
- authorized by this section, the governing body shall give
- 24 public notice of its intent to adopt the resolution in the
- 25 manner provided by the Local Tax Enabling Act and shall
- 26 conduct at least two public hearings regarding the proposed
- 27 adoption of the resolution. One public hearing shall be
- conducted during normal business hours and one public hearing
- shall be conducted during evening hours or on a weekend.
- 30 Section 307. Continuity of tax.

- 1 Every tax levied under this chapter shall continue in force
- 2 on a fiscal year basis without annual reenactment unless the
- 3 rate of the tax is subsequently changed or the duration placed
- 4 on the referendum has expired.
- 5 Section 308. Collections.
- 6 Any income tax imposed under this chapter shall be subject to
- 7 the provisions for collection and delinquency found in the Local
- 8 Tax Enabling Act.
- 9 Section 309. Credits.
- 10 (a) Credit. -- Except as set forth in subsection (b), the
- 11 provisions of the Local Tax Enabling Act shall be applied by a
- 12 board of school directors to determine any credits applicable to
- 13 a tax imposed under this chapter.
- 14 (b) Limitation. -- Payment of any tax on income to any state
- 15 other than Pennsylvania or to any political subdivision located
- 16 outside the boundaries of this Commonwealth by a resident of a
- 17 school district located in this Commonwealth shall not be
- 18 credited to and allowed as a deduction from the liability of
- 19 such person for any income tax imposed by the school district of
- 20 residence pursuant to this chapter.
- 21 Section 310. Exemption and special provisions.
- 22 (a) Earned income and net profits tax. -- A school district
- 23 that imposes an earned income and net profits tax authorized
- 24 under section 305(c) may exempt from the payment of that tax any
- 25 person whose total income from all sources is less than \$12,000.
- 26 (b) Applicability to personal income tax. -- Section 304 of
- 27 the Tax Reform Code of 1971 shall apply to any personal income
- 28 tax levied by a school district under section 305(b).
- 29 Section 311. Regulations.
- 30 A school district that imposes:

- 1 (1) an earned income and net profits tax authorized
- 2 under section 305(c) shall be subject to the provisions of
- 3 the Local Tax Enabling Act and may adopt procedures for the
- 4 processing of claims for credits and exemptions under
- 5 sections 309 and 310; or
- 6 (2) a personal income tax under section 305(b) shall be
- 7 subject to all regulations adopted by the department in
- 8 administering the tax due to the Commonwealth under Article
- 9 III of the Tax Reform Code of 1971.
- 10 CHAPTER 4
- 11 EDUCATION TAX
- 12 Section 401. Education tax.
- 13 (a) General rule. -- In addition to the tax collected under
- 14 section 302 of the Tax Reform Code of 1971, the Commonwealth
- 15 shall impose and administer the tax set forth in subsection (b)
- 16 in the same manner as the tax under Article III of the Tax
- 17 Reform Code of 1971.
- 18 (b) Imposition of tax.--
- 19 (1) Every resident individual, estate or trust shall be
- subject to, and shall pay for the privilege of receiving each
- 21 of the classes of income enumerated in section 303 of the Tax
- 22 Reform Code of 1971, a tax upon each dollar of income
- 23 received by that resident during that resident's taxable year
- 24 at the rate of 1.88%.
- 25 (2) Every nonresident individual, estate or trust shall
- 26 be subject to, and shall pay for the privilege of receiving
- each of the classes of income enumerated in section 303 of
- 28 the Tax Reform Code of 1971 from sources within this
- 29 Commonwealth, a tax upon each dollar of income received by
- 30 that nonresident during that nonresident's taxable year at

- 1 the rate of 1.88%.
- 2 (c) Deposit in Education Stabilization Fund. --
- 3 (1) All moneys collected under this section shall be deposited in the Education Stabilization Fund.
- 5 (2) So much of the proceeds of the tax imposed by this
- 6 chapter as shall be necessary for the payment of refunds,
- 7 enforcement or administration under this chapter is hereby
- 8 appropriated to the department for such purposes.
- 9 (d) Combination of tax forms. -- The department shall
- 10 incorporate the taxpayer reporting requirement for the
- 11 implementation of this section into the forms utilized by the
- 12 department under Article III of the Tax Reform Code of 1971.
- 13 (e) Definitions.--The words and phrases used in this section
- 14 shall have the same meaning given to them in Article III of the
- 15 Tax Reform Code of 1971.
- 16 CHAPTER 7
- 17 SALES AND USE TAX FOR THE
- 18 STABILIZATION OF EDUCATION FUNDING
- 19 SUBCHAPTER A
- 20 PRELIMINARY PROVISIONS
- 21 Section 700. Scope.
- 22 The tax provided for under this chapter shall be known as the
- 23 Sales and Use Tax for the Stabilization of Education Funding,
- 24 which shall be a replacement for the sales and use tax
- 25 authorized under Article II of the Tax Reform Code of 1971 and
- 26 that is repealed by this act.
- 27 Section 701. Definitions.
- The following words and phrases when used in this chapter
- 29 shall have the meanings given to them in this section unless the
- 30 context clearly indicates otherwise:

1 (a) "Soft drinks."

- (1) All nonalcoholic beverages, whether carbonated or not, such as soda water, ginger ale, Coca Cola, lime cola, Pepsi Cola, Dr Pepper, fruit juice when plain or carbonated water, flavoring or syrup is added, carbonated water, orangeade, lemonade, root beer or any and all preparations, commonly referred to as soft drinks, of whatsoever kind, and are further described as including any and all beverages, commonly referred to as soft drinks, which are made with or without the use of any syrup.
 - (2) The term does not include natural fruit or vegetable juices or their concentrates, or noncarbonated fruit juice drinks containing not less than 25% by volume of natural fruit juices or of fruit juice which has been reconstituted to its original state, or natural concentrated fruit or vegetable juices reconstituted to their original state, whether any of the natural juices are frozen or unfrozen, sweetened or unsweetened, seasoned with salt or spice or unseasoned. The term also does not include coffee, coffee substitutes, tea, cocoa, natural fluid milk or noncarbonated drinks made from milk derivatives.
 - (b) "Maintaining a place of business in this Commonwealth."
 - (1) Having, maintaining or using within this

 Commonwealth, either directly or through a subsidiary,

 representative or an agent, an office, distribution house,

 sales house, warehouse, service enterprise or other place of

 business; or any agent of general or restricted authority, or

 representative, irrespective of whether the place of

 business, representative or agent is located in this

 Commonwealth, permanently or temporarily, or whether the

- person or subsidiary maintaining the place of business,
 - (1.1) Providing taxable services.
 - (2) Engaging in any activity as a business within this Commonwealth by any person, either directly or through a subsidiary, representative or an agent, in connection with the lease, sale or delivery of tangible personal property or the performance of services thereon for use, storage or consumption or in connection with the sale or delivery for use of the services described in subclauses (11) through (18) of clause (k) of this section, including, but not limited to, having, maintaining or using any office, distribution house, sales house, warehouse or other place of business, any stock of goods or any solicitor, canvasser, salesman, representative or agent under its authority, at its direction or with its permission, regardless of whether the person or subsidiary is authorized to do business in this Commonwealth.
 - (3) Regularly or substantially soliciting orders within this Commonwealth in connection with the lease, sale or delivery of tangible personal property to or the performance thereon of services or in connection with the sale or delivery of the services described in subclauses (11) through (18) of clause (k) of this section for residents of this Commonwealth by means of catalogs or other advertising, whether the orders are accepted within or without this Commonwealth.
- 28 (3.1) Entering this Commonwealth by any person to
 29 provide assembly, service or repair of tangible personal
 30 property, either directly or through a subsidiary,

1 representative or an agent.

- (3.2) Delivering tangible personal property to locations 3 within this Commonwealth if the delivery includes the unpacking, positioning, placing or assembling of the tangible personal property.
 - (3.3) Having any contact within this Commonwealth which would allow the Commonwealth to require a person to collect and remit tax under the Constitution of the United States.

 - (3) Refining, blasting, exploring, mining and quarrying for, or otherwise extracting from the earth or from waste or stock piles or from pits or banks any natural resources, minerals and mineral aggregates including blast furnace slag.
- 28 (4) Building, rebuilding, repairing and making additions
 29 to, or replacements in or upon vessels designed for

- 4 (77) The sale at retail or use of goods or services that

- 6 Section 705. Alternate imposition of tax.
- 7 (a) General rule. -- If any person actively and principally
- 8 engaged in the business of selling new or used motor vehicles,
- 9 trailers or semitrailers, and registered with the department in
- 10 the "dealer's class," acquires a motor vehicle, trailer or

- 1 1971 and all licenses issued or renewed on or after the
- 2 effective date of this section shall be valid for a period of

- 4 (b.1) Refusal of license.--
- (1) If an applicant for a license or any person holding
 a license has not filed all required State tax reports and
 paid any State taxes not subject to a timely perfected
 administrative or judicial appeal or subject to a duly
 authorized deferred payment plan, the department may refuse

to issue, may suspend or may revoke said license.

- (2) The department shall notify the applicant or licensee of any refusal, suspension or revocation. The notice shall contain a statement that the refusal, suspension or revocation may be made public. The notice shall be made by first class mail.
- (3) An applicant or licensee aggrieved by the determination of the department may file an appeal pursuant to the provisions for administrative appeals in this chapter, except that the appeal must be filed within 30 days of the date of the notice. In the case of a suspension or revocation which is appealed, the license shall remain valid pending a final outcome of the appeals process.

- 1 Disclosure may include the basis for refusal, suspension or

- 4 (1) A person that maintains a place of business in this

- 28 HOTEL OCCUPANCY TAX
- 29 Section 709. Definitions.
- 30 (a) General rule. -- The following words and phrases when used

- 1 in this subchapter shall have the meanings given to them in this
- 2 section unless the context clearly indicates otherwise:
- 3 "Hotel." A building or buildings in which the public may,
- 4 for a consideration, obtain sleeping accommodations. The term
- 5 does not include any charitable, educational or religious
- 6 institution summer camp for children, hospital or nursing home.
- 7 "Occupancy." The use or possession or the right to the use
- 8 or possession by any person, other than a permanent resident, of
- 9 any room or rooms in a hotel for any purpose or the right to the
- 10 use or possession of the furnishings or to the services and
- 11 accommodations accompanying the use and possession of the room
- 12 or rooms.
- "Occupant." A person, other than a permanent resident, who,
- 14 for a consideration, uses, possesses or has a right to use or
- 15 possess any room or rooms in a hotel under any lease,
- 16 concession, permit, right of access, license or agreement.
- "Operator." Any person who operates a hotel.
- 18 "Permanent resident." Any occupant who has occupied or has
- 19 the right to occupancy of any room or rooms in a hotel for at
- 20 least 30 consecutive days.
- 21 "Rent." The consideration received for occupancy valued in
- 22 money, whether received in money or otherwise, including all
- 23 receipts, cash, credits and property or services of any kind or
- 24 nature, and also any amount for which the occupant is liable for
- 25 the occupancy without any deduction. The term "rent" shall not
- 26 include a gratuity.
- 27 (b) Other definitions. -- The following words and phrases,
- 28 when used in Subchapters D and F, shall, in addition to the
- 29 meaning ascribed to them by section 701, have the meaning
- 30 ascribed to them in this subsection, except where the context

- 1 clearly indicates a different meaning:
- "Maintaining a place of business in this Commonwealth."
- 3 Being the operator of a hotel in this Commonwealth.
- 4 "Purchase at retail." Occupancy.
- 5 "Purchase price." Rent.
- 6 "Purchaser." Occupant.
- 7 "Sale at retail." The providing of occupancy to an occupant
- 8 by an operator.
- 9 "Services." Occupancy.
- 10 "Tangible personal property." Occupancy.
- "Use." Occupancy.
- 12 "Vendor." Operator.
- 13 Section 710. Imposition of tax.
- 14 There is hereby imposed an excise tax of 7% of the rent on
- 15 every occupancy of a room or rooms in a hotel in this
- 16 Commonwealth, which tax shall be collected by the operator from
- 17 the occupant and paid over to the Commonwealth as provided in
- 18 this act.
- 19 Section 711. Seasonal tax returns.
- 20 Notwithstanding any other provisions in this chapter or the
- 21 Tax Reform Code of 1971, the department may, by regulation,
- 22 waive the requirement for the filing of quarterly returns in the
- 23 case of any operator whose hotel is operated only during certain
- 24 seasons of the year, and may provide for the filing of returns
- 25 by such persons at times other than those provided by section
- 26 721.
- 27 SUBCHAPTER F
- 28 PROCEDURE AND ADMINISTRATION
- 29 Section 715. Persons required to make returns.
- 30 Every person required to pay tax to the department or collect

- 1 and remit tax to the department shall file returns with respect
- 2 to the tax.
- 3 Section 716. Form of returns.
- 4 The returns required by section 715 shall be on forms
- 5 prescribed by the department and shall show such information
- 6 with respect to the taxes imposed by this chapter as the
- 7 department may reasonably require.
- 8 Section 717. Time for filing returns.
- 9 (a) Quarterly and monthly returns.--
- 10 (1) For the year in which this chapter becomes
 11 effective, and in each year thereafter, a return shall be
 12 filed quarterly by every licensee on or before the 20th day
 13 of April, July, October and January for the three months
- ending the last day of March, June, September and December.
- 15 (2) For the year in which this chapter becomes
- 16 effective, and in each year thereafter, a return shall be
- filed monthly with respect to each month by every licensee
- 18 whose actual tax liability for the third calendar quarter of
- 19 the preceding year equals or exceeds \$600 and is less than
- \$25,000. Such returns shall be filed on or before the 20th
- 21 day of the next succeeding month with respect to which the
- return is made. Any licensee required to file monthly returns
- 23 under this act shall be relieved from filing quarterly
- 24 returns.
- 25 (3) With respect to every licensee whose actual tax
- 26 liability for the third calendar quarter of the preceding
- year equals or exceeds \$25,000 and is less than \$100,000, the
- licensee shall, on or before the 20th day of each month, file
- a single return consisting of all of the following:
- 30 (i) Either of the following:

- An amount equal to 50% of the licensee's (A) actual tax liability for the same month in the preceding calendar year if the licensee was a monthly filer or, if the licensee was a quarterly or semiannual filer, 50% of the licensee's average actual tax liability for that tax period in the preceding calendar year. The average actual tax liability shall be the actual tax liability for the tax period divided by the number of months in that tax period. For licensees that were not in business during the same month in the preceding calendar year or were in business for only a portion of that month, the amount shall be 50% of the average actual tax liability for each tax period the licensee has been in business. If the licensee is filing a tax liability for the first time with no preceding tax periods, the amount shall be zero.
- (B) An amount equal to or greater than 50% of the licensee's actual tax liability for the same month.
- (ii) An amount equal to the taxes due for the preceding month, less any amounts paid in the preceding month as required by subparagraph (i).
- (4) With respect to each month by every licensee whose actual tax liability for the third calendar quarter of the preceding year equals or exceeds \$100,000, the licensee shall, on or before the 20th day of each month, file a single return consisting of the amounts under paragraph (3)(i)(A) and (ii).
 - (5) The amount due under paragraph (3)(i) or (4) shall

- be due the same day as the remainder of the preceding month's
 tax.
 - (6) The department shall determine whether the amounts reported under paragraph (3) or (4) shall be remitted as one combined payment or as two separate payments.
- 6 (7) The department may require the filing of the returns
 7 and the payments for these types of filers by electronic
 8 means approved by the department.
- 9 (8) Any licensee filing returns under paragraph (3) or 10 (4) shall be relieved of filing quarterly returns.
- 11 If a licensee required to remit payments under 12 paragraph (3) or (4) fails to make a timely payment or makes a payment which is less than the required amount, the 13 department may, in addition to any applicable penalties, 14 15 impose an additional penalty equal to 5% of the amount due 16 under paragraph (3) or (4) which was not timely paid. The penalty under this paragraph shall be determined when the tax 17 18 return is filed for the tax period.
- 19 (b) Annual returns.--No annual return shall be filed, except
 20 as may be required by rules and regulations of the department
 21 promulgated and published at least 60 days prior to the end of
 22 the year with respect to which the returns are made. Where such
 23 annual returns are required, licensees shall not be required to
 24 file such returns prior to the 20th day of the year succeeding
 25 the year with respect to which the returns are made.
- (c) Other returns.--Any person, other than a licensee, liable to pay to the department any tax under this chapter, shall file a return on or before the 20th day of the month succeeding the month in which the person becomes liable for the tax.

- 1 (d) Small taxpayers. -- The department, by regulation, may
- 2 waive the requirement for the filing of quarterly return in the
- 3 case of any licensee whose individual tax collections do not
- 4 exceed \$75 per calendar quarter and may provide for reporting on

- 6 Section 718. Extension of time for filing returns.
- 7 The department may, on written application and for good cause
- 8 shown, grant a reasonable extension of time for filing any
- 9 return required under this subchapter. However, the time for

- 12 Section 719. Place for filing returns.
- Returns shall be filed with the department at its main office
- 14 or at any branch office which it may designate for filing
- 15 returns.
- 16 Section 720. Timely mailing treated as timely filing and
- payment.
- 18 (a) General rule. -- Notwithstanding the provisions of any
- 19 State tax law to the contrary, whenever a report or payment of
- 20 all or any portion of a State tax is required by law to be
- 21 received by the department or other agency of the Commonwealth
- 22 on or before a day certain, the taxpayer shall be deemed to have
- 23 complied with the law if the letter transmitting the report or
- 24 payment of the tax which has been received by the department is
- 25 postmarked by the United States Postal Service on or prior to
- 26 the final day on which the payment is to be received.
- 27 (b) Presentation of receipt. -- For the purposes of this
- 28 chapter, presentation of a receipt indicating that the report or
- 29 payment was mailed by registered or certified mail on or before
- 30 the due date shall be evidence of timely filing and payment.

- 1 Section 721. Payment of tax.
- When a return of tax is required under this subchapter, the
- 3 person required to make the return shall pay the tax to the
- 4 department.
- 5 Section 722. Time of payment.
- 6 (a) General rule. -- The tax imposed by this chapter and
- 7 incurred or collected by a licensee shall be due and payable by
- 8 the licensee on the day the return is required to be filed under
- 9 the provisions of section 717 and the payment must accompany the
- 10 return for the preceding period.
- 11 (b) Annual payments. -- If the amount of tax due for the
- 12 preceding year as shown by the annual return of a taxpayer is
- 13 greater than the amount already paid by the taxpayer in
- 14 connection with the taxpayer's monthly or quarterly returns, the
- 15 taxpayer shall send with the annual return a remittance for the
- 16 unpaid amount of tax for the year.
- 17 (c) Other payments. -- Any person other than a licensee liable
- 18 to pay any tax under this chapter shall remit the tax at the
- 19 time of filing the return required by this chapter.
- 20 Section 723. Other times for payment.
- 21 In the event that the department authorizes a taxpayer to
- 22 file a return at other times than those specified in section
- 23 717, the tax due shall be paid at the time the return is filed.
- 24 Section 724. Place for payment.
- 25 The tax imposed by this chapter shall be paid to the
- 26 department at the place fixed for filing the return.
- 27 Section 725. Tax held in trust for Commonwealth.
- 28 (a) General rule. -- All taxes collected by any person from
- 29 purchasers in accordance with this chapter and all taxes
- 30 collected by any person from purchasers under color of this

- 1 chapter which have not been properly refunded by the person to
- 2 the purchaser shall constitute a trust fund for the
- 3 Commonwealth, and such trust shall be enforceable against such
- 4 person, the person's representatives and any person, other than
- 5 a purchaser to whom a refund has been made properly, receiving
- 6 any part of the fund without consideration, or knowing that the
- 7 taxpayer is committing a breach of trust.
- 8 (b) Presumption. -- Any person receiving payment of a lawful
- 9 obligation of the taxpayer from the fund identified under
- 10 subsection (a) shall be presumed to have received the same in
- 11 good faith and without any knowledge of the breach of trust.
- 12 (c) Right to petition and appeal. -- Any person, other than a
- 13 taxpayer, against whom the department makes any claim under this
- 14 section shall have the same right to petition and appeal as is
- 15 given taxpayers by any provisions of this subchapter.
- 16 Section 726. (Reserved).
- 17 Section 727. Discount.
- 18 (a) General rule. -- Subject to the provisions of subsection
- 19 (b), if a return is filed by a licensee and the tax shown to be
- 20 due thereon less any discount is paid all within the time
- 21 prescribed, the licensee shall be entitled to credit and apply
- 22 against the tax payable by the licensee a discount of 1% of the
- 23 amount of the tax collected by the licensee, as compensation for
- 24 the expense of collecting and remitting the tax due by the
- 25 licensee and as consideration of the prompt payment.
- 26 (b) Types of periodic filers.--For returns filed on or after
- 27 the effective date of this section, the discount under
- 28 subsection (a) shall be limited to the following:
- 29 (1) For a monthly filer, \$25 per return.
- 30 (2) For a quarterly filer, \$75 per return.

- 1 (3) For a semiannual filer, \$150 per return.
- 2 Section 728. (Reserved).
- 3 Section 729. (Reserved).
- 4 Section 730. Assessment.
- 5 The department shall make the inquiries, determinations and
- 6 assessments of the tax, including interest, additions and
- 7 penalties, imposed by this chapter. A notice of assessment and
- 8 demand for payment shall be mailed to the taxpayer. The notice
- 9 shall set forth the basis of the assessment.
- 10 Section 731. Mode and time of assessment.
- 11 (a) Duty to examine.--
- 12 (1) Within a reasonable time after any return is filed,
- 13 the department shall examine it and, if the return shows a
- 14 greater tax due or collected than the amount of tax remitted
- with the return, the department shall issue an assessment for
- the difference, together with an addition of 3% of the
- difference, which shall be paid to the department within 10
- days after a notice of the assessment has been mailed to the
- 19 taxpayer.
- 20 (2) If such assessment is not paid within 10 days, there
- 21 shall be added and paid to the department an additional 3% of
- the difference for each month during which the assessment
- remains unpaid. The total of all additions shall not exceed
- 24 18% of the difference shown on the assessment.
- 25 (b) Understated tax on returns.--
- 26 (1) If the department determines that any return or
- 27 returns of any taxpayer understates the amount of tax due, it
- shall determine the proper amount and shall ascertain the
- difference between the amount of tax shown in the return and
- 30 the amount determined. The difference may be referred to as

- 1 the deficiency.
- 2 (2) The department shall send a notice of assessment for 3 the deficiency and the reasons to the taxpayer.
- 4 (3) The taxpayer shall pay the deficiency to the
 5 department within 30 days after a notice of the assessment
 6 has been mailed to the taxpayer.
- 7 (c) Estimated assessments.--
- 8 (1) In the event that any taxpayer fails to file a
 9 return required by this chapter, the department may make an
 10 estimated assessment, based on information available, of the
 11 proper amount of tax owed by the taxpayer and shall send a
 12 notice of assessment in the estimated amount to the taxpayer.
- 13 (2) The taxpayer shall pay the tax within 30 days after
 14 a notice of the estimated assessment has been mailed to the
 15 taxpayer.
- 16 (d) Studies.--
- 17 (1) The department may conduct the studies necessary to
 18 compute effective rates by business classification, based
 19 upon the ratio between the tax required to be collected and
 20 taxable sales and to use such rates in arriving at the
 21 apparent tax liability of a taxpayer.
- 22 (2) Any assessment based on such rates shall be prima 23 facie correct, except that the rate shall not be considered 24 where a taxpayer establishes the rate is based on a sample 25 inapplicable to the taxpayer.
- 26 Section 732. Reassessment.
- 27 Any taxpayer against whom an assessment is made may petition
- 28 the department for a reassessment under Article XXVII of the Tax
- 29 Reform Code of 1971.
- 30 Section 733. Assessment to recover erroneous refunds.

- 1 The department may, within two years of the granting of any
- 2 refund or credit, or within the period in which an assessment
- 3 could have been filed by the department with respect to the
- 4 transaction pertaining to which the refund was granted,
- 5 whichever period shall last occur, file an assessment to recover
- 6 any refund or part thereof or credit or part thereof which was
- 7 erroneously made or allowed.
- 8 Section 734. (Reserved).

- In all cases of petitions for reassessment, review or appeal,
- 12 the burden of proof shall be on the petitioner or appellant, as

- 14 Section 737. Collection of tax.
- 15 (a) General rule. -- The department shall collect the tax in
- 16 the manner provided by law for the collection of taxes imposed
- 17 by the laws of this Commonwealth.
- 18 (b) Collection by persons maintaining a place of business in
- 19 the Commonwealth.--
- 20 (1) Every person maintaining a place of business in this
- 21 Commonwealth and selling or leasing tangible personal
- 22 property or services, the sale or use of which is subject to
- 23 tax shall collect the tax from the purchaser or lessee at the
- time of making the sale or lease, and shall remit the tax to
- 25 the department, unless the collection and remittance is
- otherwise provided for in this chapter.
- 27 (2) (i) Every person not otherwise required to collect
- tax that delivers tangible personal property to a
- location within this Commonwealth and that unpacks,
- 30 positions, places or assembles the tangible personal

property shall collect the tax from the purchaser at the time of delivery and shall remit the tax to the department if the person delivering the tangible personal property is responsible for collecting any portion of the purchase price of the tangible personal property delivered and the purchaser has not provided the person with proof that the tax imposed by this chapter has been or will be collected by the seller or that the purchaser provided the seller with a valid exemption certificate.

- (ii) Every person required to collect tax under this paragraph shall be deemed to be selling or leasing tangible personal property or services, the sale or use of which is subject to the tax imposed under section 702.
- (3) Any person required under this chapter to collect tax from another person, who shall fail to collect the proper amount of the tax, shall be liable for the full amount of the tax which the person should have collected.
- (c) Certificate for tax-exempt sales or leases.--
- (1) If the tax does not apply to the sale or lease of tangible personal property or services, the purchaser or lessee shall furnish to the vendor a certificate indicating that the sale is not legally subject to the tax. The certificate shall be in substantially such form as the department may, by regulation, prescribe.
- (2) Where the tangible personal property or service is of a type which is never subject to the tax imposed or where the sale or lease of tangible personal property is in interstate commerce, the certificate need not be furnished.
- (3) Where a series of transactions are not subject to tax, a purchaser or user may furnish the vendor with a single

- exemption certificate in substantially such form and valid for such period of time as the department may, by regulation, prescribe.
 - (4) The department shall provide all school districts and intermediate units with a permanent tax exemption number.
 - (5) An exemption certificate, which is complete and regular and on its face discloses a valid basis of exemption if taken in good faith, shall relieve the vendor from the liability imposed by this section.
 - (6) An exemption certificate:
 - (i) accepted by a vendor from a natural person domiciled within this Commonwealth or any association, fiduciary, partnership, corporation or other entity, either authorized to do business within this Commonwealth or having an established place of business within this Commonwealth, in the ordinary course of the vendor's business;
 - (ii) which on its face discloses a valid basis of exemption consistent with the activity of the purchaser and character of the property or service being purchased or which is provided to the vendor by a charitable, religious, educational or volunteer firefighters' organization;

 - (iv) which, in the case of any purchase costing \$200 or more, is accompanied by a sworn declaration on a form to be provided by the department of an intended usage of the property or service which would render it nontaxable, shall be presumed to be taken in good faith and the burden of

- 2 (d) Direct payment permits.--

- 23 vehicle, trailer or semitrailer, except mobile homes as defined
- 24 in 75 Pa.C.S. (relating to vehicles), required by law to be

- 22 equipment, buildings or real estate, involved in a business for
- 23 which the person is licensed or required to be licensed under
- 24 this chapter, or is liable for filing use tax returns in
- 25 accordance with this chapter, shall be subject to the provisions
- 26 of section 1403 of the Fiscal Code.
- 27 Section 741. (Reserved).
- 28 Section 742. Lien for taxes.
- 29 (a) Nature and effect of lien.--
- 30 (1) If any person liable to pay any tax neglects or

- 1 refuses to pay the same after demand, the amount, including
- 2 any interest, addition or penalty, together with any costs
- 3 that may accrue in addition, shall be a lien in favor of the
- 4 Commonwealth on the property, both real and personal, of the
- 5 person but only after same has been entered and docketed of
- 6 record by the prothonotary of the county where the property
- 7 is situated.
- 8 (2) The department may, at any time, transmit to the
- 9 prothonotaries of the respective counties certified copies of
- all liens for taxes imposed by this chapter or the Tax Reform
- 11 Code of 1971 and penalties and interest.
- 12 (3) Each prothonotary receiving the lien shall enter and
- docket the lien of record in the prothonotary's office, which
- lien shall be indexed as judgments are now indexed.

- 18 (b) Priority status.--
- 19 (1) The lien imposed under this section shall have

 - (4) (i) The lien of the taxes, interest and penalties, shall continue for five years from the date of entry, and may be revived and continued in the manner now or hereafter provided for renewal of judgments, or as may be provided in the Fiscal Code, and a writ of execution may directly issue upon the lien without the issuance and prosecution to judgment of a writ of scire facias.
 - (ii) Not less than 10 days before issuance of any execution on the lien, notice of the filing and the effect of the lien shall be sent by registered mail to the taxpayer at the taxpayer's last known post office address.
 - (iii) The lien shall have no effect on any stock of goods, wares or merchandise regularly sold or leased in the ordinary course of business by the person against whom the lien has been entered, unless and until a writ of execution has been issued and a levy made on the stock of goods, wares and merchandise.
- (c) Penalty.--Any willful failure of any prothonotary to carry out any duty imposed on the prothonotary under this section shall be a misdemeanor, and, upon conviction, the prothonotary shall be sentenced to pay a fine not more than

- 1 \$1,000 and costs of prosecution or to a term of imprisonment not
- 2 exceeding one year, or both.
- 3 (d) Priority payment from distribution.--
- 4 (1) Except as otherwise provided under the law, in the
- distribution, voluntary or compulsory, in receivership,

- 19 (e) Construction. -- Subject to the limitations contained in
- 20 this chapter as to the assessment of taxes, nothing contained in
- 21 this section shall be construed to restrict, prohibit or limit
- 22 the use by the department in collecting taxes finally due and
- 23 payable of any other remedy or procedure available at law or
- 24 equity for the collection of debts.
- 25 Section 743. Suit for taxes.
- 26 (a) General rule. -- At any time within three years after any
- 27 tax or any amount of tax shall be finally due and payable, the
- 28 department may commence an action in the courts of this
- 29 Commonwealth, of any state or of the United States, in the name
- 30 of the Commonwealth, to collect the amount of tax due together

- 1 with additions, interest, penalties and costs in the manner
- 2 provided at law or in equity for the collection of ordinary
- 3 debts.
- 4 (b) Prosecution by Attorney General. -- The Attorney General
- 5 shall prosecute the action and, except as provided in this
- 6 chapter, the provisions of the Rules of Civil Procedure and the
- 7 provisions of the laws of this Commonwealth relating to civil
- 8 procedures and remedies shall, to the extent that they are
- 9 applicable, be available in such proceedings.
- 10 (c) Construction. -- The provisions of this section are in
- 11 addition to any process, remedy or procedure for the collection

- 15 Section 744. Tax suit comity.
- 16 The courts of this Commonwealth shall recognize and enforce
- 17 liabilities for sales and use taxes, lawfully imposed by any
- 18 other state if the other state extends a like comity to this
- 19 Commonwealth.
- 20 Section 745. Service.
- 21 (a) General rule. -- Any person who maintains a place of
- 22 business in this Commonwealth is deemed to have appointed the
- 23 Secretary of the Commonwealth as the person's agent for the
- 24 acceptance of service of process or notice in any proceedings
- 25 for the enforcement of the civil provisions of this chapter, and
- 26 any service made upon the Secretary of the Commonwealth as agent
- 27 shall be of the same legal force and validity as if the service
- 28 had been personally made on the person.
- 29 (b) Substitute service. -- Where service cannot be made on the
- 30 person in the manner provided by other laws of this Commonwealth

- 1 relating to service of process, service may be made on the
- 2 Secretary of the Commonwealth and, in such case, a copy of the
- 3 process or notice shall also be personally served on any agent
- 4 or representative of the person who may be found within this
- 5 Commonwealth, or where no such agent or representative may be

- 9 Section 746. Collection and payment of tax on credit sales.

- 8 (a) General rule. -- A vendor may file a petition for refund
- 9 of sales tax paid to the department that is attributed to a bad
- 10 debt if all of the following apply:
- 11 (1) The purchaser fails to pay the total purchase price.
- 12 (2) The purchase price is written off, either in whole
- or in part, as a debt on the books and records of the vendor
- or an affiliate of the vendor.
- 15 (3) The bad debt has been deducted for Federal income
- 16 tax purposes under section 166 of the Internal Revenue Code
- 17 of 1986.
- 18 (a.1) Time for filing petition. -- A petition for refund,
- 19 which is authorized by this section, must be filed with the
- 20 department within the time limitations under section 3003.1(a)
- 21 of the Tax Reform Code of 1971.
- 22 (a.2) Private-label credit cards. -- In the case of private-
- 23 label credit card accounts not qualifying under subsection (a),
- 24 a vendor or lender that makes an election pursuant to subsection
- 25 (a.3) shall be entitled to file a petition for refund of sales
- 26 tax that the vendor has previously reported and paid to the
- 27 department, if all of the following conditions are met:
- 28 (1) No refund was previously allowed with respect to the
- 29 portion of the account written off as a bad debt.
- 30 (2) The account has been found worthless and written

- off, either in whole or in part, as bad debt on the books and
- 2 records of the lender or an affiliate of the lender.
- 3 (3) The account has been deducted for Federal income tax
- 4 purposes under section 166 of the Internal Revenue Code of
- 5 1986 by the lender or an affiliate of the lender.
- 6 (a.3) Joint election. -- In order to be eligible for a refund
- 7 under subsection (a.2), the lender and the vendor must execute
- 8 and file with the department a joint election, signed by both
- 9 parties, designating which party is entitled to claim the
- 10 refund. This election may not be revoked unless a written notice
- 11 is signed by the party that signed the election being revoked
- 12 and is filed with the department.
- 13 (b) Limitation.--
- 14 (1) The refund authorized by this section shall be
- 15 limited to the sales tax paid to the department that is
- 16 attributed to the bad debt, less any discount under section
- 17 727.
- 18 (2) Partial payments by the purchaser shall be prorated
- between the original purchase price and the sales tax due on
- 20 the sale.
- 21 (3) Payments made on any transaction which includes both
- taxable and nontaxable components shall be allocated
- proportionally between the taxable and nontaxable components.
- 24 (c) Assignment. -- A vendor or lender may assign its right to
- 25 petition and receive a refund of sales tax attributed to a bad
- 26 debt to an affiliate.
- 27 (d) Items not refundable. -- No refund shall be granted under
- 28 this section for interest, finance charges or expenses incurred
- 29 in attempting to collect any amount receivable.
- 30 (e) Documentation.--Documentation requirements are as

- 2 (1) Any person claiming a refund under this section 3 shall, on request, make available adequate books, records or 4 other documentation supporting the claimed refund, including:
- 5 (i) Date of original sale, name and Pennsylvania 6 sales tax license number of the retailer.
 - (ii) Name and address of purchaser.
- 8 (iii) Amount that the purchaser paid or agreed to pay.
- 10 (iv) Taxable and nontaxable charges.
- 11 (v) Amount on which the retailer reported and paid 12 sales tax.
- 13 (vi) All payments or other credits applied to the 14 account of the purchaser.
 - (vii) Evidence that the uncollected amount has been designated as a bad debt in the books and records of the vendor or lender, as appropriate, and that the amount has been claimed as a bad debt deduction for Federal income tax purposes.
- 20 (viii) The county in which any local sales tax was incurred.
- 22 (ix) The unpaid portion of the sales price.
- 23 (x) A certification, under penalty of perjury, that
 24 no person has collected money on the bad debt for which
 25 the refund is claimed.

- 28 (2) A person claiming a refund under this section may
 29 provide alternative forms of documentation acceptable to the
 30 department if appropriate in light of the volume and

- 1 character of uncollectible accounts. This includes the following:
 - (i) If a vendor remits sales or use tax to the Commonwealth and to another state, the entity claiming a refund under this section may use an apportionment method to substantiate the amount of Pennsylvania tax included in the bad debts to which the refund applies.
 - (ii) The apportionment method must use the vendor's Pennsylvania and non-Pennsylvania sales, the vendor's taxable and nontaxable sales and the amount of tax the vendor remitted to Pennsylvania.
 - (f) Subsequent collection. --

- (1) If the purchase price that is attributed to a prior bad debt refund is collected in whole or in part by the vendor or lender, or an affiliate of the vendor or lender, the entity claiming the refund shall remit the proportional tax to the department with the first return filed after the collection. If the entity is not required to file periodic returns, the entity shall remit the proportional tax to the department with another return pursuant to section 717(c).
- (2) Any consideration received for the assignment, sale or other transfer of a bad debt with respect to which a refund has been granted shall be deemed to be a collection of a prior bad debt. This paragraph shall not apply to a transfer to an entity that is part of the same affiliated group, as defined by section 1504(a)(1) of the Internal Revenue Code of 1986.
- (3) A person that collects, in whole or in part, the purchase price attributed to a prior bad debt refund is required to maintain adequate books, records or other

- documentation to allow the department to determine whether
- 2 the purchase price attributed to a prior bad debt refund has
- 3 been collected. Information under this paragraph includes the
- 4 pertinent facts required by subsection (e).
- 5 (4) If it is determined by the department that a prior
- 6 bad debt has been collected, in whole or in part, and the
- 7 proportional tax has not been properly reported and paid to
- 8 the department, the person that claimed the refund on the
- 9 transaction shall report and pay the proportional tax to the
- department plus applicable interest and penalty under this
- 11 chapter.
- 12 (g) Interest prohibited. -- Notwithstanding the provisions of
- 13 section 806.1 of the Fiscal Code, no interest shall be paid by

- 17 (1) No refund or credit of sales tax shall be made for

- 22 (3) This section shall provide the exclusive procedure
- for claiming a refund or credit of sales tax attributed to

- 8 "Lender." Any of the following:

- 12 (2) A person that owns or has owned a private-label
- credit card account pursuant to a contract directly with the
- vendor that reported the tax under this chapter.

- 18 (ii) an assignee or other transferee of a person
- described in paragraph (1) or (2).
- 20 "Private-label credit card." Any charge card, credit card or
- 21 other instrument serving similar purpose which carries, refers
- 22 to or is branded with the name or logo of a vendor and which can
- 23 be used for purchases from the vendor. The term does not include
- 24 a card or instrument which may also be used to make purchases
- 25 from persons other than the vendor whose name or logo appears on

- 30 Section 748. Registration of transient vendors.

- 1 (a) General rule. -- Prior to conducting business or otherwise
- 2 commencing operations in this Commonwealth, a transient vendor
- 3 shall register with the department. The application for
- 4 registration shall be in such form and contain such information
- 5 as the department, by regulation, shall prescribe and shall set
- 6 forth truthfully and accurately the information desired by the
- 7 department. This registration shall be renewed and updated
- 8 annually.
- 9 (b) Certificate to be issued. -- After registration and the
- 10 posting of the bond required by section 748.1, the department
- 11 shall issue to the transient vendor a certificate valid for one
- 12 year. On renewal of registration, the department shall issue a
- 13 new certificate valid for one year, if the department is
- 14 satisfied that the transient vendor has complied with the
- 15 provisions of this chapter.
- 16 (c) Possession and exhibition of certificate. -- The transient
- 17 vendor shall possess the certificate at all times when
- 18 conducting business within this Commonwealth and shall exhibit
- 19 the certificate upon demand by authorized employees of the
- 20 department or any law enforcement officer.
- 21 (d) Contents of certificate. -- The certificate issued by the
- 22 department shall state that the transient vendor named in the
- 23 certificate has registered with the department and shall provide
- 24 notice to the transient vendor that:
- 25 (1) The transient vendor must notify the department in
- 26 writing before it enters this Commonwealth to conduct
- business, of the location or locations where it intends to
- conduct business and the date or dates on which it intends to
- 29 conduct business.
- 30 (2) Failure to notify or giving false information to the

- department may result in suspension or revocation of the
- 2 transient vendor's certificate.
- 3 (3) Conducting business in this Commonwealth after a
- 4 certificate has been suspended or revoked may result in
- 5 criminal conviction and the imposition of fines or other
- 6 penalties.
- 7 Section 748.1. Bond.
- 8 (a) General rule. -- Upon registration with the department, a
- 9 transient vendor shall also post a bond with the department in
- 10 the amount of \$500 as surety for compliance with the provisions
- 11 of this chapter. After a period of demonstrated compliance with
- 12 these provisions or, if the transient vendor provides the
- 13 license number of a promoter who has notified the department of
- 14 a show, in accordance with the provisions of section 748.6(a),
- 15 the department may reduce the amount of bond required of a
- 16 transient vendor or may eliminate the bond entirely.
- 17 (b) Voluntary suspension of certificate. -- A transient vendor
- 18 may file a request for voluntary suspension of certificate with
- 19 the department. If the department is satisfied that the
- 20 provisions of this chapter have been complied with and has
- 21 possession of the transient vendor's certificate, it shall
- 22 return the bond posted to the transient vendor.
- 23 Section 748.2. Notification to department.
- 24 (a) General rule. -- Prior to entering this Commonwealth to
- 25 conduct business, a transient vendor shall notify the department
- 26 in writing of the location or locations where it intends to
- 27 conduct business and the date or dates on which it intends to
- 28 conduct business.
- 29 (b) Inspection of records. -- While conducting business in
- 30 this Commonwealth, the transient vendor shall permit authorized

- 1 employees of the department to inspect its sales records,
- 2 including, but not limited to, sales receipts and inventory or
- 3 price lists and to permit inspection of the tangible personal
- 4 property offered for sale at retail.
- 5 (c) Conditions for suspension or revocation of
- 6 certificate. -- The department may suspend or revoke a certificate
- 7 issued to a transient vendor if the transient vendor:
- 8 (1) fails to notify the department as required by
- 9 subsection (a);
- 10 (2) provides the department with false information
- 11 regarding the conduct of business in this Commonwealth;
- 12 (3) fails to collect sales tax on all tangible personal
- property or services sold subject to the sales tax; or
- 14 (4) fails to file with the department a tax return as
- 15 required by section 717.
- 16 (d) Regulations.--The department shall promulgate the rules
- 17 and regulations necessary to implement this section.
- 18 Section 748.3. Seizure of property.
- 19 (a) General rule. -- If a transient vendor conducting business
- 20 in this Commonwealth fails to exhibit a valid certificate on
- 21 demand by authorized employees of the department, those
- 22 authorized employees shall seize, without warrant, the tangible
- 23 personal property and the automobile, truck or other means of
- 24 transportation used to transport or carry that property. All
- 25 property seized shall be deemed contraband and shall be subject
- 26 to immediate forfeiture proceedings instituted by the department
- 27 pursuant to procedures adopted by regulation, except as
- 28 otherwise provided by this section.
- 29 (b) Release of seized property. -- Property seized pursuant to
- 30 subsection (a) shall be released on:

- 1 (1) presentation of a valid certificate to authorized
- 2 employees of the department; or
- 3 (2) registration by the transient vendor with the
- 4 department and the posting of a bond in the amount of \$500,
- 5 either immediately or within 15 days after the property is
- 6 seized.
- 7 Section 748.4. Fines.
- 8 Any transient vendor conducting business in this Commonwealth
- 9 while its certificate is suspended or revoked, as provided by
- 10 sections 748.1(b) and 748.2(c), commits a misdemeanor of the
- 11 third degree and, upon conviction, shall be sentenced to pay a
- 12 fine of not more than \$2,500 for each offense.
- 13 Section 748.5. Transient vendors subject to chapter.
- 14 Except as otherwise provided, a transient vendor shall be
- 15 subject to the provisions of this chapter in the same manner as
- 16 a vendor who maintains a place of business in this Commonwealth.
- 17 Section 748.6. Promoters.
- 18 (a) General rule. -- A promoter of a show or shows in this
- 19 Commonwealth may annually file with the department an
- 20 application for a promoter's license stating the location and
- 21 dates of such show or shows. The application shall be filed at
- 22 least 30 days prior to the opening of the first show and shall
- 23 be in such form as the department may prescribe.
- 24 (b) License.--
- 25 (1) Except as otherwise provided in this chapter, the
- department shall, within 15 days after receipt of an
- application for a license, issue to the promoter without
- charge a license to operate such shows.
- 29 (2) If application for a license under this section has
- 30 been timely filed and if the license has not been received by

- 1 the promoter prior to the opening of the show, the
- 2 authorization contained in this section with respect to the
- 3 obtaining of a promoter's license shall be deemed to have
- 4 been complied with, unless or until the promoter receives
- 5 notice from the department denying the application for a
- 6 promoter's license.
- 7 (c) Compliance. -- Any promoter who is a vendor under the
- 8 provisions of section 701 shall comply with all the provisions
- 9 of this chapter applicable to vendors and with the provisions of
- 10 this section applicable to promoters.
- 11 (d) Prohibited conduct. -- No licensed promoter shall permit
- 12 any person to display for sale or to sell tangible personal
- 13 property or services subject to tax under section 702 at a show
- 14 unless the person is licensed under section 708 and provides to
- 15 the promoter the information required under law.
- 16 (e) Penalties.--
- 17 (1) Any licensed promoter who:
- 18 (i) permits any person to display for sale or to
- 19 sell tangible personal property or service without first
- 20 having been licensed under section 708;
- 21 (ii) fails to maintain records of a show as required
- 22 by law; or
- 23 (iii) knowingly maintains false records or fails to
- 24 comply with any provision contained in this section or
- any regulation promulgated by the department pertaining
- to shows,
- shall be subject to denial of a license or the revocation of
- any existing license issued pursuant to this section.
- 29 (2) The department may deny the promoter a license
- 30 certificate to operate a show for a period of not more than

- 1 six months from the date of such denial. The penalty shall be
- 2 in addition to any other penalty imposed by this chapter.
- 3 (3) Within 20 days of notice of denial or revocation of
- 4 a license by the department, the promoter may petition the
- 5 department for a hearing pursuant to 2 Pa.C.S. (relating to
- 6 administrative law and procedure).
- 7 Section 749. (Reserved).
- 8 Section 750. (Reserved).
- 9 Section 751. (Reserved).
- 10 Section 752. Refunds.
- 11 (a) General rule. -- Subject to the provisions of subsection
- 12 (b), the department shall, pursuant to the provisions of Article
- 13 XXVII of the Tax Reform Code of 1971, refund all taxes, interest
- 14 and penalties paid to the Commonwealth under the provisions of
- 15 this chapter and to which the Commonwealth is not rightfully
- 16 entitled. The refunds shall be made to the person, the person's
- 17 heirs, successors, assigns or other personal representatives,
- 18 who actually paid the tax.
- 19 (b) Exception. -- No refund shall be made under this section
- 20 with respect to any payment made by reason of an assessment with
- 21 respect to which a taxpayer has filed a petition for
- 22 reassessment pursuant to section 2702 of the Tax Reform Code of
- 23 1971 to the extent that the petition has been determined
- 24 adversely to the taxpayer by a decision which is no longer
- 25 subject to further review or appeal.
- 26 (c) Construction. -- Nothing contained in this section shall
- 27 be deemed to prohibit a taxpayer who has filed a timely petition
- 28 for reassessment from amending it to a petition for refund where
- 29 the petitioner has paid the tax assessed.
- 30 Section 753. Refund petition.

- 1 (a) General rule. -- Except as provided for in subsection (b)
- 2 and section 756, the refund or credit of tax, interest or
- 3 penalty provided for by section 752 shall be made only where the
- 4 person who has actually paid the tax files a petition for refund
- 5 with the department under Article XXVII of the Tax Reform Code
- 6 of 1971, within the limits of section 3003.1 of the Tax Reform
- 7 Code of 1971.
- 8 (b) Assessments.--A refund or credit of tax, interest or
- 9 penalty paid as a result of an assessment made by the department
- 10 under section 731 shall be made only where the person who has
- 11 actually paid the tax files with the department a petition for a
- 12 refund with the department under Article XXVII of the Tax Reform
- 13 Code of 1971 within the time limits of section 3003.1 of the Tax
- 14 Reform Code of 1971. The filing of a petition for refund under
- 15 the provisions of this subsection shall not affect the abatement
- 16 of interest, additions or penalties to which the person may be
- 17 entitled by reason of the person's payment of the assessment.
- 18 Section 754. (Reserved).
- 19 Section 755. (Reserved).
- 20 Section 756. Extended time for filing special petition for
- 21 refund.
- 22 (a) General rule. -- Any party to a transaction who has paid
- 23 tax by reason of a transaction with respect to which the
- 24 department is assessing tax against another person may, within
- 25 six months after the filing by the department of the assessment
- 26 against the other person, file a special petition for refund,
- 27 notwithstanding the person's failure to timely file a petition
- 28 pursuant to section 3003.1 of the Tax Reform Code of 1971. The
- 29 provisions of Article XXVII of the Tax Reform Code of 1971 shall
- 30 be applicable to the special petition for refund, except that

- 1 the department need not act on the petition until there is a
- 2 final determination as to the propriety of the assessment filed
- 3 against the other party to the transaction. Where a petition is
- 4 filed under this provision in order to take advantage of the
- 5 extended period of limitations, overpayments by the petitioner
- 6 shall be refunded but only to the extent of the actual tax,
- 7 without consideration of interest and penalties, paid by the
- 8 other party to the transaction.
- 9 (b) Purpose. -- The purpose of this section is to avoid
- 10 duplicate payment of tax where a determination is made by the
- 11 department that one party to a transaction is subject to tax,
- 12 and another party to the transaction has previously paid tax
- 13 with respect to the transaction and, as such, this section shall
- 14 be construed as extending right beyond that provided for by
- 15 section 753, and not to limit the other section.
- 16 Section 757. (Reserved).
- 17 Section 758. Limitation on assessment and collection.
- 18 The amount of the tax imposed by this chapter shall be
- 19 assessed within three years after the date when the return
- 20 provided for by section 717(a) or (c) is filed or the end of the
- 21 year in which the tax liability arises, whichever occurs later.
- 22 Any assessment may be made at any time during the period
- 23 notwithstanding that the department may have made one or more
- 24 previous assessments against the taxpayer for the year in
- 25 question, or for any part of the year. In any case, no credit
- 26 shall be given for any penalty previously assessed or paid.
- 27 Section 759. Failure to file return.
- Where no return is filed, the amount of the tax due may be
- 29 assessed and collected at any time as to taxable transactions
- 30 not reported.

- 1 Section 760. False or fraudulent return.
- 2 Where the taxpayer willfully files a false or fraudulent
- 3 return with intent to evade the tax imposed by this chapter, the
- 4 amount of tax due may be assessed and collected at any time.
- 5 Section 761. Extension of limitation period.
- 6 Notwithstanding any other provisions of this subchapter
- 7 where, before the expiration of the period prescribed in that
- 8 other provision for the assessment of a tax, a taxpayer has
- 9 consented in writing that the period be extended, the amount of
- 10 tax due may be assessed at any time within the extended period.
- 11 The period so extended may be extended further by subsequent
- 12 consents in writing made before the expiration of the extended
- 13 period.
- 14 Section 762. (Reserved).
- 15 Section 763. (Reserved).
- 16 Section 764. (Reserved).
- 17 Section 765. (Reserved).
- 18 Section 766. Additions to tax.
- 19 (a) Failure to file return. -- In the case of failure to file
- 20 any return required by section 715 on the date prescribed for
- 21 the return, determined with regard to any extension of time for
- 22 filing, and, in the case in which a return filed understates the
- 23 true amount due by more than 50%, there shall be added to the
- 24 amount of tax actually due 5% of the amount of the tax if the
- 25 failure to file a proper return is for not more than one month,
- 26 with an additional 5% for each additional month, or fraction
- 27 thereof, during which such failure continues, not exceeding 25%
- 28 in the aggregate. In every case at least \$2 shall be added.
- 29 (b) Addition for understatement. -- There shall be added to
- 30 every assessment under section 731(b) an addition equal to 5% of

- 1 the amount of the understatement and no addition to the tax
- 2 shall be paid under section 731(a).
- 3 Section 767. Penalties.
- 4 (a) General rule. -- The penalties, additions, interest and
- 5 liabilities provided by this chapter shall be paid on notice and
- 6 demand by the department, and shall be assessed and collected in
- 7 the same manner as taxes. Except as otherwise provided, any
- 8 reference in this chapter to tax imposed by this chapter shall
- 9 be deemed also to refer to the penalties, additions, interest
- 10 and liabilities provided by this chapter.
- 11 (b) Monetary penalty. -- Any person who willfully attempts, in
- 12 any manner, to evade or defeat the tax imposed by this chapter,
- 13 or the payment thereof, or to assist any other person to evade
- 14 or defeat the tax imposed by this chapter, or the payment
- 15 thereof, or to receive a refund improperly shall, in addition to
- 16 other penalties provided by law, be liable for a penalty equal
- 17 to one-half of the total amount of the tax evaded.
- 18 (c) Burden of proof. -- In any direct proceeding arising out
- 19 of a petition for reassessment or refund as provided in this
- 20 chapter, in which an issue of fact is raised with respect to
- 21 whether a return is fraudulent or with respect to the propriety
- 22 of the imposition by the department of the penalty prescribed in
- 23 subsection (b), the burden of proof with respect to the issue
- 24 shall be on the department.
- 25 Section 768. Criminal offenses.
- 26 (a) False returns. -- Any person who with intent to defraud
- 27 the Commonwealth willfully makes, or causes to be made, any
- 28 return required by this chapter which is false commits a
- 29 misdemeanor and, upon conviction, shall be sentenced to pay a
- 30 fine of not more than \$2,000 or to imprisonment not exceeding

- 1 three years, or both.
- 2 (b) Other offenses. -- Except as otherwise provided by
- 3 subsection (a) and subject to the provisions of subsection (c),
- 4 any person who:
- 5 (1) advertises or holds out or states to the public or
- 6 to any purchaser or user, directly or indirectly, that the
- 7 tax or any part imposed by this chapter will be absorbed by
- 8 the person, or that it will not be added to the purchase
- 9 price of the tangible personal property or services described
- in section 701(k)(2), (3), (4), (11), (12), (13), (14), (15),
- 11 (16), (17), (18) and (20) sold or, if added, that the tax or
- any part will be refunded, other than when the person refunds
- 13 the purchase price because of the property being returned to
- 14 the vendor;
- 15 (2) sells or leases tangible personal property or the
- services, the sale or use of which by the purchaser is
- subject to tax under this chapter, and willfully fails to
- 18 collect the tax from the purchaser and timely remit the same
- 19 to the department;
- 20 (3) willfully fails or neglects to timely file any
- 21 return or report required by this chapter or, as a taxpayer,
- refuses to timely pay any tax, penalty or interest imposed or
- provided for by this chapter, or willfully fails to preserve
- the person's books, papers and records as directed by the
- 25 department;
- 26 (4) refuses to permit the department or any of its
- authorized agents to examine the person's books, records or
- 28 papers, or who knowingly makes any incomplete, false or
- 29 fraudulent return or report;
- 30 (5) does or attempts to do anything to prevent the full

- 1 disclosure of the amount or character of taxable sales
- 2 purchases or use made by himself or any other person;
- 3 (6) provides any person with a false statement as to the
- 4 payment of tax with respect to particular tangible personal
- 5 property or services; or
- 6 (7) makes, utters or issues a false or fraudulent
- 7 exemption certificate;
- 8 commits a misdemeanor and, upon conviction shall be sentenced to
- 9 pay a fine of not more than \$1,000 and costs of prosecution or
- 10 to imprisonment for not more than one year, or both.
- 11 (c) Exceptions.--
- 12 (1) Any person who maintains a place of business outside
- this Commonwealth may absorb the tax with respect to taxable
- sales made in the normal course of business to customers
- present at that place of business without being subject to
- 16 the penalty and fines.
- 17 (2) Advertising tax-included prices shall be
- 18 permissible, if the prepaid services are sold by the service
- 19 provider, for prepaid telecommunications services not
- 20 evidenced by the transfer of tangible personal property or
- 21 for prepaid mobile telecommunications services.
- 22 (d) Penalties are cumulative. -- The penalties imposed by this
- 23 section shall be in addition to any other penalties imposed by
- 24 any provision of this chapter.
- 25 Section 769. Abatement of additions or penalties.
- 26 On the filing of a petition for reassessment or a petition
- 27 for refund as provided under this chapter by a taxpayer,
- 28 additions or penalties imposed on the taxpayer by this chapter
- 29 may be waived or abated, in whole or in part, where the
- 30 petitioner has established that the petitioner has acted in good

- 1 faith, without negligence and with no intent to defraud.
- 2 Section 770. Rules and regulations.
- 3 (a) General rule. -- The department shall enforce the
- 4 provisions of this chapter and shall prescribe, adopt,
- 5 promulgate and enforce rules and regulations not inconsistent
- 6 with the provisions of this chapter, relating to any matter or
- 7 thing pertaining to the administration and enforcement of the
- 8 provisions of this chapter, and the collection of taxes,
- 9 penalties and interest imposed by this chapter. The department
- 10 may prescribe the extent, if any, to which any of the rules and
- 11 regulations shall be applied without retroactive effect.
- 12 (b) Determination of purchase price.--
- In determining the purchase price of taxable sales 13 where, because of affiliation of interests between the vendor 14 15 and the purchaser or irrespective of any such affiliation, if 16 for any other reason, the purchase price of the sale is in the opinion of the department not indicative of the true 17 18 value of the article or the fair price of the article, the 19 department shall, pursuant to uniform and equitable rules, 20 determine the amount of constructive purchase price on the

basis of which the tax shall be computed and levied.

- (2) The rules shall provide for a constructive amount of a purchase price for each sale, which price shall equal a price for the article which would naturally and fairly be charged in an arm's-length transaction in which the element of common interests between vendor and purchaser or, if no common interest exists, any other element causing a distortion of the price or value is absent.
- 29 (3) For the purpose of this chapter where a taxable sale 30 occurs between a parent corporation and a subsidiary

- 1 affiliate or controlled corporation of such parent, there
- 2 shall be a rebuttable presumption that because of such common
- 3 interest the transaction was not at arm's-length.
- 4 Section 771. Keeping of records.
- 5 (a) Persons liable for taxes. -- Every person liable for any
- 6 tax imposed by this chapter, or for the collection of the tax,
- 7 shall keep the records, render such statements, make the returns
- 8 and comply with the rules and regulations as the department may,
- 9 from time to time, prescribe regarding matters pertinent to the
- 10 person's business. Whenever in the judgment of the department it
- 11 is necessary, it may require any person, by notice served on the
- 12 person, or by regulations, to make the returns, render the
- 13 statements or keep the records as the department deems
- 14 sufficient to show whether the person is liable to pay or
- 15 collect tax under this chapter.
- 16 (b) Persons collecting taxes. -- Any person liable to collect
- 17 tax from another person under the provisions of this chapter
- 18 shall file reports, keep records, make payments and be subject
- 19 to interest and penalties as provided for under this chapter, in
- 20 the same manner as if the person were directly subject to the
- 21 tax.
- 22 (c) Nonresidents.--
- 23 (1) A nonresident who does business in this Commonwealth
- 24 as a retail dealer shall keep adequate records of the
- business and of the tax due with respect to the business,
- 26 which records shall at all times be retained within this
- 27 Commonwealth unless retention outside this Commonwealth is
- authorized by the department.
- 29 (2) No taxes collected from purchasers shall be sent
- 30 outside this Commonwealth without the written consent of and

- 1 in accordance with conditions prescribed by the department.
- 2 (3) The department may require a taxpayer who desires to 3 retain records or tax collections outside this Commonwealth 4 to assume reasonable out-of-State audit expenses.
- 5 (d) Retail dealers.--

- (1) Any person doing business as a retail dealer who at the same time is engaged in another business which does not involve the making of sales taxable under this chapter shall keep separate books and records of the person's businesses so as to show the sales taxable under this chapter separately from the sales not taxable under this chapter.
 - (2) If the person fails to keep such separate books and records, the person shall be liable for tax at the rate designated in section 702 on the entire purchase price of sales from both or all of the person's businesses.
 - (e) Segregation of taxes required. --
 - (1) In those instances where a vendor gives no sales memoranda or uses registers showing only total sales, the vendor shall adopt some method of segregating tax from sales receipts and keep records showing the segregation, all in accordance with proper accounting and business practices.
 - (2) A vendor may apply to the department for permission to use a collection and recording procedure which will show the information as the law requires with reasonable accuracy and simplicity. The application must contain a detailed description of the procedure to be adopted.
 - (3) Permission to use the proposed procedure is not to be construed as relieving the vendor from remitting the full amount of tax collected.
- 30 (4) The department may revoke the permission on 30 days'

- 1 notice to the vendor.
- 2 (5) Refusal of the department to grant permission in
- 3 advance to use the procedure shall not be construed to
- 4 invalidate a procedure which on examination shows the
- 5 information as the law requires.
- 6 Section 771.1. Reports and records of promoters.
- 7 Every licensed promoter shall keep a record of the date and
- 8 place of each show and the name, address, sales, use and hotel
- 9 occupancy license number of every person whom the licensed
- 10 promoter permits to display for sale or to sell tangible
- 11 personal property or services subject to tax under section 702
- 12 at the show. The records shall be open for inspection and
- 13 examination at any reasonable time by the department or a duly
- 14 authorized representative, and the records shall, unless the
- 15 department consents in writing to an earlier destruction, be
- 16 preserved for three years after the date the report was filed or
- 17 the date it was due, whichever occurs later, except that the
- 18 department may by regulation require that they be kept for a
- 19 longer period of time.
- 20 Section 772. Examinations.
- 21 (a) Power of department. -- The department or any of its
- 22 authorized agents may examine the books, papers and records of
- 23 any taxpayer in order to verify the accuracy and completeness of
- 24 any return made or if no return was made, to ascertain and
- 25 assess the tax imposed by this chapter. The department may
- 26 require the preservation of all such books, papers and records
- 27 for any period deemed proper by it but not to exceed three years
- 28 from the end of the calendar year to which the records relate.
- 29 (b) Duty of taxpayers. -- Every taxpayer shall give to the
- 30 department, or its agent, the means, facilities and opportunity

- 1 for the examinations and investigation.
- 2 (c) Other powers of department.--
- 3 (1) The department is further authorized to examine any 4 person, under oath, concerning taxable sales or use by any 5 taxpayer or concerning any other matter relating to the 6 enforcement or administration of this chapter, and to this 7 end may compel the production of books, papers and records 8 and the attendance of all persons whether as parties or
- 9 witnesses whom it believes to have knowledge of such matters.
 10 (2) The procedure for such hearings or examinations
- shall be the same as that provided by the Fiscal Code
- 12 relating to inquisitorial powers of fiscal officers.
- 13 Section 773. Records and examinations of delivery agents.
- 14 Every agent for the purpose of delivery of goods shipped into
- 15 this Commonwealth by a nonresident, including, but not limited
- 16 to, a common carrier, shall maintain adequate records of such
- 17 deliveries pursuant to rules and regulations adopted by the
- 18 department and shall make the records available to the
- 19 department upon request after due notice.
- 20 Section 774. Unauthorized disclosure.
- 21 Any information gained by the department as a result of any
- 22 return, examination, investigation, hearing or verification
- 23 required or authorized by this chapter shall be confidential,
- 24 except for official purposes and except in accordance with
- 25 proper judicial order or as otherwise provided by law, and any
- 26 person unlawfully divulging such information commits a
- 27 misdemeanor and, upon conviction, shall be sentenced to pay a
- 28 fine of not more than \$1,000 and costs of prosecution or to
- 29 imprisonment for not more than one year, or both.
- 30 Section 775. Cooperation with other governments.

- 1 Notwithstanding the provisions of section 774, the department
- 2 may permit the Commissioner of Internal Revenue of the United
- 3 States, or the proper officer of any state, or the authorized
- 4 representative of either such officer, to inspect the tax
- 5 returns of any taxpayer, or may furnish to the officer or to the
- 6 officer's authorized representative an abstract of the return of
- 7 any taxpayer, or supply the officer or the authorized
- 8 representative with information concerning any item contained in
- 9 any return or disclosed by the report of any examination or
- 10 investigation of the return of any taxpayer. This permission
- 11 shall be granted only if the statutes of the United States or of
- 12 such other state, as the case may be, grant substantially
- 13 similar privileges to the proper officer of the Commonwealth
- 14 charged with the administration of this chapter.
- 15 Section 776. Interstate compacts.

- and payable;
- 30 (2) was a widow or widower and was at least 50 years of

- 1 age during a calendar year or part thereof in which real
- 2 property taxes or rent were due and payable; or
- 3 (3) was a permanently disabled person 18 years of age or
- 4 older during a calendar year or part thereof in which the
- 5 real property taxes or rent were due and payable.
- 6 "Department." The Department of Revenue of the Commonwealth.
- 7 "Homestead." A dwelling, whether owned or rented, and so

- 25 (iii) Eligibility in the property tax and rent
- rebate program pursuant to subparagraph (ii) shall expire
- on December 31, 2018.
- 28 (4) All benefits received under State unemployment
- insurance laws.
- 30 (5) All interest received from the Federal or any state

- 1 government or any instrumentality or political subdivision
- 2 thereof.
- 3 (6) Realized capital gains and rentals.
- 4 (7) Workers' compensation.
- 5 (8) The gross amount of loss of time insurance benefits,
- life insurance benefits and proceeds, except the first \$5,000
- 7 of the total of death benefit payments.
- 8 (9) Gifts of cash or property, other than transfers by
- 9 gift between members of a household, in excess of a total
- 10 value of \$300.
- 11 The term does not include surplus food or other relief in kind
- 12 supplied by a governmental agency, property tax or rent rebate,

- "Permanently disabled person." A person who is unable to

 successful applicant for a Category 2 slot machine license.
 - (3) For fiscal years 2007-2008 and 2008-2009, an amount equal to the sum of approved claims to be paid in each of those fiscal years under sections 704 of the Taxpayer Relief Act and 1404(a)(2)(ii), if any.
 - (4) For fiscal year 2009-2010 and each fiscal year thereafter, all of the following:
 - (i) The difference between the sum of the amount of approved claims to be paid in the next fiscal year under section 1404(a)(2)(i) and (3) and the amount of approved claims paid in fiscal year 2006-2007 under section 1404(a)(1).
 - (ii) The sum of the amount of approved claims to be paid in the next fiscal year under sections 704 of the Taxpayer Relief Act and 1404(a)(2)(ii), if any.
 - (5) Beginning in fiscal year 2009-2010 and until the difference between the sum of subparagraphs (i) and (ii) and \$200,000,000 is paid, an amount of not less than \$40,000,000 annually or the amount of the difference, whichever is less. All transfers under this paragraph shall be completed no later than four years after the transfer required by paragraph (2).
 - (i) The difference between the sum of the amount of approved claims to be paid in fiscal year 2007-2008 under section 1404(a)(2)(i) and (3) and the amount of approved claims paid in fiscal year 2006-2007 under section 1404(a)(1).
- 30 (ii) The difference between the sum of the amount of

- approved claims to be paid in fiscal year 2008-2009 under
- 2 section 1404(a)(2)(i) and (3) and the amount of approved
- 3 claims paid in fiscal year 2006-2007 under section

- 5 Section 1409. Claim forms and rules and regulations.
- 6 (a) General rule. -- Necessary rules and regulations shall be
- 7 prescribed by a committee consisting of the Secretary of Aging,
- 8 the Secretary of Revenue and the Secretary of Community and
- 9 Economic Development. The Secretary of Aging shall serve as the
- 10 chairman of the committee. The department shall receive all
- 11 applications, determine the eligibility of claimants, hear
- 12 appeals, disburse payments and make available suitable forms for
- 13 the filing of claims.
- 14 (b) Report to General Assembly. -- In addition to any rules
- 15 and regulations prescribed under subsection (a), the department
- 16 shall collect the following information and issue a report
- 17 including such information to the chairperson and minority

- 2 (a) Civil penalty. -- In any case in which a claim is
- 3 excessive and was filed with fraudulent intent, the claim shall
- 4 be disallowed in full, and a penalty of 25% of the amount
- 5 claimed shall be imposed. The penalty and the amount of the
- 6 disallowed claim, if the claim has been paid, shall bear
- 7 interest at the rate of 1.5% per month from the date of the
- 8 claim until repaid.
- 9 (b) Criminal penalty. -- The claimant and any person who
- 10 assisted in the preparation or filing of a fraudulent claim

- 23 section under former Article II of the Tax Reform Code of 1971.
- 24 The taxes collected on or after January 1, 2018, regardless of
- 25 the transaction date, shall be deposited as provided in section
- 26 782.
- 27 (b) Other taxes. -- Notwithstanding the repeal specified under
- 28 section 1505(b)(2), a governing body shall have the authority to
- 29 enforce, after the effective date of the repeal, the collection
- 30 of taxes levied and assessed under the former provision prior to

- 1 the effective date of section 1505(b)(2).
- 2 Section 1502. Regulations.
- 3 The department shall have jurisdiction over and shall
- 4 promulgate regulations as necessary for the proper
- 5 administration of this act.
- 6 Section 1503. Construction.
- 7 Any and all references in any other act to Article II or any
- 8 provision in Article II of the Tax Reform Code of 1971 shall be
- 9 deemed a reference to Chapter 7 of this act or the corresponding
- 10 provisions in Chapter 7 of this act.
- 11 Section 1504. Severability.
- 12 The provisions of this act are severable as follows:
- 13 (1) If any provision of this act is held invalid, the
- invalidity shall not affect other provisions or applications
- of this act which can be given effect without the invalid
- 16 provision or application.
- 17 (2) Under no circumstances shall the invalidity of any
- provision or application of this act affect the validity of
- 19 any provision in this act that abolishes the power of the
- 20 governing body and any school district and city of the first
- 21 class or any other political subdivision to levy, assess or
- 22 collect a tax on any interest in real property for school
- purposes.
- 24 Section 1505. Repeals.
- 25 (a) Intent.--The General Assembly declares that the repeals
- 26 under subsection (b) are necessary to effectuate this act.
- 27 (b) Provisions. -- The following acts and parts of acts are
- 28 repealed to the extent specified:
- 29 (1) Section 631 of the act of March 10, 1949 (P.L.30,
- No.14), known as the Public School Code of 1949, is repealed.

- 1 (2) Any provision of the Public School Code of 1949 and
- 2 of any other law relating to the authority of any school
- district to levy, assess and collect any tax on real property
- 4 and the power of any city of the first class to levy, assess
- 5 and collect any tax real property for school purposes is
- 6 repealed upon the expiration of the respective schedule
- 7 prescribed in this act.
- 8 (3) Any provision of the act of the Public School Code
- 9 of 1949 and any other law relating to debt is repealed to the
- 10 extent that it is inconsistent with this act.
- 11 (4) Any provision of the Public School Code of 1949 and
- 12 any home rule charter adopted pursuant thereto is repealed
- insofar as it is inconsistent with this act.
- 14 (5) Any provision of the act of August 9, 1963 (P.L.643,
- No.341), known as the First Class City Public Education Home
- Rule Act, and any home rule school district charter adopted
- 17 pursuant thereto is repealed insofar as it is inconsistent
- 18 with this act.
- 19 (6) Article II of the act of March 4, 1971 (P.L.6,
- No.2), known as the Tax Reform Code of 1971, is repealed.
- 21 (7) Subchapters C and D of Chapter 3 and Chapter 13 of
- 22 the act of June 27, 2006 (1st Sp.Sess., P.L.1873, No.1),
- 23 known as the Taxpayer Relief Act, are repealed.
- 24 (8) All acts and parts of acts that are inconsistent
- with this act are repealed to the extent of such

- 27 Section 1506. Applicability.
- Chapter 7 and section 1505(b)(6) shall apply January 1, 2018.
- 29 Section 1507. Effective date.
- 30 This act shall take effect as follows:

- 2 June 30, 2018.
