## AN ACT

17	(d) DefinitionsAs used in this section, the following
18	words and phrases shall have the meanings given to them in this

2 "Electric or electronic incapacitation device." A portable 3 device which is designed or intended by the manufacturer to be used, offensively or defensively, to temporarily immobilize or 4 incapacitate persons by means of electric pulse or current, 5 including devices operated by means of carbon dioxide 6 7 propellant. The term does not include cattle prods, electric 8 fences or other electric devices when used in agricultural, animal husbandry or food production activities. 9 10 "Emergency medical services personnel." The term includes, but is not limited to, doctors, residents, interns, registered 11 12 nurses, licensed practical nurses, nurse aides, ambulance 13 attendants and operators, paramedics, emergency medical 14 technicians and members of a hospital security force while 15 working within the scope of their employment.
