A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, in the legislature, further providing for
- the designation of legislative and congressional districts
- 4 within this Commonwealth.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby resolves as follows:
- 7 Section 1. The following amendment to the Constitution of
- 8 Pennsylvania is proposed in accordance with Article XI:
- 9 That section 17 of Article II be amended to read:
- 10 § 17. Legislative [Reapportionment] Redistricting Commission.
- 11 (a) In each year following the year of the Federal decennial
- 12 census, a Legislative [Reapportionment] Redistricting Commission
- 13 shall be constituted for the purpose of [reapportioning the
- 14 Commonwealth. The commission shall act by a majority of its
- 15 entire membership.] <u>redistricting the districts of the Senate</u>
- 16 and House of Representatives of the General Assembly and the
- 17 <u>districts apportioned to the Commonwealth in the House of</u>
- 18 Representatives of the United States Congress.

- 1 [(b) The commission shall consist of five members: four of
- 2 whom shall be the majority and minority leaders of both the
- 3 Senate and the House of Representatives, or deputies appointed
- 4 by each of them, and a chairman selected as hereinafter
- 5 provided. No later than 60 days following the official reporting
- 6 of the Federal decennial census as required by Federal law, the
- 7 four members shall be certified by the President pro tempore of
- 8 the Senate and the Speaker of the House of Representatives to
- 9 the elections officer of the Commonwealth who under law shall
- 10 have supervision over elections.
- 11 The four members within 45 days after their certification
- 12 shall select the fifth member, who shall serve as chairman of
- 13 the commission, and shall immediately certify his name to such
- 14 elections officer. The chairman shall be a citizen of the
- 15 Commonwealth other than a local, State or Federal official
- 16 holding an office to which compensation is attached.
- 17 If the four members fail to select the fifth member within
- 18 the time prescribed, a majority of the entire membership of the
- 19 Supreme Court within 30 days thereafter shall appoint the
- 20 chairman as aforesaid and certify his appointment to such
- 21 elections officer.]
- 22 (b.1) The following shall apply to the commission:
- 23 (1) The commission shall consist of the following members:
- 24 (i) Eight legislative appointees. The majority and minority
- 25 <u>leaders of the Senate and the House of Representatives shall</u>
- 26 each appoint two commissioners under this subparagraph.
- 27 (ii) One commissioner chosen by at least six of the eight_
- 28 commissioners appointed under subparagraph (i). The commissioner
- 29 chosen under this subparagraph shall serve as chairperson.
- 30 (2) Each commissioner shall be a citizen of this

- 1 Commonwealth and may not hold a local, State or Federal office
- 2 to which compensation is attached.
- 3 (3) A commissioner may not be a staff person of a local,
- 4 State or Federal official holding an office to which
- 5 <u>compensation is attached.</u>
- 6 (4) No later than 60 days following the official reporting
- 7 of the Federal decennial census as required by Federal law, the
- 8 eight commissioners under paragraph (1)(i) shall be certified by
- 9 the President pro tempore of the Senate and the Speaker of the
- 10 House of Representatives to the Secretary of the Commonwealth.
- 11 (5) The eight commissioners under paragraph (1) (i) must,
- 12 within 45 days after their certification, select the ninth
- 13 <u>commissioner</u>, who shall serve as chairperson of the commission,
- 14 and shall immediately certify that individual's name to the
- 15 <u>Secretary of the Commonwealth.</u>
- 16 (6) If at least six of the eight commissioners appointed
- 17 under paragraph (1)(i) fail to select the ninth commissioner
- 18 within the time required under paragraph (5), a majority of the
- 19 justices of the Supreme Court must, within 30 days after the
- 20 time required under paragraph (5), appoint the chairperson and
- 21 certify that individual's appointment to the Secretary of the
- 22 Commonwealth.
- 23 Any vacancy in the commission shall be filled within 15 days
- 24 in the same manner in which such position was originally filled.
- 25 (b.2) Each meeting of the commission must be held in public
- 26 and must comply with any law which applies to open meetings.
- 27 (c) No later than 90 days after [either the commission has
- 28 been duly certified or the population data for the Commonwealth
- 29 as determined by the Federal decennial census are available,
- 30 whichever is later in time, the commission shall file a

- 1 preliminary reapportionment plan with such elections officer.]
- 2 the commission has certified that the population data for this
- 3 <u>Commonwealth</u>, as <u>determined</u> by the Federal <u>decennial</u> census, is
- 4 available, the commission shall file a preliminary redistricting
- 5 plan with the Secretary of the Commonwealth that has been
- 6 approved by at least seven of the nine commissioners and that
- 7 <u>includes both the legislative and congressional districts.</u>
- 8 The commission shall have 30 days after filing the
- 9 preliminary plan to make corrections in the plan. <u>During the 30-</u>
- 10 day period, the commission must hold at least two public
- 11 meetings for citizen input. These meetings shall be
- 12 <u>geographically dispersed throughout this Commonwealth.</u>
- Any person aggrieved by the preliminary plan shall have the
- 14 same 30-day period to file exceptions with the commission in
- 15 which case the commission shall have 30 days after the date the
- 16 exceptions were filed to prepare and file with [such elections
- 17 officer] the Secretary of the Commonwealth a revised
- 18 [reapportionment] redistricting plan to be approved by at least
- 19 seven of the nine commissioners. If no exceptions are filed
- 20 within 30 days, or if filed and acted upon, the [commissions's]
- 21 commission's plan shall be final and have the force of law.
- 22 (d) Any aggrieved person may file an appeal from the final
- 23 plan directly to the Supreme Court within 30 days after the
- 24 filing thereof. If the appellant establishes that the final plan
- 25 is contrary to law, the Supreme Court shall issue an order
- 26 remanding the plan to the commission and directing the
- 27 commission to [reapportion] redistrict the Commonwealth in a
- 28 manner not inconsistent with such order. A plan adopted after
- 29 <u>remand must be approved by at least seven of the nine</u>
- 30 commissioners.

- 1 (e) When the Supreme Court has finally decided an appeal or
- 2 when the last day for filing an appeal has passed with no appeal
- 3 taken, the [reapportionment] redistricting plan shall have the
- 4 force of law and the districts therein provided shall be used
- 5 thereafter in elections to the General Assembly and Congress
- 6 until the next [reapportionment] redistricting as required under
- 7 this section 17.
- 8 (f) Any district which does not include the residence from
- 9 which a member of the Senate was elected whether or not
- 10 scheduled for election at the next general election shall elect
- 11 a Senator at such election.
- 12 (g) The General Assembly shall appropriate sufficient funds
- 13 for the compensation and expenses of members and staff appointed
- 14 by the commission, and other necessary expenses. The members of
- 15 the commission shall be entitled to such compensation for their
- 16 services as the General Assembly from time to time shall
- 17 determine, but no part thereof shall be paid until a preliminary
- 18 plan is filed. If a preliminary plan is filed but the commission
- 19 fails to file a revised or final plan within the time
- 20 prescribed, the commission members shall forfeit all right to
- 21 compensation not paid.
- 22 (h) If a preliminary, revised or final [reapportionment]
- 23 redistricting plan is not filed by the commission within the
- 24 time prescribed by this section, unless the time be extended by
- 25 the Supreme Court for cause shown, the Supreme Court shall
- 26 immediately proceed on its own motion to [reapportion]
- 27 <u>redistrict</u> the Commonwealth.
- 28 (i) Any [reapportionment] redistricting plan filed by the
- 29 commission, or ordered or prepared by the Supreme Court upon the
- 30 failure of the commission to act, shall be published by the

- 1 [elections officer] <u>Secretary of the Commonwealth</u> once in at
- 2 least one newspaper of general circulation in each senatorial
- 3 [and], representative and congressional district. The
- 4 publication shall contain a map of the Commonwealth showing the
- 5 complete [reapportionment] redistricting of the General Assembly
- 6 <u>and Congress</u> by districts, and a map showing the
- 7 [reapportionment] redistricted districts in the area normally
- 8 served by the newspaper in which the publication is made. The
- 9 publication shall also state the population of the senatorial
- 10 [and], representative and congressional districts having the
- 11 smallest and largest population and the percentage variation of
- 12 such districts from the average population for senatorial [and],__
- 13 representative <u>and congressional</u> districts.
- 14 (j) Redistricting of Congress and the General Assembly must
- 15 be completed by the end of the calendar year following the
- 16 Federal decennial census.
- 17 Section 2. (a) Upon the first passage by the General
- 18 Assembly of this proposed constitutional amendment, the
- 19 Secretary of the Commonwealth shall proceed immediately to
- 20 comply with the advertising requirements of section 1 of Article
- 21 XI of the Constitution of Pennsylvania and shall transmit the
- 22 required advertisements to two newspapers in every county in
- 23 which such newspapers are published in sufficient time after
- 24 passage of this proposed constitutional amendment.
- 25 (b) Upon the second passage by the General Assembly of this
- 26 proposed constitutional amendment, the Secretary of the
- 27 Commonwealth shall proceed immediately to comply with the
- 28 advertising requirements of section 1 of Article XI of the
- 29 Constitution of Pennsylvania and shall transmit the required
- 30 advertisements to two newspapers in every county in which such

- 1 newspapers are published in sufficient time after passage of
- 2 this proposed constitutional amendment. The Secretary of the
- 3 Commonwealth shall submit this proposed constitutional amendment
- 4 to the qualified electors of this Commonwealth at the first
- 5 primary, general or municipal election which meets the
- 6 requirements of and is in conformance with section 1 of Article
- 7 XI of the Constitution of Pennsylvania and which occurs at least
- 8 three months after the proposed constitutional amendment is
- 9 passed by the General Assembly.
