12	(a) Badge or identification Subject to subsection (b), a
13	law enforcement officer may wear a separate badge or other
14	identification on the officer's official uniform that provides
15	information regarding the officer's blood type.
16	(b) Requirements The badge or other identification under
17	this section shall be uniform in size and lettering and be
18	approved by the entity with direct supervision over the law
19	enforcement officer.
20	(c) Permissible nature Nothing in this section shall
21	require a law enforcement officer to wear the badge or other
22	identification under this section.
23	(d) Cost The cost of the badge or other identification
24	under this section shall be paid by the following:
25	(1) The Pennsylvania State Police if the law enforcement
26	officer is a member of the Pennsylvania State Police.
27	(2) The county in which the sheriff or deputy sheriff is
28	elected or appointed.
29	(3) The municipality in which the constable or deputy
30	constable is elected or appointed.

- 3 (e) Rules and regulations. -- The Pennsylvania State Police
- 4 shall promulgate rules and regulations to carry out the

- 6 (f) Definitions.--As used in this section, the following
- 7 words and phrases shall have the meanings given to them in this
- 8 <u>subsection unless the context clearly indicates otherwise:</u>
- 9 "Law enforcement officer." Any of the following:
- 10 (1) A member of the Pennsylvania State Police.
- 11 (2) A sheriff or deputy sheriff.
- 12 <u>(3) A constable or deputy constable.</u>
- 13 <u>(4) A police officer for a municipality.</u>
- 14 "Municipality." A county, city, borough, incorporated town
- 15 or township.
- 16 Section 5. This act shall take effect in 60 days.
