AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in grounds and buildings, providing for lead testing; and, in charter schools, further providing 5 6 for provisions applicable to charter schools. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- as the Public School Code of 1949, is amended by adding a 11
- 12 section to read:
- 13 Section 742. Lead Testing. -- (a) Prior to the start of each
- school year, every school building in a district, including all 14
- 15 drinking water, shall be tested for lead levels. Any school
- 16 building that finds a lead level that is in excess of the levels
- 17 under subsection (c) shall immediately implement a plan to
- ensure no child or adult is exposed to lead contamination and 18
- 19 that alternative sources of drinking water are made available.
- 20 (b) A school building that tests at a lead level higher than

- 1 the levels under subsection (c) shall be retested monthly until
- 2 the lead level tests below the levels under subsection (c).
- 3 (c) The following shall apply:
- 4 <u>(1) The lead level in drinking water in a school building</u>
- 5 may not exceed the United States Environmental Protection
- 6 Agency's National Primary Drinking Water Regulations maximum
- 7 <u>contaminant level goal or milligrams per liter.</u>
- 8 (2) The lead levels in paint, dust and soil may not exceed
- 9 <u>levels permitted by United States Environmental Protection</u>
- 10 Agency rules.
- 11 (d) If the testing under subsection (a) results in a lead
- 12 <u>level in excess of the levels under subsection (c), the school</u>
- 13 <u>district shall, within 30 days, submit a remediation plan to the</u>
- 14 <u>Department of Education and the Department of Environmental</u>
- 15 Protection. The plan shall include, but shall not be limited to,
- 16 <u>a timeline to remediate, abate or replace any lead-lined</u>
- 17 <u>drinking fountains</u>, <u>lead pipes and copper pipes with lead</u>
- 18 solder, removing, abating or repainting lead-based paint and
- 19 soil removal. In addition, the plan shall include a timeline in
- 20 which the remediation or abatement shall be completed.
- 21 <u>(e) The Department of Environmental Protection shall work</u>
- 22 with the school district to approve and oversee the
- 23 <u>implementation of the remediation plan. If a school district</u>
- 24 fails to implement a remediation plan, the Department of
- 25 Environmental Protection, in consultation with the Department of
- 26 Education, shall work with the school to implement the
- 27 <u>remediation plan.</u>
- 28 (f) The lead levels of a test under subsection (a) or (b) in
- 29 excess of the levels under subsection (c) shall be reported in
- 30 writing to the Department of Education and shall be sent by mail

- 1 or electronically to the parent or legal quardian of every
- 2 <u>student enrolled in the school building. In addition, the</u>
- 3 Department of Education and the school district shall post the
- 4 <u>lead level result for each school building on their publicly</u>
- 5 accessible Internet website.
- 6 (g) The following shall apply:
- 7 (1) A school building built after 1978 shall not be required
- 8 to test for lead paint.
- 9 (2) A school building built prior to 1978 shall not be
- 10 required to test for lead paint if the school building has
- 11 completed a full removal of all lead paint and has a
- 12 <u>certification of the removal from the Department of</u>
- 13 Environmental Protection or an individual licensed by the
- 14 <u>Department of Environmental Protection.</u>
- (h) For purposes of this section, the term "school building"
- 16 does not include any administrative or maintenance buildings.

- 28 Act of July 17, 1961 (P.L.776, No.341), known as the
- 29 "Pennsylvania Fair Educational Opportunities Act."

- 1 providing for the use of eye protective devices by persons
- 2 engaged in hazardous activities or exposed to known dangers in
- 3 schools, colleges and universities."
- 4 Section 4 of the act of January 25, 1966 (1965 P.L.1546,
- 5 No.541), entitled "An act providing scholarships and providing
- 6 funds to secure Federal funds for qualified students of the
- 7 Commonwealth of Pennsylvania who need financial assistance to
- 8 attend postsecondary institutions of higher learning, making an
- 9 appropriation, and providing for the administration of this

- 17 (b) Charter schools shall be subject to the following
- 18 provisions of 22 Pa. Code:
- 19 Section 5.216 (relating to ESOL).
- 20 Section 5.4 (relating to general policies).
- 21 Chapter 11 (relating to pupil attendance).
- 22 Chapter 12 (relating to students).
- 23 Section 32.3 (relating to assurances).
- 24 Section 121.3 (relating to discrimination prohibited).
- 25 Section 235.4 (relating to practices).
- 26 Section 235.8 (relating to civil rights).
- 27 Chapter 711 (relating to charter school services and programs
- 28 for children with disabilities).
- 29 (c) (1) The secretary may promulgate additional regulations
- 30 relating to charter schools.

- 1 (2) The secretary shall have the authority and the
- 2 responsibility to ensure that charter schools comply with
- 3 Federal laws and regulations governing children with
- 4 disabilities. The secretary shall promulgate regulations to
- 5 implement this provision.
- 6 Section 3. This act shall take effect immediately.
