AN ACT

- 1 Authorizing and directing the Department of General Services,
- with the approval of the Governor, to grant and convey 812
- Market, Inc., or its assigns, certain lands and improvements
- situate in the City of Harrisburg, Dauphin County.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Conveyance in the City of Harrisburg, Dauphin
- 8 County.
- 9 (a) Authorization. -- The Department of General Services, with
- 10 the approval of the Governor, is hereby authorized and directed
- 11 on behalf of the Commonwealth of Pennsylvania to grant and
- 12 convey to 812 Market, Inc., or its assigns, certain land
- 13 together with any improvements thereon, situate in the City of
- 14 Harrisburg, Dauphin County, for \$1.00.
- 15 (b) Property description. -- The property to be conveyed
- 16 pursuant to subsection (a) consists of approximately 0.49 acres
- 17 of land and improvements thereon, bounded and more particularly
- 18 described as follows:
- 19 ALL THAT CERTAIN lot, parcel, tract or piece of land situate

- 1 in the City of Harrisburg, County of Dauphin, as shown on a
- 2 corrected plan of the General State Authority, dated February
- 3 17, 1965, bounded and described as follows:
- 4 BEGINNING at the Northwest corner of 10th and Market Streets;
- 5 thence along the North Side of Market Street in a Southwesterly
- 6 direction for a distance of 65.05 feet, more or less, thence in
- 7 a Northwesterly direction for a distance of 102.75 feet, more or
- 8 less, thence in a Westerly direction for a distance of 57.41
- 9 feet, more or less to the East Side of Ninth Street, thence
- 10 Northwardly along the East Side of Ninth Street for a distance
- 11 of 113.20 feet more or less, thence in an Easterly direction for
- 12 a distance of 141.70 feet more or less, thence in a Southwardly
- 13 direction for a distance of 196.67 feet more or less to the
- 14 place of BEGINNING.
- 15 CONTAINING 0.49-acres, more or less.
- 16 BEING a portion the same property that was conveyed by the
- 17 General State Authority in its deed to the Commonwealth of
- 18 Pennsylvania, acting by and through the Department of General
- 19 Services, dated June 16, 1989 and recorded in the Dauphin County
- 20 Recorder of Deeds Office in Deed Book 1520 at Page 556 (Parcel
- 21 #26).
- 22 (c) Requirement for conveyance. -- The conveyance shall be
- 23 made under and subject to all lawful and enforceable easements,
- 24 servitudes and rights of others, including, but not confined to,
- 25 streets, roadways and rights of any telephone, telegraph, water,
- 26 electric, gas or pipeline companies, as well as under and
- 27 subject to any lawful and enforceable estates or tenancies
- 28 vested in third persons appearing of record, for any portion of
- 29 the land or improvements erected thereon.
- 30 (d) Deed.--The deed of conveyance shall be by special

- 1 warranty deed and shall be executed by the Secretary of General
- 2 Services in the name of the Commonwealth of Pennsylvania.
- 3 (e) Costs and fees.--Costs and fees incidental to this
- 4 conveyance shall be borne by the grantee.
- 5 (f) Alternative disposition. -- In the event that the
- 6 conveyance authorized herein is not effectuated within two years
- 7 of the effective date of this act, the property may be disposed
- 8 of in accordance with section 2405-A of the act of April 9, 1929
- 9 (P.L.177, No.175), known as The Administrative Code of 1929.
- 10 Section 2. Effective date.
- 11 This act shall take effect immediately.
