AN ACT

- Amending the act of November 30, 2004 (P.L.1672, No.213), 1 entitled "An act providing for the sale of electric energy 2 generated from renewable and environmentally beneficial 3 sources, for the acquisition of electric energy generated from renewable and environmentally beneficial sources by 5 electric distribution and supply companies and for the powers and duties of the Pennsylvania Public Utility Commission," 7 further providing for definitions. 8 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 11 Section 1. The definitions of "municipal solid waste," "Tier 12 I alternative energy source" and "Tier II alternative energy 13 source" in section 2 of the act of November 30, 2004 (P.L.1672, No.213), known as the Alternative Energy Portfolio Standards 14 15 Act, are amended to read: Section 2. Definitions. 16 17 The following words and phrases when used in this act shall 18 have the meanings given to them in this section unless the

- 1 "Municipal solid waste." This will include energy from
- 2 existing waste to energy facilities, provided that the facility
- 3 is connected to the distribution system in this Commonwealth,
- 4 which the Department of Environmental Protection has determined
- 5 are in compliance with current environmental standards,
- 6 including, but not limited to, all applicable requirements of
- 7 the Clean Air Act (69 Stat. 322, 42 U.S.C. § 7401 et seq.) and
- 8 associated permit restrictions and all applicable requirements
- 9 of the act of July 7, 1980 (P.L.380, No.97), known as the Solid
- 10 Waste Management Act.

- "Tier I alternative energy source." Energy derived from:
- 13 (1) Solar photovoltaic and solar thermal energy.
- 14 (2) Wind power.
- 15 (3) Low-impact hydropower.
- 16 (4) Geothermal energy.
- 17 (5) Biologically derived methane gas.
- 18 (6) Fuel cells.
- 19 (7) Biomass energy.
- 20 (8) Coal mine methane.
- 21 (9) Municipal solid waste.
- "Tier II alternative energy source." Energy derived from:
- 23 (1) Waste coal.
- 24 (2) Distributed generation systems.
- 25 (3) Demand-side management.
- 26 (4) Large-scale hydropower.
- [(5) Municipal solid waste.]
- 28 (6) Generation of electricity utilizing by-products of
- the pulping process and wood manufacturing process, including
- 30 bark, wood chips, sawdust and lignin in spent pulping

- 1 liquors.
- 2 (7) Integrated combined coal gasification technology.

- 4 Section 2. This act shall take effect in 60 days.
