## A RESOLUTION

- Designating June 30, 2018, as "Arthrogryposis Awareness Day" in Pennsylvania.
- 3 WHEREAS, Arthrogryposis Multiplex Congenita (AMC) is a
- 4 prenatally developing condition, caused by various conditions
- 5 and syndromes, in which a baby is born with at least three
- 6 joints in two different areas of the body that are highly or
- 7 permanently immobilized; and
- 8 WHEREAS, AMC presents as either a limited or a fixed range of
- 9 motion in the arm and leg joints, inward rotation of the
- 10 shoulders, abnormal extension of the elbows, bending of wrists
- 11 and fingers and in dislocated hips and inwardly bent heels and
- 12 feet (clubfoot); and
- 13 WHEREAS, Both the number of and particular joints affected
- 14 differ from person to person; and
- 15 WHEREAS, AMC occurs in about 1 in 3,000 births, with about
- 16 400 distinctly identified types; and
- 17 WHEREAS, The most common form of AMC, Amyoplasia, occurs in

- 1 some 43% of cases and most often affects both upper and lower
- 2 extremities, including the hands, wrists, elbows, shoulders,
- 3 feet and knees; and
- 4 WHEREAS, AMC is not curable, but is treatable, with the goal
- 5 to allow the individuals as much independence in their daily
- 6 lives as possible; and
- WHEREAS, Physical, occupational, speech and other therapies,
- 8 stretching and surgical interventions can help improve
- 9 independence level and the quality of life; and
- 10 WHEREAS, Although severe cases of AMC can lead to shorter
- 11 lives, the majority of individuals with AMC have normal
- 12 lifespans; therefore be it
- RESOLVED, That the Senate designate June 30, 2018, as
- 14 "Arthrogryposis Awareness Day" in Pennsylvania; and be it
- 15 further
