AN ACT

Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying 2 and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, 4 collection, administration and enforcement thereof; providing 5 for tax credits in certain cases; conferring powers and 6 imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and 9 penalties," in personal income tax, further providing for 10 classes of income. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: Section 1. Section 303(a.3) of the act of March 4, 1971 14 15 (P.L.6, No.2), known as the Tax Reform Code of 1971, is amended 16 to read: 17 Section 303. Classes of Income. --* * * 18 (a.3) The cost of property commonly referred to as Section 19 179 Property may be treated as a deductible expense only to the extent allowable under [the version of section 179 of the 20 21 Internal Revenue Code in effect at the time the property is

- 2 Code of 1986 (26 U.S.C. § 179), [whichever is earlier] <u>as</u>
