AN ACT

- Amending the act of July 2, 1993 (P.L.345, No.48), entitled "An act empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities; providing 3 for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the Commissioner of Professional and Occupational Affairs; and further providing for civil penalties and license 7 suspension," providing for licensure by endorsement. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. The act of July 2, 1993 (P.L.345, No.48), 12 entitled "An act empowering the General Counsel or his designee to issue subpoenas for certain licensing board activities; 13 providing for hearing examiners in the Bureau of Professional and Occupational Affairs; providing additional powers to the 16 Commissioner of Professional and Occupational Affairs; and further providing for civil penalties and license suspension," 17
- 18 is amended by adding a section to read:

- 1 Section 6.1. Licensure by endorsement.
- 2 (a) General rule. -- Notwithstanding any existing provisions
- 3 related to licensure by endorsement or licensure by reciprocity
- 4 <u>in any applicable licensing statute</u>, a licensing board or
- 5 commission shall issue a license, certificate, registration or
- 6 permit to an applicant to allow practice in this Commonwealth
- 7 <u>if, upon application to the licensing board OR COMMISSION, the</u> <--
- 8 applicant satisfies all of the following conditions:
- 9 <u>(1) Holds a current license, certificate, registration</u>
- or permit from another state, territory or country and the
- licensing board or commission determines that state's,
- 12 <u>territory's or country's requirements are substantially</u>
- 13 <u>equivalent to or exceed the requirements established in this</u>
- 14 <u>Commonwealth.</u>
- 15 (2) Demonstrates competency in the profession or
- 16 <u>occupation through methods determined by the licensing board</u>
- 17 or commission, including having completed continuing
- 18 education or having experience in the professional or
- 19 occupation for at least two of the five years preceding the
- 20 date of the application under this section.
- 21 (3) Has not committed any act that constitutes grounds
- for refusal, suspension or revocation of a license,
- 23 registration, certificate, REGISTRATION or permit to practice <--
- that profession or occupation in this Commonwealth unless the
- 25 licensing board or commission determines, in its discretion,
- that the act should not be an impediment to the granting of a
- 27 license, registration, certificate, REGISTRATION or permit to <--
- 28 practice in this Commonwealth.
- 29 (4) Is in good standing and has not been disciplined by
- 30 the jurisdiction that issued the license, registration,

- certificate, REGISTRATION or permit unless the licensing <-
 board or commission determines, in its discretion, that the

 discipline should not be an impediment to the granting of a

 license, registration, certificate, REGISTRATION or permit to <-
 practice in this Commonwealth.

 (5) Pays any fees established by the licensing board or
 - 6 (5) Pays any fees established by the licensing board or commission by regulation.
 - 8 <u>(b) Provisional endorsement license.--A licensing board or</u>
- 9 <u>commission may issue a provisional license, registration,</u> <--
- 10 certificate, REGISTRATION or permit to an applicant for <--
- 11 <u>licensure</u> by endorsement while the applicant is satisfying
- 12 remaining requirements for the licensure by endorsement as
- 13 <u>determined by the board OR COMMISSION. The holder of a</u> <--
- 14 provisional endorsement license issued under this subsection may
- 15 practice until any of the following occurs:
- 16 <u>(1) A license, registration, certificate, REGISTRATION</u> <--

- or permit is denied by the licensing board or commission
- 18 under this section.
- 19 <u>(2) The expiration of the provisional endorsement</u>
- 20 <u>license as established by the board OR COMMISSION by</u>
- 21 regulation.
- 22 (3) The holder of the provisional endorsement license
- fails to comply with the terms of the provisional license.
- (c) Construction. -- Nothing in this section is intended to
- 25 <u>supersede or replace existing statutory provisions relating to</u>
- 26 <u>licensure by endorsement or licensure by reciprocity applicable</u>
- 27 to licensing boards and commissions through their respective
- 28 enabling statutes.
- 29 Section 2. Final regulations shall be promulgated by each
- 30 licensing board and commission within 18 months of the effective

1 date of this act SECTION.
