AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An act relating to alcoholic liquors, alcohol and malt and brewed beverages; amending, revising, consolidating and 3 changing the laws relating thereto; regulating and restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 8 persons engaged or employed therein; defining the powers and 9 duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 12 for the payment of certain license fees to the respective municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," in 16 17 preliminary provisions, further providing for definitions; and, in licenses and regulations relating to liquor, alcohol 18 and malt and brewed beverages, further providing for special 19 occasion permits AND FOR WINE AND SPIRITS AUCTION PERMITS. 20

21 The General Assembly of the Commonwealth of Pennsylvania

22 hereby enacts as follows:

- 23 Section 1. The definition of "eligible entity" in section
- 24 102 of the act of April 12, 1951 (P.L.90, No.21), known as the
- 25 Liquor Code, is amended to read:

- 1 Section 102. Definitions. -- The following words or phrases,
- 2 unless the context clearly indicates otherwise, shall have the
- 3 meanings ascribed to them in this section:
- 4 * * *
- 5 "Eligible entity" shall mean a city of the third class, a
- 6 hospital, a church, a synagogue, a volunteer fire company, a
- 7 volunteer ambulance company, a volunteer rescue squad, a unit of
- 8 a nationally chartered club which has been issued a club liquor
- 9 license, a club which has been issued a club liquor license and
- 10 which, as of December 31, 2002, has been in existence for at
- 11 least 100 years, a library, a nationally accredited Pennsylvania
- 12 nonprofit zoological institution licensed by the United States
- 13 Department of Agriculture, a nonprofit agricultural association
- 14 in existence for at least ten years, a bona fide sportsmen's
- 15 club in existence for at least ten years, a nationally chartered
- 16 veterans' organization and any affiliated lodge or subdivision
- 17 of such organization, a fraternal benefit society that is
- 18 licensed to do business in this Commonwealth and any affiliated
- 19 lodge or subdivision of such fraternal benefit society, any
- 20 <u>nationally recognized community-based voluntary health</u>
- 21 organization committed to fighting cancer, which has been in
- 22 <u>existence for at least 100 years</u>, a museum operated by a
- 23 nonprofit corporation, a nonprofit corporation engaged in the
- 24 performing arts, an arts council, a nonprofit corporation that
- 25 operates an arts facility or museum, a nonprofit organization as
- 26 defined under section 501(c)(3) of the Internal Revenue Code of
- 27 1986 (Public Law 99-514, 26 U.S.C. § 501(c)(3)) whose purpose is
- 28 to protect the architectural heritage of a municipality and
- 29 which has been recognized as such by a resolution of the
- 30 municipality, a nonprofit organization as defined under section

- 1 501(c)(3) of the Internal Revenue Code of 1986 (Public Law 99-
- 2 514, 26 U.S.C. § 501(c)(3)) conducting a regatta in a city of
- 3 the second class with the permit to be used on State park
- 4 grounds or conducting a family-oriented celebration as part of
- 5 Welcome America in a city of the first class on property leased
- 6 from that city for more than fifty years, a nonprofit
- 7 organization as defined under section 501(c)(3) of the Internal
- 8 Revenue Code of 1986 (26 U.S.C. § 501(c)(3)) whose purpose is to
- 9 raise funds for the research and treatment of cystic fibrosis, a
- 10 nonprofit organization as defined under section 501(c)(3) of the
- 11 Internal Revenue Code of 1986 (26 U.S.C. § 501(c)(3)) whose
- 12 purpose is to educate the public on issues dealing with
- 13 watershed conservation, a nonprofit organization as defined
- 14 under section 501(c)(3) of the Internal Revenue Code of 1986
- 15 (Public Law 99-514, 26 U.S.C. § 501(c)(3)) whose purpose is to
- 16 provide equine assisted activities for children and adults with
- 17 special needs, a nonprofit economic development agency in a city
- 18 of the second class with the primary function to serve as an
- 19 economic generator for the greater southwestern Pennsylvania
- 20 region by attracting and supporting film, television and related
- 21 media industry projects and coordinating government and business
- 22 offices in support of a production, a county tourist promotion
- 23 agency as defined in section 2 of the act of July 4, 2008
- 24 (P.L.621, No.50), known as the "Tourism Promotion Act," a junior
- 25 league that is a nonprofit organization as defined under section
- 26 501(c)(3) of the Internal Revenue Code of 1986 (26 U.S.C. §
- 27 501(c)(3)) that is comprised of women whose purpose is
- 28 exclusively educational and charitable in promoting the
- 29 volunteerism of women and developing and participating in
- 30 community projects and that has been in existence for over

- 1 seventy years, a nonprofit organization as defined under section
- 2 501(c)(3) of the Internal Revenue Code of 1986 and whose purpose
- 3 is the education and promotion of American history, a nonprofit
- 4 organization as defined under section 501(c)(6) of the Internal
- 5 Revenue Code of 1986 whose purpose is to support business and
- 6 industry, a brewery which has been issued a license to
- 7 manufacture malt or brewed beverages and has been in existence
- 8 for at least 100 years or a club recognized by Rotary
- 9 International and whose purpose is to provide service to others,
- 10 to promote high ethical standards and to advance world
- 11 understanding, goodwill and peace through its fellowship of
- 12 business, professional and community leaders or a nonprofit
- 13 organization as defined under section 501(c)(3) of the Internal
- 14 Revenue Code of 1986 (Public Law 99-514, 26 U.S.C. § 501(c)(3))
- 15 whose purpose is to promote mushrooms while supporting local and
- 16 regional charities, a museum operated by a not-for-profit
- 17 corporation in a city of the second class A, a nonprofit
- 18 organization as defined under section 501(c)(3) of the Internal
- 19 Revenue Code of 1986 which is located in a city of the second
- 20 class A and has as its purpose economic and community
- 21 development, a nonprofit organization as defined under section
- 22 501(c)(3) or (6) of the Internal Revenue Code of 1986 that is
- 23 located in a city of the third class in a county of the fifth
- 24 class, a nonprofit social service organization defined under
- 25 section 501(c)(3) of the Internal Revenue Code of 1986 located
- 26 in a county of the third class whose purpose is to serve
- 27 individuals and families in that county of the third class, a
- 28 nonprofit organization as defined under section 501(c)(3) of the
- 29 Internal Revenue Code of 1986 whose main purpose is to
- 30 temporarily foster stray and unwanted animals and match them to

- 1 suitable permanent homes or a nonprofit organization as defined
- 2 under section 501(c)(3) of the Internal Revenue Code of 1986 who
- 3 operates either a Main Street Program or Elm Street Program
- 4 recognized by the Commonwealth, the National Trust for Historic
- 5 Preservation or both, a nonprofit radio station that is a member
- 6 of the National Public Radio network, a nonprofit public
- 7 television station that is a member of the Pennsylvania Public
- 8 Television Network or a nonprofit organization as defined under
- 9 section 501(c)(3) of the Internal Revenue Code of 1986 whose
- 10 purpose is to promote awareness, education and research and to
- 11 provide a support system for patients with neutropenia and their
- 12 families through a national resource network, a nonprofit
- 13 organization as defined under section 501(c)(3) of the Internal
- 14 Revenue Code of 1986 whose main purpose is to stimulate
- 15 community development by facilitating residential and retail
- 16 growth in a city of the second class located in a county of the
- 17 second class or a nonprofit community development corporation
- 18 organized under section 501(c)(3) of the Internal Revenue Code
- 19 of 1986 that serves an adjoining borough and township in a
- 20 county of the second class and whose main purpose is to
- 21 facilitate commercial development and foster neighborhood
- 22 stabilization, a nonprofit organization as defined under section
- 23 501(c)(3) of the Internal Revenue Code of 1986 whose purpose is
- 24 to provide young people with a program to build character, to
- 25 teach the responsibilities of citizenship and to develop
- 26 personal fitness with a goal of creating future leaders, a
- 27 nonprofit as defined in section 501(c)(3) of the Internal
- 28 Revenue Code of 1986 whose main purpose is to assist children
- 29 and their families who are facing financial hardship due to the
- 30 death of a parent, a nonprofit as defined under section 501(c)

- 1 (3) of the Internal Revenue Code of 1986 whose purpose is to
- 2 allocate funds for research to expedite a cure achromatopsia, a
- 3 nonprofit organization as defined under section 501(c)(3) of the
- 4 Internal Revenue Code of 1986 that is located in a city of the
- 5 first class, was organized [in 1995] as a community development
- 6 [corporation] organization to promote health, safety and welfare
- 7 of the residents, businesses and institutions of a neighborhood
- 8 of a city of the first class, and whose works include public
- 9 promotions, neighborhood improvement projects and commercial
- 10 corridor improvements, including a business improvement
- 11 district, or a nonprofit organization as defined under section
- 12 501(c)(3) of the Internal Revenue Code of 1986 that is
- 13 responsible for providing services to members of the armed
- 14 forces of the United States and relief to disaster victims in
- 15 the United States and abroad, or any neighborhood improvement
- 16 district management association as defined in section 3 of the
- 17 act of December 20, 2000 (P.L.949, No.130), known as the
- 18 "Neighborhood Improvement District Act," that has been
- 19 established as a 501(c)(3) nonprofit organization under section
- 20 501(c)(3) of the Internal Revenue Code of 1986, a nonprofit
- 21 organization as defined under section 501(c)(3) of the Internal
- 22 Revenue Code of 1986 located in a city of the first class whose
- 23 purpose is to support initiatives to enrich the lives of
- 24 children, teens and families especially those in need, to reach
- 25 their full potential as productive and responsible citizens and
- 26 has been in existence for at least seventy-five years, or a
- 27 nonprofit organization as defined under section 501(c)(3) of the
- 28 Internal Revenue Code of 1986 located in a city of the second
- 29 class and incorporated as a nonprofit in 1982 that offers adult
- 30 education and family literacy, or a nonprofit organization as

- 1 defined under section 501(c)(3) of the Internal Revenue Code of
- 2 1986 located in a city of the third class and county of the
- 3 sixth class, whose purpose is primary and secondary education
- 4 and educational ministry of the Diocese of Erie, [or] a
- 5 nonprofit organization as defined under section 501(c)(3) of the

- 6 Internal Revenue Code located in a county of the fourth class
- 7 that had a population between 142,000 and 144,000 based on the
- 8 2010 Decennial Census of the Bureau of the Census and provides
- 9 rewards for information that leads to the arrest of individuals
- 10 that may have committed a crime[.] OR A NONPROFIT ORGANIZATION <--
- 11 AS DEFINED UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE
- 12 OF 1986 WHICH IS LOCATED IN A CITY OF THE THIRD CLASS IN A
- 13 COUNTY OF THE FIFTH CLASS WHOSE MISSION IS TO IMPROVE THE
- 14 QUALITY OF LIFE FOR INDIVIDUALS WITH DEVELOPMENTAL DISABILITIES_
- 15 AND THE FAMILIES OF THE INDIVIDUALS THROUGH ADVOCACY, EDUCATION,
- 16 SUPPORT AND SOCIALIZATION AND THAT HAS BEEN IN EXISTENCE FOR
- 17 OVER SIXTY YEARS.

- 19 Section 2. Section SECTIONS 408.4(i) and (m) AND 408.12(A) <-
- 20 of the act are amended to read:
- 21 Section 408.4. Special Occasion Permits.--
- 22 * * *
- 23 (i) Only one special occasion permit shall be issued to each
- 24 eliqible entity per calendar year. Each permit may only be used
- 25 for [six] <u>nine</u> consecutive or nonconsecutive days[; or] <u>and an</u>
- 26 <u>additional</u> ten consecutive days.
- 27 * * *
- 28 (m) The following apply:
- 29 <u>(1)</u> The purpose of a special occasion permit is to provide
- 30 the eligible entity with a means of raising funds for itself.

- 1 The permit may be used in conjunction with activities and events
- 2 involving other entities; however, no one other than the holder
- 3 of the special occasion permit may acquire a pecuniary interest
- 4 in the permit.
- 5 (2) An entity operating in conjunction with a special
- 6 occasion permit holder may collect and manage funds raised using
- 7 a special occasion permit if:
- 8 (i) the special occasion permit holder is the primary host
- 9 of the activity or event; and
- 10 (ii) the funds raised are used for the benefit of the
- 11 <u>special occasion permit holder.</u>

- 13 SECTION 408.12. WINE AND SPIRITS AUCTION PERMITS.--(A) UPON <--
- 14 APPLICATION OF:
- 15 (1) ANY NONPROFIT HOSPITAL;
- 16 (2) ANY NONPROFIT PUBLIC TELEVISION STATION WHICH IS A
- 17 MEMBER OF THE PENNSYLVANIA PUBLIC TELEVISION NETWORK;
- 18 (3) ANY ORCHESTRA LOCATED IN A COUNTY OF THE FIRST, SECOND
- 19 OR THIRD CLASS WHICH IS OPERATED BY A NONPROFIT CORPORATION;
- 20 (4) ANY MUSEUM LOCATED IN A COUNTY OF THE FIRST, SECOND,
- 21 THIRD OR FOURTH CLASS WHICH IS OPERATED BY A NONPROFIT
- 22 CORPORATION;
- 23 (5) ANY NONPROFIT CORPORATION LOCATED IN ANY COUNTY OF THE
- 24 THIRD CLASS WHICH TRAINS AND PLACES DOGS FOR PEOPLE WHO ARE
- 25 PHYSICALLY HANDICAPPED;
- 26 (6) ANY NATIONALLY RECOGNIZED COMMUNITY-BASED VOLUNTARY
- 27 HEALTH ORGANIZATION COMMITTED TO FIGHTING CANCER WHICH HAS BEEN
- 28 IN EXISTENCE FOR AT LEAST NINETY YEARS;
- 29 (7) ANY NATIONALLY RECOGNIZED EMERGENCY RESPONSE
- 30 ORGANIZATION THAT OFFERS HUMANITARIAN CARE TO VICTIMS OF WAR OR

- 1 NATURAL DISASTER AND HAS BEEN IN EXISTENCE FOR AT LEAST ONE
- 2 HUNDRED TWENTY-FIVE YEARS;
- 3 (8) ANY NATIONALLY RECOGNIZED ORGANIZATION WHOSE PURPOSE IS
- 4 TO SERVE AS AN AGENT TO COLLECT FUNDS FOR LOCAL CHARITIES, AS
- 5 WELL AS TO COORDINATE RELIEF SERVICES, COUNSEL AND REFER CLIENTS
- 6 TO COOPERATING AGENCIES AND MAKE EMERGENCY ASSISTANCE GRANTS AND
- 7 HAS BEEN IN EXISTENCE FOR AT LEAST ONE HUNDRED TWENTY YEARS;
- 8 (9) ANY HOSPICE AS DEFINED UNDER SECTION 802.1 OF THE ACT OF
- 9 JULY 19, 1979 (P.L.130, NO.48), KNOWN AS THE "HEALTH CARE
- 10 FACILITIES ACT";
- 11 (10) INSTITUTION OF HIGHER EDUCATION;
- 12 (11) ANY NATIONALLY RECOGNIZED COMMUNITY-BASED HEALTH
- 13 ORGANIZATION COMMITTED TO FUNDING TYPE 1 DIABETES RESEARCH; [OR]
- 14 (12) ANY NATIONALLY RECOGNIZED COMMUNITY-BASED VOLUNTARY
- 15 HEALTH ORGANIZATION COMMITTED TO FIGHTING CANCER WHICH HAS BEEN
- 16 IN EXISTENCE FOR AT LEAST TWENTY YEARS;
- 17 (13) ANY NONPROFIT ORGANIZATION AS DEFINED IN SECTION 501(C)
- 18 (3) OF THE INTERNAL REVENUE CODE OF 1986 (PUBLIC LAW 99-514, 26
- 19 U.S.C. § 501(C)(3)) AND THAT IS REGISTERED WITH THE PENNSYLVANIA
- 20 BUREAU OF CORPORATIONS AND CHARITABLE ORGANIZATIONS OF THE
- 21 DEPARTMENT OF STATE, RECOGNIZED AS A COMMUNITY-BASED VOLUNTARY
- 22 ORGANIZATION COMMITTED TO FIGHTING CANCER AND HAS BEEN IN
- 23 EXISTENCE FOR AT LEAST FIVE YEARS; OR
- 24 (14) ANY COMMUNITY-BASED VOLUNTARY HEALTH ORGANIZATION IN A
- 25 COUNTY OF THE SECOND CLASS WHICH ENRICHES THE LIVES OF CHILDREN
- 26 AND YOUNG ADULTS WITH DISABILITIES AND CHRONIC ILLNESSES;
- 27 AND UPON PAYMENT OF A FEE OF THIRTY DOLLARS (\$30) PER DAY, THE
- 28 BOARD SHALL ISSUE A WINE AND SPIRITS AUCTION PERMIT GOOD FOR A
- 29 PERIOD OF NOT MORE THAN FOUR CONSECUTIVE OR NONCONSECUTIVE DAYS
- 30 PER CALENDAR YEAR.

- 2 Section 3. This act shall take effect in 60 days.
