## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in school health services, providing for eye health examinations. 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: Section 1. The act of March 10, 1949 (P.L.30, No.14), known 9 10 as the Public School Code of 1949, is amended by adding a 11 section to read: 12 Section 1403.1. Eye Health Examinations. -- (a) Except as 13 provided under subsections (c) and (e), children of school age 14 in this Commonwealth shall be given an eye health examination: 15 (1) upon admission to school; 16 (2) while in the fourth grade; 17 (3) while in the eighth grade;
- 18 (4) as part of the evaluation of and prior to the student

- 3 (5) as part of the evaluation of and prior to the student's

- 6 <u>89-10, 20 U.S.C.</u> § 6301 et seq.); and
- 7 (6) as part of the evaluation of and prior to the student's
- 8 inclusion in an IEP.
- 9 (b) A school district or joint school board that institutes
- 10 an eye health examination program under subsection (c) shall be
- 11 <u>exempt from providing eye health examinations as required under</u>
- 12 subsection (a).
- 13 (c) A school district or joint school board may institute an
- 14 eye health examination program for children of school age.
- 15 Before a school district or joint school board institutes an eye
- 16 health examination program under this subsection, the program
- 17 shall be approved by the Secretary of Health.
- 18 (d) The parent or quardian of a child of school age shall
- 19 submit evidence that the child received an eye health
- 20 examination in accordance with subsection (a).
- 21 (e) This section shall not apply to a child who is not
- 22 <u>enrolled in a public school.</u>
- 23 (f) As used in this section, "eye health examination" means
- 24 an evaluation performed by an optometrist or ophthalmologist
- 25 that includes all of the following:
- 26 (1) An evaluation of vision history.
- 27 (2) An external and internal ophthalmic examination.
- 28 (3) An assessment of vision acuity, ocular alignment and
- 29 motility and refraction.
- 30 (4) An assessment of accommodation and binocular vision.

1 Section 2. This act shall take effect in 60 days.
