AN ACT

- 1 Establishing the COVID-19 Community Restaurant and Catering
- 2 Business Grant Program and the COVID-19 Community Restaurant
- and Catering Business Grant Fund to provide grants to
- 4 restaurant businesses impacted by COVID-19.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the COVID-19
- 9 Community Restaurant and Catering Business Grant Program Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "CARES Act." The Coronavirus Aid, Relief, and Economic
- 15 Security Act (Public Law 116-136, 134 Stat. 281).

- 1 "Department." The Department of Community and Economic
- 2 Development of the Commonwealth.
- 3 "Fund." The COVID-19 Community Restaurant and Catering
- 4 Business Grant Fund established under section 4.
- 5 "Proclamation of disaster emergency." The proclamation of
- 6 disaster emergency issued by the Governor on March 6, 2020,
- 7 published at 50 Pa.B. 1644 (March 21, 2020), and any renewal of
- 8 the state of disaster emergency.
- 9 "Program." The COVID-19 Community Restaurant and Catering
- 10 Business Grant Program established under section 3(a).
- "Restaurant business." A nonfranchise employer in this
- 12 Commonwealth that satisfies all of the following criteria:
- 13 (1) The employer has a 72251, 72241, 722320 or 722330
- North American Industry Classification System (NAICS)
- designation from the United States Census Bureau.
- 16 (2) The employer's gross annual receipts for the prior
- fiscal year did not exceed \$5,000,000.
- 18 Section 3. Establishment of program.
- 19 (a) Establishment.--The COVID-19 Community Restaurant and
- 20 Catering Business Grant Program is established within the
- 21 department.
- 22 (b) Duties of department. -- The department shall provide
- 23 grants under the program in accordance with this act to
- 24 restaurant businesses that are adversely affected financially
- 25 due to the novel coronavirus, known as COVID-19, identified in
- 26 the proclamation of disaster emergency.
- 27 Section 4. Establishment of fund.
- The COVID-19 Community Restaurant and Catering Business Grant
- 29 Fund is established as a special fund in the State Treasury.
- 30 Money appropriated under section 11 shall be deposited into the

- 1 fund to be used exclusively by the department to award grants to
- 2 restaurant businesses under the program.
- 3 Section 5. Grant application forms.
- 4 (a) Development. -- The department shall develop a grant
- 5 application form for restaurant businesses to apply for a grant
- 6 under the program. At a minimum, the grant application form
- 7 shall contain the following information:
- 8 (1) The name, address and contact information of the
- 9 restaurant business.
- 10 (2) The amount of grant money requested under the
- 11 program.
- 12 (3) The proposed use for the grant money requested under
- 13 the program.
- 14 (4) The financial impact on the restaurant business
- due to the novel coronavirus, known as COVID-19, identified
- in the proclamation of disaster emergency.
- 17 (5) Any other information that the department deems
- 18 necessary and appropriate.
- 19 (b) Submission. -- A restaurant business must submit the grant
- 20 application form under subsection (a) to the department in a
- 21 manner prescribed to be eligible for a grant under the program.
- 22 Section 6. Award of grants.
- 23 (a) Review.--No later 20 days after receipt of the grant
- 24 application form under section 5(a), the department shall review
- 25 the grant application form, determine whether to award a grant
- 26 to the restaurant business under the program and determine the
- 27 amount of the grant money to be awarded to the restaurant
- 28 business if applicable.
- 29 (b) Considerations. -- In determining the amount of the grant
- 30 money to be awarded to the restaurant business, the following

- 1 shall apply:
- 2 (1) The department shall consider all of the following:
- 3 (i) The geographic and demographic diversity of the restaurant business.
- (ii) How the restaurant business and the surrounding community of the restaurant business would be served through the award of the grant money to the business.
- 8 (2) The department may require documentation and
 9 information regarding the gross annual receipts and employees
 10 of the restaurant business.
- 11 (c) Notice. -- After conducting a review and making a
- 12 determination on a grant application under subsection (a), the
- 13 department shall provide written notice to the restaurant
- 14 business of the award or denial of a grant under the program.
- 15 Notice of the award of a grant under the program shall include
- 16 the amount of the grant money awarded and any conditions or
- 17 restrictions on the use of the grant money. Notice of the denial
- 18 of all or part of the grant money requested under the program in
- 19 the grant application shall include the reasons for the full or
- 20 partial denial.
- 21 Section 7. Public notice.
- The department shall provide information regarding the
- 23 availability and award of grants under the program on the
- 24 department's publicly accessible Internet website.
- 25 Section 8. Limitation on award of grants.
- Subject to the availability of funding, a grant to a
- 27 restaurant business under the program shall not exceed \$20,000.
- 28 Section 9. Reports.
- 29 (a) Preparation. -- No later than 60 days after the notice is
- 30 published under section 12(a), the department shall prepare a

- 1 report that lists each restaurant business that received grant
- 2 money under the program and a summary of the information
- 3 specified in each grant application under section 5(a).
- 4 (b) Publication. -- The department shall post the report under
- 5 subsection (a) on the department's publicly accessible Internet
- 6 website.
- 7 Section 10. Guidelines.
- 8 The department may promulgate guidelines for the
- 9 implementation and administration of this act.
- 10 Section 11. Appropriation.
- 11 In addition to any other money made available to the
- 12 Commonwealth for COVID-19 relief, the sum of \$100,000,000 of the
- 13 money available to the Commonwealth under the CARES Act is
- 14 appropriated to the department for the purpose of awarding
- 15 grants under the program.
- 16 Section 12. Expiration.
- 17 The authority of the department to award grants under the
- 18 program shall expire 30 days after the termination or expiration
- 19 of the proclamation of disaster emergency.
- 20 Section 13. Effective date.
- 21 This act shall take effect in 30 days.
