Amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, in Department of Military Affairs, providing for burial benefits. 3 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: Section 1. Title 51 of the Pennsylvania Consolidated 6 Statutes is amended by adding a section to read: 8 § 705.1. Burial benefits. 9 (a) Notice of deceased serviceperson to county .--(1) Subject to paragraph (2), a licensed funeral 10 11 director, funeral entity or cemetery company shall, within 96 12 hours of receipt of the remains of a deceased serviceperson, 13 notify the county director of veterans affairs of a deceased 14 serviceperson having legal residence in the county at the 15 time of death and provide the family of the deceased

serviceperson with the contact information for the county

- 2 (2) Paragraph (1) shall ONLY apply to a cemetery company <--

- 14 Code.
- 15 "Funeral entity." As defined in 49 Pa. Code § 13.1 (relating
- 16 to definitions).
- 17 <u>"Licensed funeral director." As defined in 49 Pa. Code §</u>

- 19 Section 2. This act shall take effect in 60 days.
