AN ACT

Amending the act of December 5, 1936 (2nd Sp.Sess., 1937) P.L.2897, No.1), entitled "An act establishing a system of unemployment compensation to be administered by the 3 Department of Labor and Industry and its existing and newly 4 created agencies with personnel (with certain exceptions) 5 selected on a civil service basis; requiring employers to keep records and make reports, and certain employers to pay 7 contributions based on payrolls to provide moneys for the 8 payment of compensation to certain unemployed persons; 9 providing procedure and administrative details for the 10 determination, payment and collection of such contributions 11 and the payment of such compensation; providing for 12 cooperation with the Federal Government and its agencies; 13 creating certain special funds in the custody of the State 14 Treasurer; and prescribing penalties," in compensation, 15 further providing for qualifications required to secure 16 compensation. 17 The General Assembly of the Commonwealth of Pennsylvania 18 19 hereby enacts as follows: 20 Section 1. Section 401(b) of the act of December 5, 1936 21 (2nd Sp.Sess., 1937 P.L.2897, No.1), known as the Unemployment

Compensation Law, is amended by adding a paragraph to read:

- 15 Section 2. This act shall take effect immediately.
