Amending Title 65 (Public Officers) of the Pennsylvania 1 Consolidated Statutes, in lobbying disclosure, further 2 providing for reporting, providing for conflict reporting and 3 further providing for administration; and making editorial 5 changes. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Sections 13A04(e)(4) and 13A05 heading of Title 65 of the Pennsylvania Consolidated Statutes are amended to 10 read: § 13A04. Registration. 11 12 13 (e) Termination. --* * * 14 15 Nothing in this subsection shall be construed to 16 exempt a lobbyist, lobbying firm or principal from any of the 17 requirements in section 13A05 (relating to expense 18 reporting).

- 3 Section 2. Title 65 is amended by adding a section to read:
- 4 § 13A05.1. Conflict reporting.
- 5 <u>Each lobbyist shall, subject to the penalties under 18</u>
- 6 Pa.C.S. § 4904 (relating to unsworn falsification to
- 7 <u>authorities</u>), file a conflict report with the department
- 8 <u>electronically using the computerized filing system developed by</u>
- 9 the department that is consistent with the purpose of this
- 10 chapter no later than five days after the lobbyist has sought a
- 11 waiver from a client due to a conflict of interest with the
- 12 client and another client. The lobbyist shall file the response
- 13 of the client concerning the waiver.

- 15 (5), 13A08(c) and (j) and 13A09(g)(2) of Title 65 are amended to

- 19 registration under section 13A04 (relating to registration) and
- 20 reporting under section 13A05 (relating to expense reporting):

- 26 (5) A principal or lobbyist required to report under

- 30 has complied with this section.

- 4 (c) Public inspection and copying. -- The department shall
- 5 make completed registration statements, expense reports,
- 6 <u>conflict reports</u> and notices of termination, which have been
- 7 filed with the department, available for public inspection and
- 8 provide copies of these documents at a price not in excess of
- 9 the actual cost of copying. The department shall make all
- 10 registrations and reports available on a publicly accessible
- 11 Internet website. Documents maintained and reproducible in an
- 12 electronic format shall be provided in that format upon request.

- 14 (j) Inflation adjustment. -- On a biennial basis commencing in
- 15 January 2009, the department shall review the threshold under
- 16 section 13A06 (relating to exemption from registration and
- 17 reporting) for registration under section 13A04 (relating to
- 18 registration) and the threshold for reporting under section
- 19 13A05(d) (relating to expense reporting) and shall increase
- 20 these amounts to rates deemed reasonable for assuring
- 21 appropriate disclosure. On a biennial basis commencing in
- 22 January 2009, the department shall review the filing fee
- 23 established under section 13A10 (relating to registration fees;
- 24 fund established; system; regulations) and may by regulation
- 25 adjust this amount if the department determines that a higher
- 26 fee is needed to cover the costs of carrying out the provisions
- 27 of this chapter. The department shall publish adjusted amounts
- 28 in the Pennsylvania Bulletin by June 1, 2009, and by June 1
- 29 every two years thereafter as necessary.
