A JOINT RESOLUTION

- Proposing an amendment to the Constitution of the Commonwealth 1
- of Pennsylvania, further providing for tenure of justices, 2
- judges and justices of the peace. 3
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with Article XI:
- That section 15 of Article V be amended to read: 8
- § 15. Tenure of justices, judges and justices of the peace. 9
- 10 (a) The regular term of office of justices and judges shall
- be ten years and the regular term of office for judges of the 11
- municipal court in the City of Philadelphia and of justices of 12
- the peace shall be six years. The tenure of any justice or judge 13
- 14 shall not be affected by changes in judicial districts or by
- 15 reduction in the number of judges.
- 16 [A] Except as provided under this section 15(c), a
- 17 justice or judge elected under section 13(a), appointed under
- section 13(d) or retained under this section 15(b) may file a 18

- 1 declaration of candidacy for retention election with the officer
- 2 of the Commonwealth who under law shall have supervision over
- 3 elections on or before the first Monday of January of the year
- 4 preceding the year in which his term of office expires. If no
- 5 declaration is filed, a vacancy shall exist upon the expiration
- 6 of the term of office of such justice or judge, to be filled by
- 7 election under section 13(a) or by appointment under section
- 8 13(d) if applicable. If a justice or judge files a declaration,
- 9 his name shall be submitted to the electors without party
- 10 designation, on a separate judicial ballot or in a separate
- 11 column on voting machines, at the municipal election immediately
- 12 preceding the expiration of the term of office of the justice or
- 13 judge, to determine only the question whether he shall be
- 14 retained in office. If a majority is against retention, a
- 15 vacancy shall exist upon the expiration of his term of office,
- 16 to be filled by appointment under section 13(b) or under section
- 17 13(d) if applicable. If a majority favors retention, the justice
- 18 or judge shall serve for the regular term of office provided
- 19 herein, unless sooner removed or retired. At the expiration of
- 20 each term a justice or judge shall be eligible for retention as
- 21 provided herein, subject only to the retirement provisions of
- 22 this article.
- 23 (c) A justice of the Supreme Court shall be eligible to
- 24 serve two terms. A justice of the Supreme Court who shall have
- 25 exceeded the term limitation prescribed under this subsection
- 26 shall be permitted to complete their current term in office.
- 27 Section 2. (a) Upon the first passage by the General
- 28 Assembly of this proposed constitutional amendment, the
- 29 Secretary of the Commonwealth shall proceed immediately to
- 30 comply with the advertising requirements of section 1 of Article

- 1 XI of the Constitution of Pennsylvania and shall transmit the
- 2 required advertisements to two newspapers in every county in
- 3 which such newspapers are published in sufficient time after
- 4 passage of this proposed constitutional amendment.
- 5 (b) Upon the second passage by the General Assembly of this
- 6 proposed constitutional amendment, the Secretary of the
- 7 Commonwealth shall proceed immediately to comply with the
- 8 advertising requirements of section 1 of Article XI of the
- 9 Constitution of Pennsylvania and shall transmit the required
- 10 advertisements to two newspapers in every county in which such
- 11 newspapers are published in sufficient time after passage of
- 12 this proposed constitutional amendment. The Secretary of the
- 13 Commonwealth shall submit this proposed constitutional amendment
- 14 as a single ballot question to the qualified electors of this
- 15 Commonwealth at the first primary, general or municipal election
- 16 which meets the requirements of and is in conformance with
- 17 section 1 of Article XI of the Constitution of Pennsylvania and
- 18 which occurs at least three months after the proposed
- 19 constitutional amendment is passed by the General Assembly.
