## AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled "An act relating to the finances of the State government; providing for cancer control, prevention and research, for 3 ambulatory surgical center data collection, for the Joint Underwriting Association, for entertainment business financial management firms, for private dam financial 6 assurance and for reinstatement of item vetoes; providing for 7 the settlement, assessment, collection, and lien of taxes, 8 bonus, and all other accounts due the Commonwealth, the 9 10 collection and recovery of fees and other money or property due or belonging to the Commonwealth, or any agency thereof, 11 including escheated property and the proceeds of its sale, 12 the custody and disbursement or other disposition of funds 13 and securities belonging to or in the possession of the 14 15 Commonwealth, and the settlement of claims against the Commonwealth, the resettlement of accounts and appeals to the 16 courts, refunds of moneys erroneously paid to the Commonwealth, auditing the accounts of the Commonwealth and 17 18 all agencies thereof, of all public officers collecting 19 20 moneys payable to the Commonwealth, or any agency thereof, and all receipts of appropriations from the Commonwealth, 21 authorizing the Commonwealth to issue tax anticipation notes 22 23 to defray current expenses, implementing the provisions of section 7(a) of Article VIII of the Constitution of 24 Pennsylvania authorizing and restricting the incurring of 25 certain debt and imposing penalties; affecting every 26 department, board, commission, and officer of the State 27 government, every political subdivision of the State, and 28 29 certain officers of such subdivisions, every person, association, and corporation required to pay, assess, or 30 31 collect taxes, or to make returns or reports under the laws 32 imposing taxes for State purposes, or to pay license fees or other moneys to the Commonwealth, or any agency thereof, 33 every State depository and every debtor or creditor of the 34

- Commonwealth," in disposition of abandoned and unclaimed 1
- property, further providing for notice and publication of lists of property subject to custody and control of the Commonwealth under this article. 2

- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 6
- 7 Section 1. Section 1301.12 heading, (b) introductory
- paragraph and (c) of the act of April 9, 1929 (P.L.343, No.176), 8
- 9 known as The Fiscal Code, are amended and the section is amended
- 10 by adding a subsection to read:
- 11 Section 1301.12. [Notice] Notices and Publication of Lists
- 12 of Property Subject to Custody and Control of the Commonwealth
- under this Article. --\* \* \* 13
- The published notice under subsection (a) shall be 14
- 15 entitled "Notice of Names of Persons Appearing to be Owners of
- 16 Abandoned and Unclaimed Property, " and shall contain:

- 18 (c) The State Treasurer is not required to include in [such]
- the notice under subsection (a) published in an English language 19
- 20 newspaper of general circulation any item of less than two
- 21 hundred fifty dollars (\$250) or to include in such notice
- 22 published in a legal newspaper any item of less than two hundred
- 23 fifty dollars (\$250), unless the State Treasurer, in either
- instance, deems such publication to be in the public interest. 24

- 26 (d.1) No less frequently than once every five years, the
- State Treasurer shall determine whether a county, city, borough, 27
- township, incorporated town or school district is identified as 28
- 29 the apparent owner of property which has been paid or delivered
- 30 to the State Treasurer under section 1301.13. If a county, city,
- borough, township, incorporated town or school district is 31
- identified to be the apparent owner of such property, the State 32

- 1 Treasurer shall notify the appropriate governing body or officer
- 2 of the county, city, borough, township, incorporated town or
- 3 school district. The notice shall contain a statement that,
- 4 according to a report filed with the State Treasurer, property
- 5 <u>is being held to which the addressee may be entitled.</u>

- 7 Section 2. This act shall take effect in 60 days.
