## AN ACT

1 2 3 4 5 6 7	Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," providing for the Universal School Meal Program; establishing the Universal School Meal Fund; and making an appropriation.
8	The General Assembly of the Commonwealth of Pennsylvania
9	hereby enacts as follows:
10	Section 1. The act of March 10, 1949 (P.L.30, No.14), known
11	as the Public School Code of 1949, is amended by adding an
12	article to read:
13	<u>ARTICLE XIV-C</u>
14	UNIVERSAL SCHOOL MEAL PROGRAM
15	<u>Section 1401-C. Definitions.</u>
16	The following words and phrases when used in this article
17	shall have the meanings given to them in this section unless the
18	context clearly indicates otherwise:
19	"Breakfast." A meal that meets the meal requirements

1	<u>specified in 7 CFR 220.8 (relating to meal requirements for</u>
2	breakfasts) and 220.23 (relating to nutrition standards and menu
3	planning approaches for breakfasts) and that is served to a
4	child in the morning hours.
5	"Department." The Department of Education of the
6	Commonwealth.
7	"Fund." The Universal School Meal Fund established in
8	section 1406-C.
9	"Lunch." A nutritiously adequate meal provided by a public
10	school entity, served during a meal service period, that
11	qualifies for a Federal reimbursement under the National School
12	Lunch Program.
13	"Meal service period." A time reserved for meals in a school
14	day, established in a manner that best meets the needs of the
15	school and participating students.
16	"National School Lunch Program." As defined in 7 CFR 210.2
17	<u>(relating to definitions).</u>
18	"Program." The Universal School Meal Program established in
19	section 1402-C.
20	"Public school entity." Any of the following:
21	(1) A school district.
22	(2) A charter school, regional charter school or cyber
23	<u>charter school.</u>
24	(3) An area career and technical school.
25	(4) An intermediate unit.
26	"School Breakfast Program." As defined in 7 CFR 220.2
27	<u>(relating to definitions).</u>
28	Section 1402-C. Universal School Meal Program.
29	(a) Establishment and purpose
30	(1) The Universal School Meal Program is established to

1	provide two free meals each school day to each student of a
2	public school entity regardless of the household income of
3	the student.
4	(2) The purposes of the program are to:
5	(i) Further the principle that no child should
6	<u>experience hunger.</u>
7	(ii) Provide that each student of a public school
8	entity benefit from healthy meals and have the
9	nourishment needed to achieve academic success, free from
10	<u>stigma or stress.</u>
11	(b) Duty to provide free breakfastEach public school
12	entity that serves breakfast shall provide all students of the
13	public school entity a meal that meets the requirements of the
14	School Breakfast Program during each school day at no cost,
15	without consideration of the student's eligibility for a
16	federally funded free or reduced-price meal, with a maximum of
17	one free meal per student for each meal service period.
18	(c) Duty to provide free lunchEach public school entity
19	that serves lunch shall provide all students of the public
20	school entity a meal that meets the requirements of the National
21	School Lunch Program during each school day at no cost, without
22	consideration of the student's eligibility for a federally
23	funded free or reduced-price meal, with a maximum of one free
24	meal per student for each meal service period.
25	(d) Data collection
26	(1) Except as provided in paragraph (3), each public
27	school entity shall collect household income information
28	regarding students of the public school entity through a
29	household meal benefit application or an alternate household
30	income data collection form established by the public school

2	(i) Be used to determine the number of students who
3	are eligible for federally funded free or reduced-price
4	meals from the United States Department of Agriculture.
5	(ii) Remain confidential and shall not be shared by
6	the public school entity other than as necessary for
7	purposes of determining funding allocation.
8	(iii) Not be used to deny any student from receiving
9	two free meals each school day.
10	(2) Students for whom household income information is
11	not collected under paragraph (1) shall continue to be
12	provided two free meals each school day upon request.
13	(3) Paragraph (1) does not apply if the public school
14	entity is able to obtain equivalent information through
15	another means, such as eligibility for other assistance
16	programs.
17	(e) Additional foodIf an additional snack or other food
18	is offered by the public school entity that is not included in
19	the free meal, students may be required to purchase the
20	additional snack or other food unless the public school entity
21	provides the additional snack or other food at no charge.
22	(f) Administration
23	(1) The department shall administer this program and
24	develop guidance and monitoring requirements as it deems
25	necessary to implement this article.
26	(2) The State Board of Education may, in the manner
27	provided by law, promulgate regulations as necessary to carry
28	out the provisions of this article.
29	Section 1403-C. Public school entity reporting.
30	(a) RequirementBeginning January 1, 2023, and each school

1	year thereafter, each public school entity shall report data to
2	the department regarding the program. Each public school entity
3	shall report the following:
4	(1) The number of students who qualify as eligible for
5	federally funded free or reduced-price meals.
6	(2) The total reimbursement to the public school entity
7	from the United States Department of Agriculture through the
8	National School Lunch Program and the School Breakfast
9	Program.
10	(b) Accurate dataA public school entity that reports
11	inaccurate data shall coordinate with the department to rectify
12	any discrepancies.
13	(c) MonitoringThe department shall monitor public school
14	entities that receive State reimbursement for compliance with
15	the provisions of this article, consistent with their cyclical
16	monitoring schedule, at a minimum.
17	Section 1404-C. State reimbursement.
18	(a) Federal reimbursementAs a condition for receiving
19	State reimbursement as described in this section, each public
20	school entity shall maximize the amount of Federal reimbursement
21	available through the National School Lunch Program and the
22	School Breakfast Program of the United States Department of
23	Agriculture for students who qualify and participate in the
24	community eligibility provision for all schools that qualify.
25	(b) AmountThe department shall provide State
26	reimbursement to public school entities equal to the difference
27	between the Federal free reimbursement rate and the reduced-
28	price and the paid reimbursement rates under the National School
29	Lunch Program and the School Breakfast Program.

1	(1) The department shall distribute State reimbursement
2	under this article to public school entities.
3	(2) The department shall not be required to distribute
4	State reimbursement under this article to public school
5	entities if the United States Department of Agriculture
6	provides a full reimbursement for meals from the National
7	School Lunch Program and the School Breakfast Program.
8	Section 1405-C. School meal operations.
9	(a) DutyTo the extent possible, each public school entity
10	shall provide a meal in which the cost of the meal is equal to
11	or less than the Federal reimbursement rate for a free meal
12	during any given school year, as determined annually by the
13	United States Department of Agriculture.
14	(b) Federal reimbursement rateA public school entity
15	shall only receive State reimbursement from the department up to
16	the Federal reimbursement rate. The public school entity shall
17	be responsible for any additional costs if the cost per meal is
18	more than the amount set by the Federal reimbursement rate.
19	Section 1406-C. Universal School Meal Fund.
20	(a) EstablishmentThe Universal School Meal Fund is
21	established as a nonlapsing fund in the State Treasury.
22	(b) Operations
23	(1) All money deposited into the fund and the interest
24	that the money accrues are appropriated to the department on
25	a continuing basis to provide State reimbursement to public
26	school entities under the program.
27	(2) No administrative action shall prevent the deposit
28	of money into the fund in each fiscal year.
29	<u>(c) Use of fund</u>
30	(1) The fund may only be used for the program and the

1	appropriation shall not lapse at the end of any fiscal year.
2	(2) No money in the fund shall be transferred or
3	diverted to any other purpose by administrative action.
4	(d) SourcesMoney available to the fund shall include
5	appropriations and transfers from the General Fund, the Budget
6	Stabilization Reserve Fund, special funds, Federal funds and
7	other sources of revenue made available to the fund.
8	(e) AppropriationBy December 1, 2022, the sum of
9	\$275,000,000 shall be appropriated from the General Fund to the
10	<u>fund.</u>
11	Section 2. This act shall take effect immediately.
