5	WHEREAS, Investments in road and bridge construction are
6	critical to highway safety, mobility and economic development of
7	this Commonwealth; and
8	WHEREAS, Despite the highest liquid fuels tax in the country, <
9	highest tolled Turnpike in the world and increasing driver fees,
10	reliable and sustainable transportation maintenance and
11	construction remains a systemic issue in this Commonwealth; and
12	WHEREAS, Pennsylvania ranks second in the nation in number of
13	bridges in poor condition and faces a \$8.1 billion shortfall for
14	critical infrastructure maintenance; therefore be it
15	WHEREAS, DESPITE HAVING ONE OF THE HIGHEST LIQUID FUELS TAXES <
16	IN THE COUNTRY, INCREASING DRIVER FEES AND TRANSPORTATION
17	MAINTENANCE AND CONSTRUCTION REMAIN AN ISSUE IN THIS
18	COMMONWEALTH; AND

WHEREAS, PENNSYLVANIA RANKS FIFTH IN THE NATION IN NUMBER OF

- 1 STATE AND LOCAL BRIDGES WITH DECK AREAS IN POOR CONDITION AND
- 2 FACES AN \$8.1 BILLION SHORTFALL FOR CRITICAL INFRASTRUCTURE
