AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in organization meetings and officers
- of boards of school directors, further providing for
- 7 solicitor and other appointees.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 406 of the act of March 10, 1949 (P.L.30,
- 11 No.14), known as the Public School Code of 1949, is amended to
- 12 read:
- 13 Section 406. Solicitor and Other Appointees. -- (a) Each
- 14 board of school directors may appoint a solicitor, such
- 15 assistant solicitors and such other appointees, clerks or
- 16 employes as it may deem proper, none of whom, except as provided
- 17 in section three hundred twenty-four of this act, shall be a
- 18 member of the board, and shall define their duties and fix their
- 19 salaries.
- 20 (b) In addition to any other duties prescribed by law, when

- 1 participating at a regular or special meeting in accordance with
- 2 this act, it shall be the duty of a solicitor or assistant
- 3 solicitor appointed by a board of school directors to:
- 4 (1) Act loyally and in accordance with the best interests of
- 5 the students and parents of the school districts under the board
- 6 of school directors' jurisdiction and authority.
- 7 (2) Act impartially and avoid conflicts of interest that
- 8 impair the solicitor's ability to act in the best interests of
- 9 the students and parents.
- 10 (3) Abstain from deception and practice honesty and equity
- 11 <u>in matters that concern the education, health, safety and</u>
- 12 general welfare of students.
- 13 (4) Act with the care, competence and diligence ordinarily
- 14 exercised by solicitors or assistant solicitors of boards of
- 15 school directors.
- 16 (5) Act in good faith.
- 17 (c) A parent or student may bring a civil cause of action in
- 18 a court of common pleas based upon a violation of a duty under
- 19 subsection (b) and may recover one thousand dollars (\$1,000) per
- 20 violation in addition to treble damages and any other relief
- 21 deemed appropriate by the court.
- 22 Section 2. This act shall take effect in 60 days.
