AN ACT

- 1 Amending the act of March 28, 1984 (P.L.150, No.28), entitled
- 2 "An act relating to the rights of purchasers and lessees of
- defective new motor vehicles," further providing for
- 4 definitions.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The definition of "new motor vehicle" in section
- 8 2 of the act of March 28, 1984 (P.L.150, No.28), known as the
- 9 Automobile Lemon Law, is amended and the section is amended by
- 10 adding a definition to read:
- 11 Section 2. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 * * *
- 16 <u>"Farm equipment." A new and unused vehicle that is</u>
- 17 specifically designed and manufactured for and used exclusively
- 18 <u>in agriculture to plant, seed, cultivate, harvest or apply soil</u>

- 1 <u>nutrients, fertilizers or chemicals, which was purchased or</u>
- 2 leased and is registered in this Commonwealth or purchased or
- 3 <u>leased elsewhere and registered for the first time in this</u>
- 4 Commonwealth.
- 5 * * *
- 6 "New motor vehicle." As follows:
- 7 <u>(1) Any of the following:</u>
- (i) Any new and unused self-propelled, motorized 8 conveyance driven upon public roads, streets or highways 9 which is designed to transport not more than 15 persons, 10 which was purchased or leased and is registered in [the] 11 12 this Commonwealth or purchased or leased elsewhere and 13 registered for the first time in [the] this Commonwealth 14 and is used, leased or bought for use primarily for 15 personal, family or household purposes, including a vehicle used by a manufacturer or dealer as a 16 17 demonstrator or dealer car prior to its sale.
 - (ii) Farm equipment.
- 19 <u>(2)</u> The term does not include motorcycles, motor homes 20 or off-road vehicles[.] that are not specifically designed 21 and manufactured for and used exclusively in agriculture to 22 plant, seed, cultivate, harvest or apply soil nutrients,
- fertilizers or chemicals.
