## **OVERVIEW:**

House Bill 174 Print Number 2067 consolidates various food safety related laws under Title 3 Agriculture with technical clarifications and federal compliance. The bill repeals the following:

- The Public Eating and Drinking Place Law, because the material is supplied by 3 Pa.C.S. Chapter 57 Subchapter A.
- The Food Act because the material is supplied by 3 Pa.C.S. Chapter 57 Subchapter B.
- Section 602-A (16) of the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, because the fees are under 3 Pa.C.S. Chapter 57 Subchapter A.

Section 6504(a), relative to the frequency of onsite presence of a certified food handler, will take effect when regulations are promulgated, or in two years, whichever occurs first. The remainder of the act takes effect in 60 days.

## **ANALYSIS:**

This bill codifies current law and authorizes the Department of Agriculture (PDA) to establish regulations for using risk-based factors established by the Food and Drug Administration (FDA) relating to the interval between license renewals. The bill proposes two new PDA fees related to re-inspections.

- 1. Inspection (2nd follow-up) \$150
- 2. Inspection (3rd or more): \$300

PDA conducts about 40,000 Retail Food Facility inspections per year. On average, 6% require a first re-inspection or 2,400 facilities. Of those, historical data shows 50% require a second re-inspection or 1,200 facilities. The introduction of re-inspection fees will provide an incentive to retail food facilities to do a better job of compliance with this act. Therefore, assuming that 50% of the historical data will require re-inspection, the estimated new revenue is \$180,000. This assumes 600 facilities require a 2<sup>nd</sup> and that 300 of those facilities will need a 3<sup>rd</sup> re-inspection.

The fee change was a recommendation of the Auditor General that came as a result of a 2005 audit of PDA's food inspection records. Local political subdivisions continue to operate food facility license programs and adopt fees at their discretion by local ordinance.

The bill removes a PDA issued a certification fee to food handlers who are already certified under an approved training program. This PDA duplicate certification was for five years and had a \$20 fee. The removal of this fee will result in estimated loss of \$180,000 in revenue.

PDA's food safety costs for 2008-09 are budgeted at \$9.8 million. The related PDA fee revenue is \$2.4 million which represents 24% of costs. The 2009-10 food safety costs are estimated at \$10.6 million. The related fee revenue, including the proposed re-inspection fees, is estimated at \$2.4 million or 23% of costs.
