HB 1456, PN 3190 (Amended)

By Rep. J. L. WRIGHT

An Act amending the act of May 5, 1933 (P. L. 364, No. 106), entitled, as amended, "An act relating to corporations; defining and providing for the organization, merger, consolidation, reorganization, winding up and dissolution of certain corporations for profit; conferring certain rights, powers, duties and immunities upon them and their officers and shareholders; prescribing the conditions on which such corporations may exercise their powers; providing for the inclusion of certain existing corporations and associations within the provisions of this act; prescribing the terms and conditions upon which certain foreign corporations may be admitted, or may continue, to do business within the Commonwealth; conferring powers and imposing duties on the courts of common pleas, and certain State departments, commissions, and officers;

authorizing certain State departments, boards, commissions, or officers to collect fees for services required to be rendered by this act; imposing penalties; and repealing certain acts and parts of acts relating to corporations and other entities," further providing for the right of a public utility corporation to condemn property inside the limits of a railroad line or street railway.

Mr. E. H. SMITH. Mr. Speaker, on SB 616 I would like to be recorded in the affirmative. I did not vote, because I was not in my seat.

BILLS ON THIRD CONSIDERATION CONTINUED

The House proceeded to third consideration of HB 1986, PN 2496, entitled:

An Act amending the act of July 11, 1923 (P. L. 1044, No. 425), referred to as the Prisoner Transfer Law, further providing for transfers.

On the question,

Will the House agree to the bill on third consideration? Mr. GOEBEL offered the following amendments:

Amend Title, page 1, line 9, by removing the period after "transfers" and inserting, requiring that rules and regulations relating to inmates at penal and correctional institutions apply equally to both male and female inmates.

Amend Bill, page 3, by inserting between lines 21 and 22 Section 2. The act is amended by adding a section to read: Section 2.1. In making or approving rules and regulations relating to inmates at penal or correctional institutions pursuant to this or any other act, the Department of Justice shall ensure that the rules and regulations directly relating to inmates, including rules or regulations governing personal safety or security, shall apply equally to both male and female inmates.

Amend Sec. 2, page 3, line 22, by striking out "2." and inserting 3.

On the question,

Will the House agree to the amendments?

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Goebel.

Mr. GOEBEL. Mr. Speaker, this amendment was passed out quite a while ago. I do not know if the members still have it on their desks. It is A5697.

Mr. Fisher, the sponsor of the bill, has no objection to the amendment. It states that in making or approving rules and regulations relating to inmates of penal or correctional institutions that the regulations governing personal safety or security shall apply equally to both male and female inmates. The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Fisher.

Mr. D. M. FISHER. I have no objection to the amendment. I think it is a good amendment and I would urge its adoption.

BILLS ON THIRD CONSIDERATION CONTINUED

The House proceeded to third consideration of HB 1993, PN 2790, entitled:

An Act amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing for certain arrests.

On the question,

Will the House agree to the bill on third consideration? Mr. WHITE offered the following amendment:

Amend Sec. 1 (Sec. 8901), page 2, line 9, by striking out all of said line and inserting committed in the officer's view, or where the officer has reason to believe an offense was committed, while the officer is within the territorial limits of his political subdivision.

On the question,

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. White.

Mr. WHITE. The original intent of the bill is to permit a police officer in one district to exercise arrest powers in an adjacent district if he, while in his district, sees a crime occurring in the adjacent district.

The purpose of the amendment is to clarify this in the language of the legislation and to exert clearer language to make it all possible. The problem with the current language is that it is too vague and may permit police officers to engage in making arrests while both the offense and the officer are outside the police officer's district.

The language in this amendment had been discussed in the Subcommittee on Crime and Corrections. I believe that the sponsor of the legislation has indicated that he has no problem with it, nor has the chairman of the Subcommittee on Crime and Corrections expressed any concern for the amendment. I would hope that we would have an affirmative vote from the House on this particular amendment, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Fisher.

Mr. D. M. FISHER. The gentleman from Philadelphia, Mr. White, is correct. I reviewed this amendment with both Mr. White and Mr. Wilson 2 weeks ago, and I believe that Mr. White's amendment does nothing more than clarify the **LEGISLATIVE JOURNAL—HOUSE**

original intent of the act, that the police officer, to be authorized to make the arrests across the boundary line, would at least have been in his political subdivision when he viewed the commission of the offense. For that reason I urge the adoption of the White amendment. Thank you, Mr. Speaker.

On the question recurring, Will the House agree to the amendment?
