#### STATEMENT BY MR. WOZNIAK

##### TERCENTENARY COMMITTEE ON THIS DAY IN HISTORY

The SPEAKER. The Chair recognizes the gentleman from Cambria, Mr. Wozniak.

Mr. WOZNIAK. On this day in history, Mr. Speaker, the people of Johnstown surveyed the devastation and damage inflicted by the raging waters the day before. It began early on Friday, the 31st of May, 1889. A boom in the Stony Creek broke away, and the mass of logs swept down against the inundated houses. Later that afternoon the dam at South Fork Lake broke, and the mass of water that swept through the valley carried everything before it away. Sixteen million tons of water raced through the area.

On this day, June 1, the residents of Johnstown surveyed the damage and counted the casualties - 2,235 persons dead, more than \$10 million in property damages. It was written at that time in history that nothing in the history of the United States in time of peace ever approached the appalling catastrophe of the Johnstown Flood of 1889.

Mr. A. C. FOSTER. Thank you, Mr. Speaker.  
My amendment merely corrects an omission in SB 851 with regard to the fee of \$30 for an appeal from the court of common pleas to an appellate court. The same line is contained in SB 852 but was somehow omitted from SB 851.

The SPEAKER. The Chair recognizes the gentleman from Berks, Mr. Davies.

Mr. DAVIES. Mr. Speaker, I, personally, had a difficult time understanding the gentleman. Not to delay the thing, but if he could repeat it so that we would have the benefit of that explanation, I would appreciate it.

The SPEAKER. Would the gentleman from York, Mr. Foster, kindly repeat his explanation of the amendment?

Mr. A. C. FOSTER. Thank you, Mr. Speaker.

The amendment merely corrects an omission in SB 851 with respect to the fee paid for an appeal from the court of common pleas to an appellate court. If you would check SB 852 for a similar section, you would find this same language present in SB 852, but for some reason it was omitted from SB 851. I would ask for an affirmative vote on the amendment.
