There will never be another day quite like it in this magnificent place surrounded by family and friends – your son, Dylan; your mother, Judy Hogarty; and your other family members and friends. You have accepted the tremendous responsibility which was given to you by the people of your legislative district.

Becoming a member of this body is a special privilege, yet it is one that you have truly earned. In a little less than 2 months, you personally visited over 7,000 homes in your legislative district. That kind of devotion is truly remarkable, and we admire your dedication, your hard work, and your perseverance. That you possess these characteristics, to us in this chamber, is not surprising. Your predecessor had them all in spades. All of us in this chamber deeply care about the constituents who send us here, and one who was truly dedicated to those he served was your dad, Roy Cornell. Today, Sue, you embark on one of the most challenging and rewarding journeys of your life, a journey shared by the other 202 members of this body. Never forget that regardless of party and regardless of politics, we all share the same ultimate goals. We strive to bring into existence a greater good to ensure that all of the people of Pennsylvania have a better chance at a better life. By working hard to meet the needs of your constituents and by never ceasing to give careful, thoughtful consideration to measures which find their way before you here, you will be doing your part.

We look forward to working with you, Sue. Your energy, your enthusiasm, your friendly advice are always welcome, and my door to my office is always open.

Congratulations on becoming a member of the Pennsylvania House of Representatives, and good luck, Sue.

### **REMARKS BY MAJORITY LEADER**

The SPEAKER. The Chair now recognizes the majority leader, the Honorable Sam Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

To Honorable Judge Wogan, it is a pleasure to have you in our presence once again.

To the members, to all the family and friends of our newest member, Sue Cornell, it is an honor and a pleasure to participate in this congratulatory swearing in for Sue Cornell.

Actually, Sue has helped to take a little load off of my back, being that she finally got the House Republicans back to the 109 we began this session with last November. My whip keeps kind of busting my chops about the fact that since I have been majority leader, we have only lost spaces, but of course, those were due to unforeseen and forces outside of our control. So, Sue, I want to give you a personal thanks for helping us get back to the 109 that we began this legislative session at.

You know, as you set on this new time in your life, Sue, you will be forging a legacy of leadership, and I am sure that you have used the memory of your father as a source of strength and energy to bring you to this day, and I am certain that it has to bring with it a certain bittersweet element of the day, and yet, you know, you worked hard through your campaign. You told the people of the district, of the 152d District in Montgomery County, that you understood the issues, and you do, and that you are willing to go work on those issues that are important to your constituents, the issues of open space and the medical malpractice issue that is important to many of us across the Commonwealth. The 7,000-plus personal contacts that you made over that short campaign is a testimony to your will and to your desire to work on behalf of the people of that legislative district and the people of Pennsylvania and your ability to bring about with you the friends and volunteers and the family members that go about actually making a campaign and truly giving it life through erecting the red, white, and blue signs throughout the district. I think the percentage of vote that you won by is a testimony to not only the organization and the people that you brought to the campaign but to you as an individual, as a candidate who put yourself forth as someone to go out and represent these people.

It is funny - a lot of people that have never run for public office, they do not know how personal it is to put your name on the ballot, and everyone here that sits in this hall certainly understands, and I am sure, Sue, that today you recognize it a little more than you even did in the past as you worked with your father, but it is very personal. You put your name on the ballot and you hold yourself out to win or lose, and sometimes that is a very difficult and personal thing to undertake, and you need to be especially congratulated under the circumstances of this special election for your fortitude and your hard work.

But today you bring about your own legacy. You bring about a fresh, bold outlook. Although something that you and I and a few other members in this have in common, having succeeded a parent to the legislature, you will find that there is always going to be a little bit of a comparison. You are always going to be compared a little bit to what your father did and this was the way your father did something or whatever. I know I experienced that same thing. And while I have been fortunate enough to have my father still be around to give me little bits of advice and some ideas about who is who and what is what, and unfortunately, you do not have that blessing, I think you will still find strength in knowing what he did, and when people talk about your father, know that it is meant in such a way as to help you build your own legacy, for you to build your own record of accomplishment within this body, and it is something that over the years of having worked with your father, I know that is what really builds the potential for a great Representative, and you will certainly have the potential to fulfill that over the years.

You can count on our support. Something that you will find in this body, as you may recognize, is that you will have friends on both sides of the aisle, and while Judge Wogan started off looking at a marriage ceremony this morning, you know, it is not wholly inappropriate in some respects. While a term of office in the legislature is not till death do us part, it nevertheless is a deep and abiding bond that will live with you for the rest of your life no matter how long you are a member of the legislature, and it is a commitment of that kind of deep sincerity that a marriage ceremony also carries with us when you stood here and took the oath of office.

You also find that sometimes in this body – I have said this before at other swearing ins in the past year – sometimes it is not just what any one of us thinks, and I think what makes this body so great and what makes this country of ours great, not just the Commonwealth but this country, is that it is our collective wisdom, that it is not my idea or your idea or another member's individual idea, but it is sometimes when those ideas all meld together in the collective wisdom of this body – I guess I am going out on a limb here, but it could even include the collective wisdom of the Senate – that melds together to create the laws and the procedures that we live by, the policies that we live by in this Commonwealth, that they all meld together to help us be a better and stronger people, and we know that you bring to this body a portion of that collective wisdom that will help us as a body to move Pennsylvania forward.

### **REMARKS BY MR. LEVDANSKY**

#### **GUESTS INTRODUCED**

Before I offer a few words in memory of my predecessor, Representative Miscevich, let me first introduce the members of his beloved family that have traveled here to witness this today: his beloved wife, Josephine; his daughter, Leesa Miscevich, and her two children, Gibson and Berlin; his daughter, Becky, and her husband, Scott, and her two children, Taylor and Austin; and good family friends, Dorothy and Wayne Phillips. Thanks for coming.

Twenty years ago I made a commitment to public service, but unfortunately, it meant that I had to run against a fine gentleman who served the people of the 39th District for 8 years before me.

When I think about George Miscevich's life, I think about, really, a life of professional versatility. There are few men that I have met in my life that can claim to be master of so many trades. In addition to being a State Representative, George worked as a diesel mechanic; he was a teacher – he taught people, young kids, how to work with their hands at the Connelley School – he worked at U.S. Steel Irvin Works where he was both a union member and a foreman at one point in his career; and then he went on to become a legislator, and after 8 years of service here in the General Assembly serving the people of the 39th District, he went on to work as a field auditor for the Auditor General.

But I have also got to share a few observations about 1984, and that was the year that I decided that I really wanted to be a State Representative. We are both from the Mon Valley, and the Mon Valley, those of you who are probably aware, is pretty strong Democratic country, so when you want to be a legislator in the Mon Valley, you are pretty much faced with the dilemma of running against an incumbent Democrat in the primary. We fought a good, hard political battle in 1984, but when I look back on it, our battles were never, ever personal. Oh, we had some differences of opinion on how to handle certain issues and we had a difference of political style and we both came from different generations, but we both shared common ethnic roots. George was a proud, 100-percent Serbian man and was very proud of that. I am half Polish and half Slovak. We both share traditional working-class values. The communities we are privileged to represent are working-class communities, and we

shared a common commitment to the values and the traditions of the Democratic Party.

I am happy to have had the opportunity to share some good times with George Miscevich as well, and I value his service to our mutual constituents and the political insights and even advice that he came to give me later on in his life so generously.

While his family and friends and constituents will miss him dearly, we should all realize that his spirit lives on in the people of the Mon Valley he was so proud to represent.

Under the current law, our current National Guard's members and reservists who have served on active duty in Iraq and Afghanistan and on ships at sea and in combat areas do not qualify under our current law for veterans' benefits, but they do qualify under the Federal system. What this bill does is to bring them up on an equal footing, if you will, with those who are on active duty who served in the same places. In fact, some reservists have served more time than the active duty forces.

This is an important bill, and one thing I would recommend is we all get together and urge the Senate to pass this as quickly as possible, because a number of our young men and women, and some not so young, have returned, and they are entitled to these benefits.

When no spouse or minor children survive, the benefit shall be paid to the parent or parents of such National Guard member, State police officer or other law enforcement officer of the Commonwealth. The benefit shall be payable whether or not the National Guard member or officer was killed within the Commonwealth of Pennsylvania.

(f) On July 1 of each fiscal year beginning after January 1, [1995] 2004, the Commonwealth shall adjust the level of the benefit payable immediately before July 1 under subsections (d) and (e) of this section to reflect the annual percentage change in the Consumer Price Index for All Urban Consumers, published by the United States Department of Commerce, Bureau of Labor Statistics, occurring in the one-year period ending on January 1 immediately preceding July 1.

Section 3. Section 2 of the act, amended October 16, 1981 (P.L.295, No.102), is amended to read:

Section 2. "Firefighter, ambulance service or rescue squad member or law enforcement officer" means a firefighter[,]; a member

(1) The amendment of sections 1(d), (e) and (f) and 2 of the act shall take effect in 60 days.

The remainder of this act shall take effect (2)immediately.

Mr. HUTCHINSON. Mr. Speaker, I rise in support of HB 2285. Quite simply, this bill would provide State death benefits to families of emergency responders as well as National Guard members who suffer a heart attack or a stroke within 24 hours of a physical training exercise or an emergency response. This bill will bring our State death benefit into line with recent changes in the Federal death benefit for these very deserving individuals, and I ask for your support, and then I will also submit further remarks for the record.

The SPEAKER. The Chair thanks the gentleman.

# **REMARKS SUBMITTED FOR THE RECORD**

Mr. HUTCHINSON submitted the following remarks for the Legislative Journal:

Fighting an intense fire is a very strenuous and stressful job. Simply moving around while wearing heavy fire-retardant clothing and lugging heavy and awkward gear into a burning building takes a great deal of strength and stamina.

Now add to the equation a respirator, the rush of adrenaline, a few extra pounds and a few extra years - along with a respectful fear of danger - and you have got all the makings of a heart attack or stroke in the let-down hours following the emergency response.

The same type of circumstances can induce fatal heart attacks or strokes following a response to a serious auto accident, a face-off during a dangerous police incident, and after completing an intense military training exercise.

But more often than not in incidents of death by heart attack or stroke, under the current Firefighter, Ambulance Service, Rescue Squad, Law Enforcement or National Guard Line of Duty Death Benefits Act, it has been ruled such deaths were not a direct result of an injury sustained in the line of duty.

As a result, families receive no benefits even though the deaths were clearly triggered by the rigors of the job.

This situation is not right and must be corrected. We recognize that our emergency responders are our first line of defense here at home. They not only respond to fires, accidents, medical emergencies, and police incidents; since September 11, they have stepped into a new role – that of our protector against terrorist threats.

The families of these outstanding men and women also must not be neglected. They know that every time a call comes in, danger awaits. They know that each time their loved ones respond to an emergency, they may not return.

My legislation, HB 2285, clarifies and corrects this omission in Pennsylvania's death benefits law. It brings State law into conformity with recently enacted Federal law that considers heart attacks and strokes within a 24-hour period to be a compensable line-of-duty death for the Federal death benefit program.

This situation has been particularly serious for the families of volunteer firefighters who have suffered heart attacks upon returning from fighting an intense fire.

According to National Volunteer Fire Commission statistics, nearly half of all firefighter fatalities, though clearly caused by the rigors of the job, are not covered because they were heart related.

We are also facing a similar situation with members of the National Guard as they are put through more frequent, tougher training exercises in preparation for being activated to Iraq, Afghanistan, Kosovo, and other terrorist danger spots around the world.

Because Pennsylvania's current law is ambiguous, specific cases are falling through the cracks. With this legislation, we can end a longstanding problem that has put the burden on families to fight for benefits they rightly deserve - a situation that giving loved ones should never have to endure.

Specifically, HB 2285 establishes that a heart attack or stroke-related death of an emergency responder – police officers, firefighters, and emergency medical personnel – or a member of the National Guard in the line of duty or within 24 hours thereafter is compensable under the emergency responders' death benefit act.

Again, we stand with our heroes and their families by providing help for the families of our protectors.

On the question recurring, Shall the bill pass finally?
