#### **BILLS ON THIRD CONSIDERATION**

The House proceeded to third consideration of **HB 612**, **PN 685**, entitled:

An Act amending the act of March 1, 1988 (P.L.82, No.16), known as the Pennsylvania Infrastructure Investment Authority Act, further providing for definitions.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman, Mr. Markosek, the gentleman from Allegheny.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, I would like to interrogate the prime sponsor of the bill, please.

The SPEAKER. The gentlelady indicates that she will stand for interrogation. The gentleman is in order and may proceed.

Just one second.

Please, keep the noise levels down, please. Nobody can hear anyone in here, please.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, HB 612 passed the Commerce Committee several weeks ago and now, of course, is on the House floor for a vote on final passage.

Since the bill has passed the committee, some information has come to light. This bill passed the House unanimously last year and died in the Senate. Since that occurred, there has been a court case offered by the courts that has answered some of the questions regarding this bill.

I would like to ask the prime sponsor if she is aware of that court case, and in light of that court case or that court decision, how does that affect the bill and, in fact, is the bill still necessary?

Mrs. RUBLEY. Thank you, Mr. Speaker.

Frankly, I am not aware of this court case. I mean, all this bill does is clarify within the definition of PENNVEST (Pennsylvania Infrastructure Investment Authority) that moneys needed by water and wastewater facilities to improve their security devices would be an allowable grant under PENNVEST. So maybe you can enlighten me on how the court case would affect this.

Mr. MARKOSEK. The courts have ruled that utilities, water utilities, for example, could go to the PUC (Public Utility Commission) and seek relief that way for security issues, which I believe the original intent of the bill last session was based on the fact that they could not do that. With this court ruling, they can now do that. Therefore, the reason behind this bill is no longer necessary.

Mrs. RUBLEY. Well, it was my understanding, Mr. Speaker, that the larger water systems were going to the PUC to allow for an offset in their expenses. My concern rests with the smaller systems, many of which are not under the PUC at all, and these systems are very vulnerable because the owners of these systems often do not have the wherewithal to put in the necessary protections to make sure that they are not going to be affected by any threats of terrorism, such as cameras, fences, things like this. So I cannot see where this court case would have an impact because we are really gearing this to the smaller systems that would not necessarily have access to the PUC.

Mr. MARKOSEK. Mr. Speaker, I do not disagree with the intent of the bill, but as many of us know, the devil is often in the details on these kinds of issues. Certainly, security of all of our utilities is very important.

#### MOTION TO TABLE

Mr. MARKOSEK. Mr. Speaker, in light of this court case and in light of some of the information that has come forward since we put this bill out of committee, I think it would not be unreasonable for us to take a little longer look at this. Therefore, Mr. Speaker, I will make a motion, or I would like to make a motion, if I am in order, to table the bill to a date certain, April 11, so that we can go back and get our staffs together, get the prime sponsor, the folks in the Governor's Office all on the same page with this bill and iron out some of these details that I think we need to do before this bill becomes a reality.

Again, I support the intent of the bill. I applaud the lady in her attempt to introduce this bill and to have this kind of an

issue before us. However, I think there are some problems with the language that certainly a week or two here, a date certain of April 11, would not be unreasonable. So I make the motion that we table the bill until April 11, which I believe is our next scheduled session day.

The SPEAKER. It has been moved by the gentleman, Mr. Markosek, that HB 612, PN 685, be postponed until April 11.

On the question,

Will the House agree to the motion?

The SPEAKER. On that motion, the Chair recognizes the majority leader.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, I oppose the motion to table for a couple of reasons. One, Mr. Speaker, we have not had exactly the heaviest load of legislative work. This bill was moved through the process, and the concerns being raised at the last minute I do not think are all that valid and are not something that cannot be dealt with through the remaining part of the legislative process. It is an issue that the legislature, the House, is pretty well familiar with, and I think that we should take up this business today.

Furthermore, to table it into the week of April 11 is flying into the face of a week when we hope to do the initial passage of the State budget. That budget week, in and of itself, is very time-consuming, and I do not really think it is proper to delay the vote on this bill at this point in time.

So I would urge the members to oppose the motion to table. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the minority leader.

Mr. DeWEESE. Mr. Speaker, I support the gentleman, and I would prefer that he expatiate.

The SPEAKER. Mr. Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, the intent certainly is not to kill the bill here. I am in favor of the bill. I supported it in committee, and I can understand the majority leader's opposition and his feelings towards this.

Mr. Speaker, if we could put the bill over temporarily, I would consider withdrawing the motion, certainly.

The SPEAKER. Would Mr. Markosek please come to the rostrum.

(Conference held at Speaker's podium.)

### MOTION WITHDRAWN

The SPEAKER. The gentleman, Mr. Markosek, has withdrawn his motion to table.

On the question recurring, Shall the bill pass finally?

The SPEAKER. On final passage, the Chair recognizes the gentleman, Mr. Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, I have withdrawn the motion to table the bill temporarily, although the bill does need some work. As I mentioned in my interrogation, I am not opposed to this bill.

In many, many ways, it is a very good bill and a very necessary bill

I understand the ramifications of the schedule here. I will say this, though. Our staff has come up with some things that need to be changed, some of the details of the bill, and I would urge that we pass the bill today, send it over to the Senate. We will be informing the Senate of our concerns, and hopefully, with the prime sponsor and with the appropriate Senate committee as well as the Governor's Office, we can work out the differences in this bill and craft a very good and reasonable piece of legislation to deal with these security problems.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

I would like to see this done, and I would also like to thank the gentleman from Erie County for allowing me to amend his bill, and I would ask the Speaker's permission to submit remarks for the record.

#### REMARKS SUBMITTED FOR THE RECORD

Mr. YUDICHAK submitted the following remarks for the Legislative Journal:

Mr. Speaker, I rise to offer amendment A00194 to HB 402 and encourage members to adopt the amendment. The amendment would redesignate the Carey Avenue Bridge that connects the Luzerne County communities of Plymouth Borough, Larksville Borough, and Hanover Township as the 1st Battalion, 109th Field Artillery Pennsylvania Army National Guard Bridge.

The Pennsylvania National Guard is the largest unit of citizen soldiers in the nation. Members of the Pennsylvania National Guard have long demonstrated their dedication to the service of their Commonwealth and their country. Our nation's war on terrorism has, however, redefined the role of our National Guard units. Members of the Pennsylvania National Guard, in great numbers, are now deployed throughout the world defending the principles of American freedom on the battlefield.

In April of 2004, Sgt. Sherwood Baker, a Plymouth Borough resident and a member of the 1st Battalion, 109th Field Artillery PA Army National Guard, bravely gave his life in service to his country in the Iraq war. Sherwood Baker became the first Pennsylvania National Guard member to perish in combat since World War II. Sergeant Baker's death made it clear that as America asks more of its National Guard units, we must also be prepared to do more for the members of the National Guard and their families as they make great personal sacrifices in service to our nation.

In December of 2004, Governor Rendell signed into law legislation that I authored known as the Sgt. Sherwood Baker bill that will honor all Pennsylvania soldiers who are killed on active duty by providing their children with a free college education at any State-owned, State-related, or community college in Pennsylvania. The Sgt. Sherwood Baker bill is a great step toward ensuring Pennsylvania remembers the debt it owes to its citizen soldiers and their families.

The legislation I bring before the House of Representatives today will continue the spirit of the Sgt. Sherwood Baker bill and honor all the members, past, present, and future, of Sergeant Baker's unit, the 1st Battalion, 109th Field Artillery Pennsylvania Army National Guard, by memorializing their service through the renaming of the Carey Avenue Bridge to "1st Battalion, 109th Field Artillery Pennsylvania Army National Guard Bridge."

The "109th Bridge" will forever serve as a tribute to the members of Pennsylvania's National Guard and will be a reminder to us all of the responsibility we have to remember those brave souls who boldly volunteer to put their lives on the line to preserve the freedoms we cherish. I thank all the members of the Pennsylvania National Guard for their valiant service, and I ask my colleagues to join me in support of this legislation that will authorize the renaming of the Carey Avenue Bridge to "1st Battalion, 109th Field Artillery Pennsylvania Army National Guard Bridge."

A Resolution commemorating the bicentennial of the Lewis and Clark Expedition; and congratulating and commending the Senator John Heinz Pittsburgh Regional History Center and The Academy of Natural Sciences in Philadelphia for their outstanding educational exhibits and other activities relating to the transcontinental expedition of Meriwether Lewis, William Clark and the Corps of Discovery.

On the question, Will the House adopt the resolution?

The SPEAKER. The Chair recognizes the gentleman from Centre, Mr. Herman.

Mr. HERMAN. Thank you very much, Mr. Speaker, and I thank you and your staff for reserving No. 200 for this very special bicentennial HR 200.

Mr. Speaker, next Thursday, April 7, marks a very special day in American history as it is the 200th anniversary of the third year of the famed Lewis and Clark Expedition to the great Northwest Territories of the Louisiana Purchase, from Fort Mandan, North Dakota, to the Pacific Ocean to what is now known as Astoria, Oregon.

Mr. Speaker, there are many signature events for this coming bicentennial year on that trek in the Northwest, but I offer this resolution to commemorate this bicentennial but also to remind all historians and tourists who are taking advantage of the Lewis and Clark trail that all this bicentennial work really started here in Pennsylvania. It was in 1803, Mr. Speaker, that Captain Meriwether Lewis spent much time here in Pennsylvania making ready for this great journey into the great Northwest Territories and through very dangerous Indian territorial lands.

Even in your own city of Philadelphia, Mr. Speaker, Captain Meriwether Lewis spent much time learning from the greatest scientists of the world, of that day in Philadelphia, where he studied anatomy and paleontology under Dr. Caspar Wistar and medicine under Dr. Benjamin Rush, and also Dr. Robert Patterson of the University of Pennsylvania taught Meriwether Lewis how to find latitude and longitude, and Benjamin Smith Barton taught him how to preserve and collect flora species, which are still available today for everyone to see at Philadelphia's Academy of Natural Sciences, and Meriwether Lewis also spent some time in Lancaster studying under Andrew Ellicott where he gave Meriwether Lewis instructions on celestial navigation.

But it did not start and end there, Mr. Speaker. Captain Meriwether Lewis also started from Pittsburgh, which was then the western-most port of the United States of America, where he ordered a very specially made keelboat and a pirogue, which were the watercraft necessary for him and his soldiers and civilians to make that great trek down the Ohio River and up the Mississippi and Missouri Rivers into Northwest Territory.

Mr. Speaker, this HR 200 commemorates the bicentennial of the Lewis and Clark Expedition, but it also recognizes the great work of the Academy of Natural Sciences in Philadelphia as well as the Senator John Heinz Regional History Center in Pittsburgh for their outstanding displays and educational artifacts they have for the public, for all of us to enjoy for now and in future years.

Mr. Speaker, I request a unanimous vote on HR 200. The SPEAKER. The Chair thanks the gentleman.
