For the life with which You have blessed us and for the day that lies ahead of us, we offer You our thanks, for we recognize You as the source of all good things in our lives. Make us diligent and determined that no good thing which You have invested in us will be neglected or wasted, as we hold in our hands the resources of this land and of this people. Lead us through this day, gracious God, as we commit ourselves to follow You without fear. Amen.

Today it is my distinct pleasure and honor to introduce Miss Kaytlin Roholt, standing behind me. Last year she entered an essay contest as a junior at Wallenpaupack Area High School. Upon writing the essay against 13,000 other submissions, she was declared the national winner. For this, she received a \$10,000 scholarship. She opened Wall Street by ringing the bell. She received a laptop computer. She also received a pizza party for her class.

So please join me in congratulating her for a job well done. Not only did she win the contest, but she is also ranked number two in her class at Wallenpaupack Area, and it is my distinct pleasure to introduce her today.

## WESTERN CENTER FOR TECHNICAL STUDIES PRESENTED

The SPEAKER. The Chair recognizes Representative Bob Mensch and Representative Thomas Quigley for the purpose of an introduction.

Mr. QUIGLEY. Thank you, Mr. Speaker.

It is with great pleasure that I present today, along with my colleague, Bob Mensch, recognition for students and teachers and advisors from the Western Center for Technical Studies, which is located in Limerick Township in my district. These young men and women have graced us with their presence after having performed a great service for their fellow Americans.

Some time ago I and then colleague Representative Ray Bunt went to the Western Center for Technical Studies located in Limerick Township to hear about a program, a project that they were undertaking to help a serviceperson down in Louisiana. The project was to construct a modular home, a transportation of that home to a designated location in Louisiana, transportation of the students to that location, and completion of the project on site by the students from the Western Technical Studies, and then of course transferring the keys and the ownership to this family.

The family that was chosen for the house project had to be a military family, it had to be a family that a husband and wife was either lost or injured in the Iraqi war, and the last factor to determine the family is that they lost their home due to Hurricane Katrina, which many call the hurricane of the century.

The Western Center for Technical Studies is a cooperative between three school districts: the Pottsgrove School District, the Spring-Ford School District, and the Upper Perkiomen School District. Students there can enroll in full-time, 1- or 2-year programs for vocational training in such areas as auto collision, auto technology, construction technology, electrical/mechanical, health occupational, metal technology, just to name a few.

The mission statement for the Western Center for Technical Studies is to prepare quality citizens for lifelong productivity in a challenging world by forming innovative partnerships among family, school, and community, and I think when you hear my colleague, Representative Bob Mensch, explain the details of what took place with this great project, you will find out that they have certainly lived up to that mission statement.

Thank you, Mr. Speaker.

Mr. MENSCH. We are all familiar with the adage "commit a random act of kindness." Today we are here to recognize 41 individuals who collectively committed a random act of kindness.

You see, S. Sgt. James Johnson of Lake Charles, Louisiana, served with the Louisiana National Guard in Iraq and was seriously wounded. When he returned home, he learned his 7-year-old daughter, Gracie, had leukemia. Then he and his wife, Heather, endured the loss of their home to the ravages of Hurricane Katrina. Without a home, wounded and caring for his ill daughter, Sergeant Johnson, I am told, never lost his faith, his courage, or his commitment to his family.

Then a wonderful thing happened. A group of volunteers, more than a thousand miles away, decided to help Sergeant Johnson and his family. They decided to build him a new home. This is by no means an ordinary construction project. The students, faculty, and administration of the Western Technical Center in Montgomery County began to build the Johnsons their new home in the back lot of the school in Limerick, Pennsylvania. Working with local donors for supplies and materials and with staff leadership, they showed what the Pennsylvanian can-do spirit is really all about.

As the Johnson family lived in temporary housing in Louisiana, the construction proceeded here in Pennsylvania. Twenty-seven students, along with 14 faculty and adult advisors, worked diligently to finish the home for this American hero and his family.

In early May, just as the home was completed, it appeared all that was left to do was put the house on two trucks and transport it to Louisiana. But then there came a shortage of money for the shipment, so working with local businesses, we were able to raise the necessary \$20,000 in only a few days. Then once the home was on its way, the trucks experienced mechanical problems. They were only 30 miles from the technical school. So the same corporate partners quickly dispatched employees, mechanics and welders, and they repaired the trucks, and again, the trucks were on their way.

The students here today traveled to Lake Charles, along with the faculty and parents, to complete the siting of the home on its foundation. Today it is our turn to take our stand in supporting the selfless efforts of these extraordinary volunteers. Now, while in Louisiana, they received from the National Guard the highest civilian award that the Louisiana National Guard can present, the Distinguished Citizen Award.

Many times we talk about duty, honor, and sacrifice. And this story is not complete without our remembering and honoring Staff Sergeant Johnson, a civilian soldier, for his bravery and service and his family for their courage in the face of adversity. So today we honor the students, faculty members, and administration and volunteers from the Western Center for their volunteerism. We often speak of "random acts of kindness." This endeavor is a gold medal winner in that category.

Representative Quigley and I are pleased to also be joined by our colleagues, Representatives Doug Reichley, Tim Hennessey, and Mike Vereb, in honoring our fellow Pennsylvanians.

To the students, faculty, and administration of the Western Center for Technical Studies of Montgomery County, we all extend our thanks and our appreciation. You are indeed among our best and our brightest.
