## CLARE ZALES PRESENTED

The SPEAKER. The Chair would now invite the Commonwealth's State Librarian, Clare Zales, to come up to the podium for a few brief remarks and to explain why I am in this attire. Clare, would you please come up?

Ms. ZALES. Thank you, Mr. Speaker.

In response to you exercising your historic prerogative to call for a volume from the State Library collection to be present in deliberations and resolutions on the House floor, it is with honor and awe that I present to you the second volume of the work of John Locke. This volume is one of 425 volumes that was referenced during the writing of our Constitution and the Declaration of Independence. This volume in particular was selected because it directly influenced Thomas Jefferson's writing of the words "life, liberty and the pursuit of happiness."

On behalf of all the generations since then who have been influenced by this collection and involved in its care, I present it to you today that it may inspire our deliberations today and inspire future generations as we strive for that more perfect Union.

Mr. Speaker, the collection is yours.

The SPEAKER. Thank you very much. Thank you, Clare.

I do not know if any of you have had the opportunity that I have had to go over and visit our Rare Books Collection that is unique to this Commonwealth of Pennsylvania. It was founded by Ben Franklin, who also founded the Library Company of Philadelphia.

The Library Company of Philadelphia was an instrument so the common man could attain learning skills by pooling their resources and buying books. Those books were under attack, and they were moved to three various locations in Pennsylvania – Philadelphia, York, and eventually Harrisburg. Our Founding Fathers and learned members from all over the country would come to our State Library to do their research and their writings.

There is a uniquely engineered facility that is preserving these wonderful books. It is in jeopardy right now, and I submit for our consideration in the House, in the Senate, and the administration that we provide \$10 million to this library to sustain the viability of these publications, these books, these periodicals.

Over the years, other libraries have tried to preserve these. When they press down, they destroy the original documents. This library is something that we should be very, very proud of, but if we do not take care of it, it is going to go away.

Many of us served with the great Speaker Matthew Ryan. This was a project that he started in this Commonwealth. I submit to you that you consider, in the name of Matthew J. Ryan, that we appropriate and finish the work that he started with this library and preserve these books, these periodicals, for generations to come. It is our responsibility, and thank you very much.

An Act amending the act of December 7, 1982 (P.L.784, No.225), known as the Dog Law, further providing for definitions, for issuance of dog licenses, for applications for dog licenses, for license certificates, for kennels, for requirements for kennels, for out-of-State dealer license, for bills of sale, for revocation, suspension or refusal of kennel licenses, for transportation of dogs, for health certificates for importation, for inspections of premises and dogs and for additional duties of department; providing for refusal of entry; further providing for seizure and detention of dogs, for confinement of dogs, for dog bites, for registration, for certain requirements, for control of dangerous dogs, for public safety, for selling, bartering or trading dogs, for damages caused by coyotes, for burdens of proof, for enforcement and for violations; providing for exemption; further defining "releasing agency"; and making editorial changes.

On the question,  
Will the House agree to the bill on third consideration?  
Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally? Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.

(Members proceeded to vote.)

The SPEAKER. For what purpose does the gentleman, Representative Bastian, rise?

Mr. BASTIAN. I would like to speak on final passage.

**VOTE STRICKEN**

The SPEAKER. The clerk will strike the vote.

Representative Bastian.

Mr. BASTIAN. Thank you, Mr. Speaker.

The SPEAKER. The House will come to order.

Representative Bastian is in order.

Mr. BASTIAN. Mr. Speaker, Monday's rejection of certain sound and sensible amendments to HB 2525 was a triumph of extreme policymaking over essential regulation. It is telling and unfortunate that the advice from veterinarians who are recognized as animal-welfare experts would actually be ignored. I am personally and professionally offended by that fact. Recommendations in good faith to the House Representatives from conscientious groups such as the PVMA (Pennsylvania Veterinary Medical Association) and others were met with criticism rather than careful consideration.

All Pennsylvanians want strong and effective oversight of the canine industry. We do not believe the welfare of dogs would be strengthened by forcing responsible kennel owners to move to less regulated States. The maker of the bill will tell you that the PVMA was listened to, but in fact only on the minor issues, not on the major issues.

Without the inclusion of provisions that would have made this a more balanced bill, I will be voting "no," and I urge my colleagues to do so also. Thank you.

#### REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Chair recognizes Representative Staback.

The gentleman indicates that he wishes to submit his remarks for the record. The Chair thanks the gentleman.

Mr. STABACK submitted the following remarks for the Legislative Journal:

Mr. Speaker, I rise in support of HB 2525.

This bill has been the subject of a lot of study and work by the outdoor community throughout the State; in particular, the Sporting Dog Defense Coalition.

I had the opportunity to work closely with the Coalition in working out important portions of this bill and saw firsthand how their concerns were addressed one by one and how this bill became a much better piece of legislation.

The Coalition, speaking on behalf of sporting dog owners, myself included, no longer oppose this bill.

Groups represented by the Coalition include: American Kennel Club, American Beagler, Chester County Fox Hunter Association, Pointer Club of America, Radnor Hunt Club, United Kennel Club, and the Masters of Foxhounds Association of North America, National Hunting Beagle Association, PA Beagle Gundog Association, and many more groups.

Throughout the formation of this bill, their goal was for this measure to become an effective tool to clean up the puppy mill industry while not causing harm to legitimate sporting dog owners. I believe that goal was met.

Representative Hanna should be commended for his hard work towards that goal and for this finished product: a Dog Law that fixes problems without causing them.

Mr. Speaker, for these reasons I support HB 2525 and ask for the members' support.

The SPEAKER. The question is, shall the bill pass finally?  
Representative Gabig.

Mr. GABIG. Thank you, Mr. Speaker.

I just wanted to speak briefly to follow up on Dr. Bastian's comments – very well made. So I will make it brief now.

My wife is a veterinarian also – I think some people know that – a member of the PVMA. She is the president of the Capital Area Veterinary Medical Association. And, of course, I have heard these concerns expressed not only here in the hall of the House but in my house halls. But I am going to take a slightly different tact than Dr. Bastian at this point.

We have got to remember, this is only moving the process along. This still has to go to the Senate for their consideration. This is not going directly to the Governor, so there is still time to work on this bill. There have been a lot of amendments up for consideration. So we are moving the process along. It is a product, I think, that most of us can support at this stage, and if there are some other concerns that need to be raised, we can hopefully address those over in the Senate.

So at this stage I will be supporting this, not because I support every provision or I was glad that every amendment was defeated, but that I just want to move the process along so that we can all accomplish what we want to by helping to keep these animals safely treated here in Pennsylvania.

Thank you very much, Mr. Speaker.

#### REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. Representative Hanna.

Mr. HANNA. Thank you, Mr. Speaker.

I will simply submit my comments for the record as well, but I would like to just respond to the two previous speakers and just say that I want all members to understand that our disagreement with the PVMA is not over the standards themselves that the PVMA would like to see adopted in the bill but over the enforceability of those standards in a court of law.

Unfortunately what the PVMA had advocated would have been either difficult or impossible to enforce in a court of law, and we needed the tougher standards that the department had put forward, and that is what is ultimately in this bill. But we thank the PVMA for their input on the bill, and I encourage a "yes" vote on it.

I would like to submit the balance of my comments for the record, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

Mr. HANNA submitted the following remarks for the Legislative Journal:

House Bill 2525 goes a long way in ensuring the humane care of dogs in the State's commercial kennels.

This bill represents a victory for our dogs, animal lovers, and consumers who buy dogs from commercial kennels. We had overwhelming public support, evidenced by thousands of letters and e-mails, asking us to strengthen the State's Dog Law and put an end to unacceptable practices that are currently perfectly legal.

Not only would some of the proposed changes improve conditions for dogs, but they would also allow for better enforcement of the State's Dog Law, which has been a problem in the past.

The bill would, for the first time in Pennsylvania, define commercial kennels and set standards for these kennels that generally mirror those required by the U.S. Department of Agriculture. Commercial kennels would be defined as any kennel where dogs are bred and sold or transferred to a dealer or pet shop, or where 60 or more dogs are sold or transferred in a calendar year.

The legislation would have little, if any, impact on noncommercial kennels such as boarding kennels, private sporting or hobby kennels, pet stores, rescue shelters, or nonprofit kennels.

Some of the requirements for commercial breeding kennels would:

- double the current cage size for dogs and require solid flooring in cages;
- prohibit the stacking of cages;
- require that dogs be given access to an outdoor area for exercise;
- introduce new standards for temperature controls, lighting, and ventilation; and
- require dogs to receive an annual exam by a veterinarian and prohibit anyone but a veterinarian to euthanize dogs in a commercial kennel.

While we respect the opinions of the Pennsylvania Veterinary Medical Association when it comes to the care of animals, we could not agree with some of their suggestions because they would have been difficult or impossible to enforce in a court of law.

We did work with many stakeholders, including PVMA, to reach a compromise on this bill, including the Pennsylvania Farm Bureau and Senator Mike Brubaker, my counterpart in the Senate. I would also like to thank Representative Casorio for introducing the bill and the 92 legislators who signed on as cosponsors, as well as the many individuals and organizations who testified before the House Agriculture and Rural Affairs Committee to offer suggestions for improving the legislation.

Ensuring the humane treatment of dogs in the State's large-scale commercial breeding kennels is the right thing to do. I urge your support of this legislation, and I urge legislators in the Senate to pass it when it moves to their chamber.

Mr. HERSHEY submitted the following remarks for the Legislative Journal:

Mr. Speaker, I support basic care for ALL dogs. Basic standards exist in today's law and regulations.

I also support many of the provisions in HB 2525 that would make improvements on this basic care. But I think that some of the provisions in HB 2525 go beyond providing basic care and seek to provide conditions that are simply not necessary and which, according to the professional veterinary medical community, could actually be detrimental to the health of dogs.

I supported the provisions offered by Dr. Bastian that would have provided regular veterinary care for dogs in commercial kennels and that would have provided for regular veterinarian-approved exercise outside of the primary enclosure. I am disappointed that this House chose to support a bill that was created from emotion and not based on science and the true welfare of our animals.

Therefore, Mr. Speaker, I will be casting a negative vote.

### STATEMENT BY MR. CIVERA

The SPEAKER. For what purpose does the gentleman, Representative Civera, rise?

Mr. CIVERA. Mr. Speaker, I would like to have a statement with Representative Evans and myself in regard to the budget and the Governor's comments of yesterday. If we could have some order in the House, please.

The SPEAKER. I assume that the two gentlemen have checked with the majority leader under the provision of unanimous consent?

Mr. CIVERA. Yes, we have, Mr. Speaker.

The SPEAKER. The gentleman is in order.

The Chair will ask all members to please take their seats. The Sergeants at Arms will clear the aisles.

Representative Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, as we enter into the '08-09 budget and what we did in July in the House and the budget that we had crafted that was passed well by a majority in the House, as we all know when we look at the financial impacts both on the nation as well as Pennsylvania, the Governor yesterday, which I respect and I applaud, came out with a statement that he is going to conserve \$200 million and \$4.3 million in the independent departments and ask all his department heads to cut as we watch what is going to happen with our budget.

Our budget presently and our revenues are approximately \$118 million short than we were. Our estimate was at \$3.1 million, and what I am saying here today is this, that we are now into some difficult times, and I believe that the administration and the House Democrats as well as the House Republicans agreed when we did our budget that we would protect the \$750 million as far as the Rainy Day money is concerned, my point being this: that I believe now is the time that we put partisan politics aside and that we come together as a group to represent the people that we were sent here to represent.

I do not want to see Pennsylvania get into a situation where in next year's budget, we will have to significantly increase taxes to balance our budget because our Constitution calls for that. I do not want to see Pennsylvania get into a situation where our debt and our revenues are so low that it would be that we would have to drastically go into different programs. So what I am recommending to the majority chairman of the

Appropriations Committee is that we, on a monthly basis, with the Appropriations Committee and the administration, meet with the Appropriations Committee to discuss the budgetary items and the different programs that could be in jeopardy as we come into these difficult times. We must both together and with the administration design a path that will protect Pennsylvania from what other States have gone through.

And my comments today are this: I respectfully thank the Governor for coming out yesterday and saying what he did, because he is recognizing that there is a problem and that there are cuts that have to be made and that there has to be monitoring made as far as the State budget is concerned. And I would wish that Representative Evans – and I am sure he will – would join me in this bipartisan effort where we can have monthly meetings with the administration to go on and discuss our budgetary situation.

### STATEMENT BY MR. D. EVANS
