A Resolution congratulating the Mansfield University Concert Choir and The Mansfieldians for winning world championship gold medals at the World Choir Games in Graz, Austria, July 9 through 19, 2008.

On the question, Will the House adopt the resolution?

The SPEAKER. The Chair recognizes Representative Baker on the resolution.

Mr. BAKER. Thank you very much, Mr. Speaker.

Mr. Speaker, we have a rare opportunity today to honor one of our 14 State universities, Mansfield University, particularly the choir, who defeated 93 other countries in Graz, Austria for gold medals. They have achieved something that never before could ever have been dreamed of for such a small university – the second smallest university in the 14-university family. To think that they have accomplished this given the size of the university is just amazing. I am proud to present them here this afternoon. They won preliminary and world championship gold medals at the World Choir Games held in Graz, Austria. The concert choir, under the direction of Peggy Dettwiler, took the world championship gold medal in the spiritual and gospel open category. The Mansfieldians, a select 12-member ensemble of concert choir members, directed by Shervl Monkelien, took its world championship gold medal in the jazz vocal ensemble, a cappella category. The concert choir also earned a gold diploma in the mixed youth choir category, finishing second and missing the gold medal by less than a point.

Overall, the Mansfield groups earned six gold medals in both qualifying and final rounds. Very appropriately, the theme of this year's games, "Singing Together Brings Nations Together," aptly described the competition, as it brought together 20,000 singers and 441 choirs from 93 countries. I just want to say how proud I am of Mansfield University. I think all 12 million citizens, all 14 State universities, and all Pennsylvanians can be proud of the representation, globally, that Mansfield University and their choir singers performed and accomplished for us. I would like to introduce them now before we take the vote to officially honor them with a resolution.

To my left is the university president of Mansfield University, Maravene Loeschke. We have the director of the concert choir, Dr. Peggy Dettwiler. We have the Mansfieldians director, Dr. Sheryl Monkelien, and two students; from the concert choir, we have Megan McFadden, and from the Mansfieldians, we have Bryan Hoover. They, along with the army of choir students proudly wearing their gold medals, Mansfield University Choir and Mansfieldians, I believe there are 50, 60, 70 of them sitting in the rear of the House, please stand and be recognized.

I hope you had an opportunity to listen to them. They did perform in the Main Capitol Rotunda, and if there were ever a group that sounded like a choir from heaven, this was the group. What an outstanding job. Thank you very much for representing us well in Austria and for your accomplishments, and thank you very much, Mr. Speaker, for allowing this resolution to be voted upon. Thank you.

A Resolution honoring the good works of "Goodies For Our Troops" of Wellsboro and the leadership of Dawn Pletcher and her volunteers and contributors.

On the question, Will the House adopt the resolution?

The SPEAKER. The Chair recognizes Representative Baker on the resolution.

Mr. BAKER. Thank you very much, Mr. Speaker.

Mr. Speaker, we have about seven representatives of the "Goodies For Our Troops" group. They are a much smaller group than the Mansfield Concert Choir, but their impact has been known all over Iraq and Afghanistan. And what this group has done for the last 4 years is just incredible in terms of building the morale, building inspiration, encouragement, support for our troops abroad. I know the House of

Representatives has done some similar efforts in sending gifts, supplies, cards, and different items to our troops abroad over the years, but this particular group, every week, gathers together and puts hundreds of care packages together for at least 150 troops every single week and month to honor and to lift up our troops, particularly our Pennsylvania National Guard members.

I would just like to give you a little bit of information about them. They are a nonprofit, charitable organization. And under the leadership of Dawn Pletcher, they have, along with their small army of volunteers, done something spectacular in providing these items.

Mr. CASORIO. Mr. Speaker-

Mr. Speaker, will the gentleman interrupt, please?

The SPEAKER. For what purpose does the gentleman rise? Mr. CASORIO. Thank you, Mr. Speaker.

Just personal latitude. The gentleman is speaking about our troops in Pennsylvania and folks doing yeoman's tasks to aid them; I think it behooves the House if we could pay attention to the gentleman supporting our troops.

The SPEAKER. The Chair thanks the gentleman. Members will please take their seats.

Mr. BAKER. Thank you very much. I appreciate those kind words.

"Goodies For Our Troops" – they have been providing a lot of gifts and support for our troops, our National Guard members in particular. This weekend I will be honoring three of our troops who paid the ultimate sacrifice. We are going to be dedicating a pavilion in the Pennsylvania Grand Canyon, which is located in my district. Three of them have paid the ultimate sacrifice, and because of that and because of all the ongoing sacrifices and commitment and dedication of our troops, this particular group, who gathers every week and sacrificially gives of their resources, their money, their donations, their time and effort, some are quite young, some are Girl Scouts, some are Boy Scouts, some are elderly, some are young, but they all give and they give graciously and freely.

What they have done, particularly, is to lift up our Pennsylvania National Guard soldiers who have been deployed in the countries of Iraq and Afghanistan. This month alone, they will have sent to 152 of our troops. They are primarily helping troops that are located out of the Wellsboro Armory as well as the Williamsport Armory, Lewisburg and Lock Haven armories. Some are actually, currently as we speak, in training in Mississippi preparing for deployment to Iraq next year. Four hundred and forty-six troops altogether that they have honored, and they continue to do this with Christmas cards, with Christmas gifts, with Thanksgiving cards, Thanksgiving gifts, all year around, 12 months a year. They go basically unthanked. I just, in some small measure and humble way, I think it is appropriate for the House to build up, encourage this group and other groups across Pennsylvania, and I am sure there are others that are doing something similar.

I thought what would be appropriate is to just conclude with those remarks before we vote, but I thought it might be nice to just hear a couple of the e-mails from our troops who are on the front lines about the work that they have done.

Sgt. Russell Wood: "Myself and my guys from 2d Plt thank you and everyone that has given their help and time to send us packages for that lets them know people at home care for them and for what we are doing...."

M. Sgt. Cliff Reynolds from Iraq, "Well I'm back in the sandbox. Once again, thanks for all you're doing for us. I get a little teary-eyed every time I read the support notes from people. They are all really wonderful."

S. Sgt. Chad Nagel from Iraq: "Thank you very much for the e-card and all boxes you guys send us. We really appreciate it."

Pfc. Lorelle Whipple, Afghanistan: "Thank you all so very much for the wonderful snacks, etc., that you've sent us out here. Some days are so long here, it's nice to see God at work through others like you who want to help us out here as we fight for freedom. The reading material was nice to receive..." "Feeling closer to home as I catch up on the latest news. Thank you all for your gifts!"

Cpl. Eric Myers: "Thank you for the package you sent me and my fellow Marines. I know it took a lot of time and effort to put it together by a lot of people."

Christopher Hammond from Iraq: "Thank you for everything you did for myself and many other troops. The packages helped through many hard times."

Sgt. Maj. Patterson from Iraq: "The package full of 'goodies' was a big hit with the soldiers in my unit. I opened the box and within a couple of hours it was already empty. It is good to know that those back home support us. You are 'Great Americans'...."

And just a couple more, Iraq vet, Justin Whipple: "Hello guys, you are a great organization. I was deployed four times and received packages throughout the deployments from you. Every time I would get a package from you..." my colleague's "eyes would light up because he knew that I was going to share it with him."

And Sgt. Fred Miller from Iraq: "Thank you to everyone for the care packages. I appreciate it very much. It's nice to know people at home are thinking of us. It lifts our spirits and gives us strength."

I would like to now introduce the small group that traveled 3 hours to be here today. There are probably 50, 60, 70 other volunteers that are a part of this group and probably hundreds of other people that have donated to them, but if they would please rise as I announce their names. A Resolution congratulating the Chief Complanter Council of the Boy Scouts of America on the occasion of its 95th anniversary.

On the question, Will the House adopt the resolution?

The SPEAKER. The Chair recognizes Representative Rapp on the resolution.

Ms. RAPP. Thank you, Mr. Speaker.

Today it is my great honor and privilege to welcome Scout Master Kevin Bonner and many current members of the Chief Complanter Council of the Boy Scouts of America to the House floor and to offer HR 864 in proud recognition of this organization's 95th anniversary. The Chief Complanter Council, Boy Scouts of America, with headquarters in Warren, Pennsylvania, serves roughly 1,000 youth members throughout Warren County, Pennsylvania, and Hamilton Township in McKean County. It is the oldest continuously registered, nonmerged council in America. The council received its first charter from the National Office of the Boy Scouts of America in July of 1913, as the Warren County Council. Sixteen other councils were chartered before this time, however, these councils either went out of business or merged with another council at some point in their history. The Warren County Council changed its name to Chief Complanter Council in 1954 to honor the famous Seneca Nation chief. Chief Cornplanter.

In 2008 the council is celebrating its 95th anniversary with various events and activities, including a visit by Chief Scout Executive Bob Mazzuca on July 25, 2008. This marked the first-ever visit by a Chief Scout Executive to the Chief Complanter Council. The council's camp property is Camp Olmsted. Situated on the Allegheny Reservoir in the midst of the Allegheny National Forest, Camp Olmsted provides nearly 500 acres of natural woodlands and allows for every water-oriented merit badge that is offered. The camp was named after Ludlow, PA native George Olmsted, founder of the Long Island Lighting Company and former chairman of the National Camping Committee of the Boy Scouts of America, who donated significant funding towards the construction of the camp.

Mr. Olmsted was the recipient of both the Silver Beaver Award from the Warren County Council as well as the Silver Buffalo Award from the national council. Mr. Olmsted received the Silver Buffalo in 1931, just 6 years after the award was initiated. He also served as chairman of the National Camping Committee of the Boy Scouts of America.

The original camp opened in 1927 along the banks of the Allegheny River, but was relocated up the hill from the original site when the Kinzua Dam was built in the early 1960s, creating the Allegheny Reservoir. The new location was first used in August 1965. In 2007 the council took a major step in increasing the quality of the program offered at Camp Olmsted, moving to just one week of summer camp for Boy Scouts and catering only to Chief Complanter Council Troops. The camp staff is still made up of all adult volunteers who give a week of their time to conduct the program for the Scouts. Camp Olmsted also has a Youth Corps consisting of Scouts who are first class and above and who also volunteer their time. In exchange for

their time and hard work, the Youth Corps members get to go to camp at no cost and may work for up to three merit badges during the week.

Now, I am sure many of you are saying, well, who is Chief Cornplanter? When I first came to the House, I was honored to see— Mr. Speaker, may we have order, please?

The SPEAKER. The lady is correct. Members and guests will please take their seats. Conferences will break up.

Ms. RAPP. When I first came to the House, I was thrilled to see, in the East Wing, a portrait in "Hello Pennsylvania," a portrait of one of our famous Seneca Nation chiefs in the State of Pennsylvania, Chief Cornplanter of the Seneca Nation. Pennsylvania Heritage also did a cover page and an article on Chief Cornplanter in 2006. And thus, Chief Cornplanter is very significant to Warren, Pennsylvania, and obviously, to the Chief Cornplanter Boy Scout Council.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 2722**, **PN 4224**, entitled:

An Act designating the bridges on State Route 830 over Interstate 80 in Washington Township, Jefferson County, as the SFC Michael J. Tully Memorial Bridges.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

The Chair recognizes the minority leader, Representative Sam Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Today I rise with great pride to honor Sfc. Michael J. Tully. Sergeant Tully grew up in Falls Creek, Jefferson County, and his passion in life was to be a soldier. At age 18 he joined the Marine Corps and later joined the Army, becoming an Army Ranger. As he advanced in his career, becoming a Special Forces Green Beret, it became increasingly evident that his devotion to his career and to his country was unparalleled.

I did not know Michael personally, but as I was reading some of the messages that were sent to him and his family following his death in Iraq, it became clear to me that he was an extraordinary man. Michael Tully was a model soldier, an ideal son, a caring brother, a loving and devoted father and husband, and a friend to those in need.

There are many sentiments written about Michael's sense of humor, his leadership, his kindness, and his genuine care and concern for others. I wish I had time to share them. However, there are a couple that were especially insightful to me. A fellow soldier shared this, quote, "I knew Mike Tully. We were privates together, went to Airborne school together, then the 82d together. I was crushed when I found out he was killed. He was a genuinely great guy, a super dad, and a real quiet professional. He is truly missed, but he will never be forgotten."

An Army wife wrote of Sergeant Tully volunteering to watch her children after her 2-year-old had an accident and needed to be rushed to the emergency room. She recalled, "I do not remember ever meeting him personally, but I know he was there for my family in time of need.... To me, this speaks of a person who is a true friend with an honest and loving heart.... He left a beautiful mark on the world."

As I read those testaments, I could not help but recall the Parable of the Good Samaritan in which Jesus taught about the importance of loving your neighbor regardless of wealth or status. Michael Tully understood what it meant to love and serve your neighbor. He did it faithfully at home, and he did it gallantly abroad.

Sergeant First Class Tully died August 23, 2007, when his vehicle was struck by an improvised explosive device southeast of Baghdad. He had been in Iraq for about 6 weeks serving as a combat medic, and it was his second tour of duty.

His mother had just mentioned to me when we came in that she had a picture of him with one of his buddies. Both of them were killed in the same incident. Michael was killed instantly and the other young man survived for a while at the hospital, but basically said he wanted to go be with Mike, and she felt that that was Mike's strong spirit calling to his comrade.

His brother, Sfc. John Tully, who was also serving in Iraq at the time, accompanied the body home. They were embraced by a grateful community lining the streets on the day of the funeral.

In addition to the numerous awards Michael was presented during his years of service, he was awarded the Bronze Star, Purple Heart, Meritorious Service Medal, Iraqi Campaign Medal, and the Combat Infantryman Badge following his death.

Today we again show our gratitude to Sergeant Tully by naming two bridges in his hometown in his honor. The legislation we are about to consider designates the Red Mill Bridges in Washington Township, Jefferson County, as the "SFC Michael J. Tully Memorial Bridges."

In addition to the bill we are voting today, we will be presenting a flag that has flown over the Capitol. I will be presenting that to Michael's parents.

Mr. Speaker, we share in the grief of the Tully family. His parents, Jack and Marilyn, are with us today. Would you please rise and be recognized.

We often say there is no greater sacrifice that an individual can give to our country than to give up their life, and I would say, as a parent, there is probably no greater sacrifice than surviving the death of one of your children, and we pass our great sympathy on to the family.

The House proceeded to third consideration of HB 2600, PN 4443, entitled:

An Act amending the act of December 3, 1959 (P.L.1688, No.621), known as the Housing Finance Agency Law, providing for the Pennsylvania Housing Affordability and Rehabilitation Enhancement Program.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

The Chair will ask members to please take their seats. The Chair recognizes Representative Daley.

Mr. DALEY. Thank you, Mr. Speaker.

As the majority chairman of the House Commerce Committee, our committee has recognized the need for all various ways of attacking the mortgage crisis in Pennsylvania as well as the affordable housing issue. The Commerce Committee has done that mission and has done it very, very well, and HB 2600 is part of that component with affordable housing.

We all believe that Pennsylvanians need help and deserve to have safe, decent, and affordable homes, and HB 2600 will do just that by creating the affordable housing trust fund. HB 2600 will keep people in their homes, and it will give everyone a fair chance to achieve the American dream of homeownership. HB 2600 will enable the Pennsylvania Housing Finance Agency to continue to rehabilitate and preserve housing for low- to moderate-income people, especially the elderly and people with disabilities. Providing adequate housing is critical to the economic vitality and will serve as an economic stimulus to all our communities.

In light of the current climate in the housing and financial markets, we must continue to act quickly and not continue to be behind the mark. You have made sure that Pennsylvania has acted quickly.

More than 15,000 Pennsylvanians still today are homeless. More than 90,000 families statewide are on various housing authority waiting lists. These numbers are unacceptable. This legislation has been endorsed by over 300 organizations in the Commonwealth, including the Pennsylvania Builders, the Pennsylvania Realtors, ACORN (Association of Community Organizations for Reform Now), the Housing Alliance of Pennsylvania, the Pennsylvania Banking Department, the Pennsylvania Coalition to End Homelessness, and that list goes on

Representative Hess and I have worked very diligently to make sure this legislation came through the committee and can be considered before we go in this sine die session and get considered and voted upon.

Over 38 other States have already created funds to stimulate production of affordable housing. Pennsylvania has been the leader in that effort, and today we hope that Pennsylvania will become the 39th.

I ask for an affirmative vote, Mr. Speaker. Thank you.

The SPEAKER. Representative Metcalfe.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, may I ask a brief question of the sponsor?

The SPEAKER. Representative Daley indicates he will stand for interrogation. Representative Metcalfe is in order and may proceed.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, as I kind of read through the legislation, it seems like it is going to set up a program whereby money could be appropriated through that program to fund, to give money to low-income-housing-type projects or would it be going directly to homeowners who are looking to buy a home? Would it go directly to the homeowner? Would it go to just the development of low-income housing? How would that work in this legislation?

Mr. DALEY. In this particular legislation, the way it has been drafted, moneys appropriated to the program will go to low- and moderate-single family homes as well as funding will be appropriated for the elderly population.

Mr. METCALFE. So it would go directly to the individual homeowner, both for low-income and senior citizen homes.

Mr. DALEY. Could you restate your question, please?

Mr. METCALFE. Mr. Speaker, I think both of us are having a hard time hearing both the question and the answer because of the—

The SPEAKER. Members will please take their seats. Conferences in the side and center aisles will break up immediately. Conferences will break up. Members will take their seats. Conferences in the side aisle and center aisle and the rear of the House will please break up immediately.

Representative Metcalfe is in order.

Mr. METCALFE. Thank you, Mr. Speaker.

So to restate the question and to make sure that I understand your answer, Mr. Speaker, that the moneys that would be appropriated, if money was appropriated through this legislation – because right now, as I understand it, this legislation does not contain any appropriation but it sets up the structure that would allow for an appropriation to be streamlined through this legislation – that it then would go directly to individual single-family-home owners and then be based on whether or not they are low-income homeowners or elderly homeowners. Is that correct, Mr. Speaker?

Mr. DALEY. It will go for both low- and moderate-income families. It will be single-family housing as well as rental. It will be not for project building like we have seen in the past where we had low-income projects built. We have seen a tremendous shift in the way we have addressed low-income housing in Pennsylvania. The Pennsylvania Housing Finance Agency has taken a different approach, and this money will go for low-to moderate-income individuals, and also those seniors, that will be a single-family dwelling as well as a rental unit.

Mr. METCALFE. And the money would be a grant-type money or it would be a loan to those homeowners?

Mr. DALEY. Yes. What it basically will be is - it is not a grant - it will be fundamentally a low-interest loan to developers to develop these types of properties throughout the Commonwealth.

Mr. METCALFE. Thank you. Thank you, Mr. Speaker.

A few comments on the legislation.

The SPEAKER. Representative Metcalfe is in order and may proceed.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, just as I was driving to Harrisburg today, I was talking to one of my constituents as he made me aware of his observations of the market that was occurring today with the severe drop in the market today. Last week, of course, we were all kind of on the edge of our seats, both those of us that are in office and those of us that are not were watching to see what Congress was going to do regarding the \$700 billion bailout.

Mr. Speaker, there are many people around the country that have been aware of the subprime problems that were created over the years. The majority of constituents that I have been talking to, Mr. Speaker, overwhelmingly did not support the bailout, do not support government dollars – their tax dollars – being used to pay for somebody else's mortgage or inability to pay for their mortgage.

Mr. Speaker, I think this legislation sets up a structure here in Pennsylvania to continue us down the Fannie-Mae, Freddie-Mac-type path. Mr. Speaker, I just find it hard to believe that we are even considering this today with the recent activity in the market in the United States of America and now even what was reported this morning around the world in other markets. It is like there are only so many dollars that can be stripped away from the taxpayers and used for government programs, Mr. Speaker.

We have a problem with roads and bridges in this State. We have a problem where -I guess many of us do not see it as a problem – but the I-80 tolling has been rejected so it has created a need for finding additional money for the roads and bridges. Many of us applaud the rejection of the I-80 tolling, but we have needs in this Commonwealth that benefit the common wealth – the common interest – that we all share to make it from point A to point B, to make it to the jobs that taxpayers have to go to to feed their families, to house their families, to pay their taxes, to make ends meet.

And, Mr. Speaker, to set up yet another government program that is going to take somebody's tax dollars and redistribute them for low-income housing or senior housing, Mr. Speaker, this legislation follows that same conduit that the problems in our economy currently have exposed.

Mr. Speaker, I am going to vote in the negative against this legislation. I do not believe that this is a wise move on the part of this legislature to advance a piece of legislation that is going to set up a program to take yet more tax dollars from our constituents to redistribute into somebody else's pockets.

Thank you, Mr. Speaker.

The SPEAKER. Representative Daley, for the second time.

Mr. DALEY. I am sorry, Mr. Speaker; I will be very quick. I do not want to belabor this issue.

I hate to tell you, Mr. Speaker, that I do not think you understand the current economic crisis on Wall Street. What happened to Fannie Mae and Freddie Mac, what happened to the investment brokers, it has nothing to do with what we are doing today.

This is not a redistribution-of-wealth concept. What this is is reaching out to people of low- to moderate-income taxpayers in Pennsylvania who do not live in Cranberry Township that has higher affluence than other parts of the State. In Fayette County and Washington County, in Philadelphia, in Harrisburg, York County, in the city of Pittsburgh, and Erie, and Scranton, there are many people that are in low- to moderate-income housing. They do not live in the affluence of some other communities. I wish they did, but what we are trying to do is reach out and touch those people. This is not redistribution of wealth. It is not Fannie Mae, Freddie Mac, or anything we are doing with the \$700 and \$800 billion bailout of what is going on on Wall Street. This has to do with people's lives and families, and I ask for an affirmative vote.

The SPEAKER. The Chair recognizes Representative Metcalfe for the second time.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, I know there is a lot of information that has been out there and I know the speaker may have missed some of it, but I think when you look back through the many years of where this problem has been created, from Jimmy Carter on through, many years of government trying to create homeowners out of individuals who, in the end, have not been responsible in taking care of those loans that they actually took out for those homes, forcing, forcing institutions into a situation where they are pressing them to give out more and more loans to people who actually will not be responsible in taking care of their debts.

Mr. Speaker, this is redistribution of wealth. There is no way that you can provide a low-interest loan from the government and subsidize it from the government and say that you are not taking tax dollars from one citizen and redistributing them to another. Mr. Speaker, this is another redistribution-of-wealth scheme, and it falls in the line of the schemes that the Democratic majorities have been pushing in Congress over the years, and I will be voting in the negative.

The SPEAKER. Representative Brooks.

Members will please take their seats.

Mrs. BROOKS. May I interrogate the maker of the bill, please?

The SPEAKER. Representative Daley indicates he will stand for interrogation. Representative Brooks, you are in order and may proceed.

Mrs. BROOKS. Would this also provide loans – which I am going to use the word "loans"; they are not grants – for repayment to groups such as AWARE or the mentally challenged like MH/MR (mental health/mental retardation) and different organizations such as that, that they can build transitional homes or group homes?

Mr. DALEY. Yes.

Mrs. BROOKS. And is it my understanding that they are low-interest loans, and there would be guarantees that this is not going to put people in housing that they cannot afford? It is going to put them in housing that they can afford, with low-interest loans. Is that correct?

Mr. DALEY. Your question is succinct, absolutely on point, and very amplifying of exactly what this legislation will be doing.

Mrs. BROOKS. Okay. Thank you very much.

The SPEAKER. Representative Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, may I have brief interrogation of the prime sponsor?

The SPEAKER. Representative Daley indicates he will stand for interrogation. Representative Clymer is in order and may proceed.

Mr. CLYMER. Thank you, Mr. Speaker.

I notice that we are amending the Pennsylvania housing-

The SPEAKER. The gentleman will suspend.

Mr. DALEY. Not one penny.

Mr. CLYMER. I am sorry; I did not hear you.

Mr. DALEY. Not one penny.

Mr. CLYMER. Not one penny. So would it seem reasonable that for money to get into this program, it would have to be established by the General Assembly, by us here?

Mr. DALEY. That is exactly right, Mr. Speaker.

Mr. CLYMER. The next question would be, logically, it would be, in next year's budget, if it would be the desire of the General Assembly, we would put the money in so that they would have this money to do the things, as has been mentioned by a previous speaker. Would that be correct? Mr. DALEY. Yes, Mr. Speaker. This is the vehicle that will be able to do that. It will be up to this General Assembly as well as the Senate to make that determination. We would like to have the program in place to do that if it is the desire of the General Assembly.

Mr. CLYMER. That finishes my interrogation, Mr. Speaker. I would like to have just some observations on the bill.

The SPEAKER. The gentleman is in order and may proceed.

Mr. CLYMER. I thank the gentleman for those responses, and then that begs the question, who is going to be responsible for allocating this money to the various personnel that we just talked about? Who would be recipients of the Commonwealth's money? That always raises a question. Certainly, we want to make certain that the dollars, if they were to be appropriated, would be used in a very transparent way and to truly help those who are in need, and I appreciate the opportunity to make those thoughts.

Thank you, Mr. Speaker. The SPEAKER. The Chair thanks the gentleman.

Mr. Speaker, this resolution before us commemorates the 100th anniversary of the Delaware Water Gap Fire Department Chemical and Hose Company No. 1 that serves a community in my district.

This company was founded in 1908 and over the past 100 years has undergone many changes in fire suppression, equipment, and personnel and has become quite diversified in the types of emergencies to which it responds. These include fires at both commercial and residential buildings, vehicle accidents, floods, water and mountain rescues, hazardous material incidents, industrial accidents, brush fires, medical calls, and anything with which the general public requires help.

In 1994 the department approved its first female firefighter, and in 2006 this woman became the first female fire chief in Delaware Water Gap and all of Monroe County and only the seventh in the Commonwealth.

From its inception, the company has provided effective fire service by continually updating its equipment and operations and expanding its range of emergency services. I myself have been a member of this organization for 40 years and still join them to respond to calls as my schedule permits. I have seen firsthand the dedication and sacrifices of the men and women who serve Delaware Water Gap as its first responders.

Volunteer first responders make sacrifices every day by giving up the comforts of their homes and spending time away from their loved ones to protect the people of Pennsylvania. Pennsylvania's roughly 70,000 volunteer firefighters and nearly 14,000 emergency service providers save Pennsylvania taxpayers \$6 billion each year.

I thank volunteers from across the State for their work and selflessness in performing the sometimes dangerous tasks that protect all of us. The Delaware Water Gap Fire Department Chemical and Hose Company No. 1 stands out today as an accomplished company with a proud history of dedicated men and women who have served their community with distinction. I cannot think of a more valuable contribution to the residents of this State than the dedication, bravery, and heroism of the first responders, and I ask for your support of this resolution.

Mrs. BROOKS. Thank you, Mr. Speaker.

Mr. Speaker, I rise today in support of the 1,167 Pennsylvanians and all of our other POW/MIAs (prisoners of war/missing in action) across this great country who have been classified since World War I as prisoners of war or missing in action. These valiant soldiers answered the call to service, they fought for our freedom, they protected the values we hold so dear, and they never came home.

Their disappearances have remained mysteries for years, and, Mr. Speaker, with the passage of HR 715, we are asking Congress to honor them and to pass HR 111, which would establish a select committee on POW/MIA affairs. This committee would be charged with investigating unresolved cases involving military personnel who served in wars and conflicts. This resolution has the support of more than 71 cosponsors on both sides of the aisle.

Mr. Speaker, it has been nearly 100 years since the first of these POWs and MIAs were silenced, but for the families involved, it has been an eternity. They deserve that their government finds answers. They deserve closure, and we need to give it to them.

Mr. Speaker, it is our duty to honor and account for all persons who have so faithfully served America and to show our respect and gratitude for the quiet heroes and their families who served our nation so well and sacrificed so much.

As a young teenager, I used to drive by a young man's car that had been parked in his yard, and over 30 years later I noticed that that car had finally moved. In that 30 years, that car had never moved from its spot. And I came to find out in my young adult life that those parents kept that car in that position in memory of their son and the heartache that touched my heart

to realize the parents had wondered what happened to their son all of those years. Finally, they were given the answer, but they never did remove that car, until finally, one day they aged, they did have to sell their house, and for the first time in over 30 years, their son's car, Merle Higgins's car, was removed from this spot.

I am so proud to say that the counties that I represent – Lawrence, Mercer, and Crawford Counties - every year say to our POW and MIA families, we remember you and we honor you and we need to bring your loved ones home.

Mr. Speaker, it is my privilege and my honor today to offer HR 715 in memory of all of those who gave so much, and it is my sincerest hope that someday the great ache and heartbreak that those families have held in wondering where their loved ones are, someday that pain will be healed when we bring their loved ones home.

I ask all of my colleagues to join me in voting in support of HR 715. Thank you.
