These talented musicians won the 2014 Cavalcade of Bands American A Class Championships in November 2014. They compiled an overall

score of 95.1. This represents the first major marching band competition championship won for the East Pennsboro School District in about 40 years. In addition to the highest overall score, they also received the award for best music and best overall effect.

The Panthers are led by director Andrew Williams and assistant director William George and other adult leaders, all of whom were too bashful to come up front, so we have five senior members – I believe they are all seniors – five senior members of the band joining me here today at the rostrum: Zachary Raves, Spencer Melnick, Emma Falcone, Rebecca Weaver, and Lance Samuel. Other members are seated in the rear, together with family, friends, and fans of this great musical organization. I would ask the other band members to rise and ask my colleagues to congratulate them on a great accomplishment.

**VINAY RAMESH PRESENTED**

The SPEAKER. Representative Santarsiero of Bucks County is invited to the rostrum for the purpose of presenting a citation to Vinay Ramesh, the PIAA Class AAA State Champion Golfer.

Representative, the floor is yours. And for any other guests that you may have, please come to the rostrum.

Mr. SANTARSIERO. Thank you, Mr. Speaker.

Mr. Speaker, I am joined by Representative Galloway as well because Vinay is a senior at Pennsbury High School, and Representative Galloway and I have the great honor of representing the Pennsbury School District here in the House of Representatives. It is indeed an honor for both of us to be here today to acknowledge Vinay, who as you just noted, Mr. Speaker, won the 2014 PIAA Class AAA Boys Golf Championship.

On October 21 at Heritage Hills Country Club in York, Vinay, a senior at Pennsbury High School and a Lower Makefield resident, birdied the third hole of a sudden-death playoff to defeat Manheim Township's Ryan Dornes to win the State title. Vinay is Pennsbury's first State golf champion since Russ Elkan in 1975. That is, by the way, the year my brother graduated from high school, so it was a long time ago.

The playoff birdie is just one example of Vinay's perseverance this season. After winning the Suburban One League title in September by four strokes, Vinay carded a 6-over-par 78 on the first day of District 1 championships. He was the very last golfer to make the cut on the second day. And on the second day, he needed a playoff hole just to stave off elimination and advance to the Eastern Regional Championships.

At regionals, Vinay's fortunes were better and he carded a 1-under-par 71 to finish second. Then on the first day of the State tournament, Vinay finished a three-way tie for fifth place and was six strokes off the lead. Again Vinay showed his trademark tenacity and golfed like a champion. On the second and final day of the State meet, he finished with a 36-hole total of a 3-over-par 145. I note all of that because it is a measure of any great athlete to be able to come from behind and win a championship the way he did, and for that as well, he should be doubly proud. Vinay will continue his academic and golf pursuits next year at Princeton University.

With us today, joining Vinay in Harrisburg are his mother, Radha Iyer, and his father, Ramesh Peruvemba. I would like to acknowledge them and ask them to stand, if they would. They are in the back. They are on the side, side of the House. Thank you.

Of course, Vinay had to put a lot of effort into his success, but I know you would agree that you would not be standing here without your parents, so we are very grateful that they are here today. I also want to acknowledge Vinay's coach, Glenn Goldsborough. Glenn, please stand. Glenn just finished his final year as Pennsbury's golf coach. He compiled a 77-15-1 record in that span.

Please join me in congratulating Vinay on his much-deserved State title. Thank you all very much. Vinay.

## ROSA PARKS REMEMBRANCE DAY

### STATEMENT BY MS. BISHOP

The SPEAKER. Members, thank you very much.

At this time we would like to call up to the rostrum our colleague, Representative Louise Bishop. She is being asked to address the House in honor of Rosa Parks Remembrance Day. So I would ask that all the members and guests please be seated. We would very much appreciate your full attention.

Representative Bishop, the floor is yours.

Ms. BISHOP. Thank you very much, Mr. Speaker.

I am very proud and humbled to stand today in honor of the late, great Rosa Parks. Each year since 2001, I rise and speak in gratitude of her heroic, selfless acts that much hard work helped to wipe out and wipe away hundreds of years of oppression. Rosa Parks was tired after a long, cold workday in December. She refused to give up her seat to a White man on a bus in Montgomery, Alabama. Little did she realize she would be taking a stand that would help to launch a movement of reform and spark a 382-day-long boycott of the bus system.

I am blessed and was blessed to meet Rosa Parks. She was adamant in making sure that I knew and understood and passed on that she never broke a law. She was arrested for civil disobedience, the refusal to obey governmental demands or commands, especially as a nonviolent and usually collective means of forcing concessions from the government.

Incidents across this country have shown that while we have come far, we have come a long way, we still have a long ways to go in protecting the rights of those who are different. The uproars of violence and the loss of lives across this country, we must not allow or let their tragedies to ever be forgotten. Do not forget. The first female to lose her life in this struggle was a White woman who left her children at home in Michigan to drive all the way to Alabama because she believed she could make a difference. We must come together and take civil actions to make the point that as our country's Constitution says, "...all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness."

We must make our civil rights leaders of history proud of us. Let Rosa Parks be proud of us. Let us use Rosa Parks's historic moment standing up to injustice as an inspiration to spark much-needed change. Her firm belief that the courage of one

person could inspire others to make this country better is needed today more than ever. I hope and pray her courage will inspire the civil rights leaders of today, to help us to make even greater strides for future generations. True equality is still a dream floating on the wings of the wind. It is a dream that can become a reality, but we as leaders must call our communities to action and work directly with our family, friends, and neighbors, and work in love, kindness, humility, and strength, not violence, and remember that all men and all women are created equal.

Rosa Parks's legacy reminds us that if we do not act, there will be no ripple and no waves of change. The women, the women who stand up for their beliefs and stand up for others, are the women who care for their families and lend an ear to friends and show compassion and kindness to their neighbors. Those are the women who really want to make a difference and want to make this world a better place for all of us to live in.

The spirit of Rosa Parks lives on in the women who work hard every day while juggling multiple demands and requests. Rosa Parks's death was not the period that ends this great sentence of life. It is the exclamation point that punctuates our existence, how we live can inspire others. And I hope Rosa Parks continues to inspire everyone, especially women, to come forward and work together, to be the change we wish to see, the world always would like to see, Rosa Parks.

I would just like to close with one short Rosa Parks story. I want to share a personal experience from many years ago. It must have been my very first or possibly second time of offering remarks about Rosa Parks. When I finished, I was standing on the rostrum – not standing on the floor; I learned my lesson from that. Representative E.Z. Taylor, a fellow legislator from the other side of the aisle, ran up to me and enveloped me with a bear hug that almost took me down, it was so forceful. I knew that I was falling and I could almost see stars, but I managed somehow to stay on my feet and keep my balance as we hugged each other. That forged a bond between us, a Republican from West Chester and a Democrat from Philadelphia, a Black woman who wanted to make changes and a White woman who wanted to see that those changes exist.

God bless you, and thank you, Mr. Speaker.

The amendment adds one word to the bill as filed. In addition to intentional and knowing, it makes reckless conduct part of the new offense of endangering the welfare of a care-dependent person that the bill is designed to establish. So it is a one-word change.

Thank you very much.

The SPEAKER. Thank you, Madam Chair.

The gentleman from Delaware County, Representative Vitali, is recognized.

Mr. VITALI. I just want to thresh out that a little bit. So the penalty for reckless—

The SPEAKER. Please hold, sir. Mr. Vitali, are you seeking interrogation?

Mr. VITALI. I am.

The SPEAKER. Okay.

Mr. VITALI. So the bill in chief does what? It provides a penalty with regard—

The SPEAKER. Sir, can you please hold.

Would all members please take your seats. Would members please take their seats.

The SPEAKER. I would also like to recognize that Representative Gergely has joined us on the floor and will be taken off leaves of absence.

### CONSIDERATION OF HB 215 CONTINUED

The SPEAKER. Representative Vitali, you are seeking interrogation?

Mr. VITALI. I am. I am.

The SPEAKER. Let me see.

The good lady has indicated she will take some questions.

Mr. VITALI. Okay.

So the bill in chief provides a penalty for the mistreatment of care-dependent people. Is that correct?

Mrs. GINGRICH. Mr. Speaker, is my interrogator speaking on the amendment? It sounds like he is speaking on the bill.

Mr. VITALI. Well, I am trying to lay the groundwork for the word "reckless." I want to get to that, but I want to lay the groundwork first.

The SPEAKER. Representative Vitali, let me just please make clear: As you know, interrogation is to be used only for an answer that you do not know. We are on the amendment right now. The good lady has indicated she will be glad to take questions on the amendment.

Mr. VITALI. Right.

The SPEAKER. Would you please stick to the amendment.

Mr. VITALI. Right. I got it. But I cannot get this darn thing up on the screen, so I am trying to – and I truly do not know the answers to this. I am really catching this on the fly, because I think when you reduce a standard to reckless, I want to make sure we know what we are doing when we vote on the amendment. But first, I want to get at the crime and penalty we

are talking about. So it deals with the care of care-dependent people, like let us say your dad or mom is in a nursing home or something like that. Is that what we are talking about?

Mrs. GINGRICH. Mr. Speaker, I am having trouble hearing the gentleman.

But I will say on the amendment, with regard to the new word "reckless," that was added at the recommendation of the Attorney General's Office, to give them the enforcement they need to be able to enact the bill to its max. We will be talking more about the bill tomorrow.

Mr. VITALI. Right.

But it is key what we are doing, because we are making it— See what I am concerned about is—

The SPEAKER. Sir, my understanding is that we are done with interrogation and that you are going to make comments on the amendment.

Mr. VITALI. No, that is not it at all.

What I am trying to do is provide a rationale for the questions I am asking, because there seems to be some doubt as to where I am going with this. So I am trying to lay that groundwork.

The SPEAKER. Sir, if you could, if you have questions upon interrogation on the amendment, feel free to ask those questions, but if you are going to make remarks, that is separate and distinct. So if you are going to ask questions, you need to ask questions about the amendment.

Mr. VITALI. Okay. So the words you refer to with regard to the amendment is adding "reckless." Is that correct?

Mrs. GINGRICH. That is correct.

Mr. VITALI. Okay. Now, put that in context. Who is acting reckless towards what?

Mrs. GINGRICH. Again I cannot hear the gentleman.

Mr. VITALI. Okay. I said put the word "reckless" in context. How does this "reckless" apply to the bill? Does that mean who was being reckless towards whom in what regard?

The SPEAKER. Members, we would like to get through this interrogation quickly, please.

I think there are only a few specific questions that could possibly be asked on this one word. Please give this gentleman the opportunity to ask that.

Mr. Vitali, please ask direct questions on the amendment.

Mr. VITALI. See, I think that is what people do not get, the importance of how one word really turns the whole import of a statute, so I mean, it is crazy to say 1 word, just because it has like 10 letters, is insignificant—

The SPEAKER. Sir, please—

Mr. VITALI. —because it is significant.

The SPEAKER. Sir, please suspend.

I would just direct you to please ask specific questions on the amendment. Thank you.

Mr. VITALI. Okay. I am going to repeat the question I just asked because I thought it was pretty specific.

The question involved, your amendment adds the word "reckless," right? So what I am saying is, put that in context. Reckless – who is being reckless towards whom?

Mrs. GINGRICH. We are talking about the caregiver being reckless in the care they are providing to the care person, the individual.

Mr. VITALI. Right.

Mrs. GINGRICH. And that is clearly stated in the language of the bill, adding the word "reckless" to that.



Mr. VITALI. Okay. Got it. Got it. Got it.  
 Next question, if one is reckless in caring for a care-dependent person, if your amendment gets in, what would that penalty be for a person who is reckless in their care?

Mrs. GINGRICH. Go back to the language of the bill. Hold on.

Okay. That is an M2.

Mr. VITALI. M2.

Mrs. GINGRICH. Misdemeanor 2. Second.

Mr. VITALI. Okay. And how would you define "reckless"?

Mrs. GINGRICH. The courts define "reckless." It would be the same in this case.

Mr. VITALI. There is no definition in the Crimes Code that this refers to?

Mrs. GINGRICH. This is an effort with the recommendation of the Attorney General's Office to give them the authority they need to go further than they are able to do now towards a caregiver who is being intentionally negligent or reckless. I happen to agree with the Attorney General's Office on this recommendation; you may not, sir.

Mr. VITALI. Okay. That concludes my interrogation.

Just to talk generally – listen, this is going to pass unanimously. I very well may vote for it too, but you have to be very careful when you subject people in the Crimes Code with regard to unintentional conduct.

I mean, I am just concerned about people who work in nursing homes and all the rest, what we choose to criminalize. I was not trying to be a problem here. I was just trying to understand what I was voting on.
