### REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Chair would recognize Representative Hanna, who will be recognized on HR 87.

Mr. HANNA submitted the following remarks for the Legislative Journal:

Thank you, Mr. Speaker.

HR 87 designates February 25, 2015, as "Peripartum Cardiomyopathy Awareness Day" in Pennsylvania. Peripartum cardiomyopathy is a form of heart failure during pregnancy or postpregnancy.

I introduced this resolution on behalf of Heather Moore, a constituent who developed the disease when she became pregnant with her son at age 29. By the time doctors realized what was happening, her son, named Ty Steven, did not survive because of the late diagnosis. She suffered multiorgan failure and a stroke, and spent 3 months in the hospital on a heart pump. She was even the first name on the area's heart transplant list for weeks.

Luckily, Heather has recovered, but she can never get her son back. Heather's doctors told her she cannot have more children, even though she is otherwise healthy, because the risk of peripartum cardiomyopathy grows with each pregnancy.

The exact cause of this disease is unknown. Diagnosis is not always made right away, as some conditions associated with pregnancy – like fatigue, swelling of the ankles, and shortness of breath – are also symptoms of peripartum cardiomyopathy and can mask its presence.

I wanted to sponsor this resolution because it is important that the public, health-care professionals, and patients learn more about the disease so that we can protect mothers and their babies. I urge my colleagues to support this resolution. Thank you.

A Resolution recognizing and honoring the work, activism, leadership and courage of Frances P. Aulston of the City of Philadelphia during "Black History Month 2015."

On the question,  
Will the House adopt the resolution?

The SPEAKER. The Chair would like to recognize Representative Acosta on the resolution. Please proceed down front to the rostrum – I mean to the well of the House.

Ms. ACOSTA. Mr. Speaker, I rise today in celebration of the unique history, tremendous sacrifices, and remarkable contributions that African-Americans have made in building and making real the principles that America was founded upon: the path to liberty, equality, and opportunity for all.

One hundred and fifty-one years ago the Emancipation Proclamation, an Executive order issued by President Abraham Lincoln, freed the slaves in all States that were in rebellion against the Union and established the broad legal framework for the future. The strong will of the African-American people led to conquering feats such as coming out of slavery, earning the right to vote, fighting for civil rights, and creating a solid foundation to build an ongoing legacy for the future.

In honor of Black History Month, it is with distinct privilege to acknowledge the achievements, activism, civic engagement, and leadership of Frances P. Aulston.

Ms. Aulston is a graduate of Antioch and Drexel Universities, with a bachelor of arts in human services and a master's degree in library science. In 1984 she founded the West Philadelphia Cultural Alliance, a multicultural, multiethnic organization, with the assistance of several local artists. Under her leadership, WPCA has worked in partnership with over 80 organizations, government agencies, and educational institutions to build a community through the arts with the goal of increasing visibility of the community's cultural resources, encouraging professional development of local artists, and promoting positive social change.

Ms. Aulston states that for her, "...WPCA has been a ministry to encourage families, especially children, to appreciate, participate in, and actively support the arts...." She believes "...this awareness of the cultural contributions of our community makes for better citizens, not only for our community, but for the world." Under her leadership, she initiated a campaign to ensure that the west Philadelphia residence of legendary performer, lawyer, human rights activist, and scholar, Paul Leroy Robeson, be preserved as a historical house museum.

The Paul Robeson House has gained national prominence as a historical site and is now listed as an African-American historical site in the National Register of Historic Places. In 1991 the Pennsylvania Historical and Museum Commission declared the Paul Robeson House a historical landmark. In 2000 the National Trust for Historic Preservation designated the Paul Robeson House as an official project of "Save America's Treasures," a national program of the White House Millennium Council and the National Trust for Historic Preservation.

Ms. Aulston is currently working to renovate the three-story house, which is expected to be the most historically significant property in the United States. She envisions the Robeson House as an institute of civic responsibility where the community will come and learn about the challenges of the past and the opportunities of tomorrow.

The final destination for success ends with fulfilling one's true purpose in life. Frances P. Aulston is fulfilling that purpose, evidenced by her determination to build, transform, and cultivate leaders, not just for our time, but for generations to come.

Ms. Aulston, thank you for making Philadelphia a better place to live, work, and play. Thank you for never underestimating the power of dreams and the influence of the human spirit. We are all the same in this notion: the potential for greatness lives within us.

Finally, I would like to thank my House colleagues for their support of HR 90.

As we commemorate Black History Month, let this be a reflection on how far our nation, and especially our African-American communities, has traveled on the long road toward equality and freedom. Let this chamber embrace and achieve a future consistent with our dreams and worthy of our founding documents. Let us inspire each other to dream of and work for a more inclusive, more just, and more perfect union.

Mr. J. HARRIS. Thank you, Mr. Speaker.

Mr. Speaker, I rise today on amendment A00118 to talk about the perception that we have of the Department of Human

Services with regards to how the lottery winnings would affect the public.

Mr. Speaker, my purpose for the amendment was to ensure that there are not any collateral consequences with this. While I agree with the good gentleman's intent of this legislation, what I did not want to see was that folks who had a temporary windfall would see themselves not receiving the necessary services that help them and their children.

Mr. Speaker, oftentimes when we think about this type of bill, we think about people who are sitting at home collecting checks on public assistance through taxpayer dollars. Mr. Speaker, that is a false thought when the Department of Human Services tells us that only 412 people in the entire Commonwealth of Pennsylvania receive general assistance, that is 412 in the entire Commonwealth that receive general assistance dollars.

The majority of the Department of Human Services budget is for mental health services that provide speech therapy for our children, that provide intellectual disabilities services for our folks, that provide care in nursing homes for our seniors. That is what the Department of Human Services does. The Department of Human Services does not provide taxpayer dollars for folks to sit at home and collect the checks. Four hundred and twelve people in the entire Commonwealth of Pennsylvania get general services, get general assistance dollars through this Commonwealth.

Mr. Speaker, I ask that we change our mindset when we talk about the Department of Human Services, because it is truly a department that provides a wealth of services for people in our Commonwealth.

Representative Davidson, you have the floor, but give me just a second.

Members, please give the floor to Representative Davidson.

Mrs. DAVIDSON. Thank you, Mr. Speaker.

Mr. Speaker, I do applaud the gentleman's legislation proposal, this bill that would intercept payments for particular instances. But my amendment would clean up this bill, Mr. Speaker, by removing the requirement of the Department of Revenue to notify the Department of Human Services in order to be determined continued eligible for public assistance.

While the State lottery is an appropriate place for the interception of lottery winnings for payment of money owed to the State, including State liabilities and court ordered obligations, the requirement to notify the Department of Human Services is an issue that should be resolved in the Public Welfare Code. This is not an appropriate place to resolve this issue.

Currently the domestic relations section 4308 requires the Department of Revenue to intercept lottery winnings for delinquent child support payments. That is in a separate code. I argue, Mr. Speaker, that this should also be in a separate code for human services so we do not have unintended consequences going on when people receive \$2500 and then cannot pay for child care that allows them to go to work every day.

I do agree with my colleague, the gentleman from Philadelphia, that our perception about people that receive assistance may be a little bit askew, which is all the more reason why this particular section should be taken out of this bill.

I want to bring your attention to an article that I recently read which lets us know that a welfare mom received \$188 million from a Powerball winning.

She is a welfare mom because she worked at McDonald's and Walmart and had to quit her job to care for her children, one boy and three girls, one of which has cerebral palsy, which did not allow her to work. With her winnings she declared that I am going to first pay my tithes, because I know I would have none of this without God's help, and then I will let the Welfare Department know that I will no longer need their services.

And so I think we need to first of all have a different sort of mindset about moms that are doing the best they can and they get a lucky break through the lottery system. And secondly, as a matter of legislation, the Department of Revenue code is not the proper place to handle this, and we need to have this go through the committee structure for human services so that we can determine the best way to make sure that our taxpayer dollars are protected from people who are fraudulent and that people that receive services legitimately can continue to receive those services.

Thank you, Mr. Speaker.

I ask for a "yes" vote on taking out that provision. Thank you.

The SPEAKER. Thank you, Representative.

The Chair recognizes the good gentleman, Representative Adam Harris, for comment.

Mr. A. HARRIS. Thank you, Mr. Speaker.

I would like to thank both of the previous speakers for their comments and they are on point. I would respectfully ask that we oppose this amendment.

The welfare benefit check is a key part of this legislation. It was actually introduced by amendment last session by the good gentleman from Centre County and passed this House unanimously. I think it makes the bill better. I think stripping the language from this bill makes it a weaker and less beneficial bill, and I would ask everyone to oppose amendment A00120.

### REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. The Speaker recognizes the good gentleman from Dauphin County, Representative Marsico, on unanimous consent.

Mr. MARSICO. Thank you, Mr. Speaker.

I would like to thank the members for your vote and submit remarks for the record.

The SPEAKER. They will be accepted. Thank you very much.

Mr. MARSICO submitted the following remarks for the Legislative Journal:

Mr. Speaker, it seems that every day we read about, hear about, or have a constituent tell us about an incident of bullying of children. This, of course, is not a new problem. It has probably been around as long as there have been children.

Several years back the General Assembly recognized the particular problem that bullying in schools presented. We addressed it on the schoolyard, in the classroom, and on the school bus by passing Act 61 of 2008. It requires schools to establish policies and define responses to bullying that occurs in school or in a school setting.

Today, however, young bullies do not need a schoolyard or school bus to confront their victims. Bullying today is just as likely to occur over the Internet or through other electronic means. Today a victim can be tormented with a few keystrokes and a click of the mouse.

This not only has made bullying much easier to perpetrate, but much more pervasive. Electronic media has emboldened bullies and brought about new ways to cause serious emotional distress to children of all ages.

The Judiciary Committee held hearings on the problem of bullying last session. We worked together, Republican and Democratic members, to explore the issue. And this bill, HB 229, was a product of that work, including thoughtful amendments added to the bill last session by Representative Barbin and Representative Krieger this session.

We have heard from children who have been victims, along with child mental health experts and school administrators. They gave our committee a wealth of information about the way bullying occurs and the impact it can have on a child's performance both in the present and down the road.

We have heard about the efforts schools have made to confront it, as well as the limitations on their authority and ability to do so. It is clear from those hearings that there is only so much schools can do, since only so much bullying takes place in a school setting today.

We have laws on the books that prohibit harassment, of course, but those laws were written long ago. This bill is about making sure that the crime of harassment reflects the realities of today.

We need to make sure that the Pennsylvania Criminal Code does not allow criminal conduct that should be stopped. And if it does, we need to change our laws to make sure that our Criminal Code applies to everyone.

One way to modernize Pennsylvania's criminal law is for our statutes to catch up with the technology that has changed the bully's playing field. The hearings we held make clear that our current laws are inadequate to address bullying in the electronic age.

HB 229 will go far forward doing that. This bill will bring the authority of the courts into play where persistent bullying conduct results in serious emotional distress to a child. The bill will establish a subsection within the current harassment statute to specifically prohibit cyber harassment of a child. It will classify as a misdemeanor, a continuing course of conduct, perpetrated through electronic means, that is intended to cause serious emotional distress to a child.

To ensure that normal childhood behavior directed, however, at a particularly sensitive child is not swept into the net, the law would only apply if the bullying is likely to cause serious emotional distress to the average child the age of the victim.

Some may feel that the grading of cyberharassment as a misdemeanor is overreaching. They may feel this is something that can be dealt with as a summary offense, with a citation then perhaps a fine and a few hours of community service. I believe, however, our current summary harassment law has proven inadequate and that grading cyberharassment of a child as a misdemeanor will add an important element to the strategy for dealing with the problem.

As a misdemeanor, jurisdiction over a bully under the age of 18 will lie with the juvenile court. Unlike the magisterial district courts, juvenile courts address offenses by young people through principles of balanced and restorative justice. Furthermore, unlike a summary offense, a juvenile offender in the juvenile justice system automatically has his record expunged at age 21, so the taint of a criminal record does not follow him into adulthood. Rehabilitation, acceptance of responsibility, and restoration of the victim are the primary focus of the juvenile system.

By involving the juvenile court, the response to persistent, serious bullying will include the full spectrum of juvenile court remedies that are unavailable in cases brought before the minor judiciary. This will, I believe, also serve as a deterrent. Children engaging in cyberbullying and their parents are much more likely to respond to complaints, knowing the consequences may involve an appearance in juvenile court if they do not.

Mr. Speaker, every child in this Commonwealth has the right to grow up free from intimidation, torment, and emotional distress. They deserve to grow up in an environment that allows them to focus their energy on achieving their full potential. I believe HB 229 will go a long way toward helping children to do so, and I ask for the support of the members in passing this bill.
