Almighty God, creator of us all, bless those who hold office in the government of this Commonwealth, that we may do their work in a spirit of wisdom and kindness and justice. Help them use the authority to serve faithfully and to promote the general welfare of all that they serve. Under Your law we live, great God, and by Your will we govern ourselves. Help us as good

citizens to respect neighbors whose views differ from ours so that without partisan anger we may work out issues that sometimes divide us, for in the common good of Your people, we are all servants.

**STATEMENT BY MS. WHITE**

The SPEAKER. Representative White is recognized on unanimous consent. Martina White, Representative from Philadelphia County, is recognized on unanimous consent.

Ms. WHITE. Good afternoon. Mr. Speaker, each day 780,000 police officers across the country put on a badge and head to work, knowing they are placing themselves in extremely dangerous situations. For our police officers, protecting the public is not a job but a calling. What the public does not see is the toll taken on our law enforcement officials as they fight to keep our communities safe.

In 2014, 117 officers died in the line of duty. What too few people recognize are the 50,000 officers who are assaulted in the line of duty each year, and the 14,000 injured protecting the public. Then there is the painful statistic that each year more than 300 officers commit suicide. With the exception of the military, there is no other profession in the world with such staggering statistics.

Our police officers have chosen to serve their communities knowing that one day their actions may make a real difference in somebody's life. Our police officers will run into a burning building to save someone's life, often without protective equipment. They race the injured to the hospitals, rescue lost children, and give comfort to those following the death of a loved one.

That is why we have designated January 9 as "Law Enforcement Appreciation Day" in Pennsylvania. On this day we in the House of Representatives recognize and honor those who continue to make the ultimate sacrifice to keep our communities safe and play such an integral role in our society.
