REMARKS BY SPEAKER

The SPEAKER. Congratulations, Representative McNeill.

I am sure Dan is looking down with great pride on you and your family members, and on behalf of the members of the House of Representatives, it is my pleasure, as Speaker, to welcome Representative Jeanne McNeill to this distinctive body. You now have the honor of being part of one of the first, if not the first, legislative bodies in the United States, in America itself. REMARKS BY DEMOCRATIC LEADER

But as I said, this is a happy day for all of us, because Jeanne McNeill has taken her seat in the House and she is going to create a legacy of her own. Once again, the 133d District has an elected advocate in State government, a person they chose and sent here to be their voice.

Jeanne, I join all our colleagues and all of us who are not here, welcome to our House. Thank you.

Whether it is your first day or it is your - in my case, this is the 26th, getting to be 27th; it has been a while - the magic of this place, the beauty of this place, just never wears off. Magic

is probably the wrong word, but the beauty never wears off. It is a spectacular building and where we do the people's business and it is a great place to go to work every day and I am sure you are going to enjoy it.

I want to welcome your family and friends. You are very important people to Jeanne. You supported her in one of the worst times of her life. Then you helped her to succeed Dan, and with today's ceremony, I hope you are all savoring a very precious new memory. Each of you shares in Jeanne's victory, but, family and friends, your job is not done. In the months ahead, you will have many chances to let Jeanne know how she is doing. The support and encouragement you provide will be crucial. Every one of us who serves here in this House has important people back home who make it possible for us to do this job. With your friendship and support, you will make the frequent absences and unusual demands of this round-the-clock job bearable.

To Representative McNeill, you know as well as anyone how tough this job can be. You will not be on the winning side of all the votes, but with your hard work, you will help move this Pennsylvania forward and you will feel a sense of accomplishment. Get to know your colleagues and pay close attention to those with whom you might think you do not have a thing in common, have the least in common, because you will discover that we all have things in common.

It is a testament to Jeanne that she was selected to run in the special election last month and the voters chose to send her as their new Representative. In addition to supporting the work of her husband, she has built a career in special education. Jeanne's knowledge and experience in this crucial field is going to be a great addition to our deliberations about education issues in this House.

I also note today that with Jeanne's arrival, one in every four members of the House Democratic Caucus is a woman. Leaders like Jeanne McNeill will make this House stronger and better.

Once again, Mr. Speaker, it is my pleasure to welcome our newest colleague in this House, Jeanne McNeill. She joins us in the middle of a session and at the start of a new year, where we have many, many important issues before us. Jeanne, myself, the rest of all your colleagues, not the ones that are just here today, but I think all of us want nothing more than to see you succeed, and I assure you and promise you that we will work together with you to make sure you do succeed.

Congratulations and good luck. I know you are going to be a special contributor to our collective effort to move Pennsylvania forward.
